INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
The Automated Health Systems, Inc. 401(k) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Automated Health Systems, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

FOR THE YEARS ENDED JUNE 30, 2024 AND 2023

A. Description of Plan:

The following description of the Automated Health Systems, Inc. 401(k) Retirement Plan (“the Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees who have one year of service and are age twenty-one or older. The Plan is a single-employer, safe harbor plan under Internal Revenue Code Section 414(m). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

For the years ended June 30, 2024 and 2023, the participating employers consisted of Automated Health Systems, Inc., Allied Physician Services, LLC (a wholly owned subsidiary of Automated Health Systems, Inc), Automated Health Systems, LLC, Brown Professional Services and Sigma Advanced Solutions, Inc.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, up to the maximum amount allowed by law of \$23,000 and \$22,500 for 2024 and 2023, respectively. Participants who are at least age 50, or who will attain age 50 before the end of the calendar year, may elect to defer up to an additional \$7,500 for 2024 and 2023. They may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various mutual fund investment options offered by the Plan. The Company matches 100% of the employees’ elective deferral contributions up to 3% and matches 50% of salary deferrals greater than 3% and up to 5%, equating to a maximum total employer contribution of 4% per participant.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan investment income. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions and the Company’s safe harbor contributions plus actual earnings thereon.

Vesting in the Company’s discretionary additional matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. The Plan has a graduated vesting schedule which increases in 20% increments commencing after two years of continuous service. A participant is 100% vested after six years of credited service.

A. Description of Plan (Continued):

Forfeited Accounts

The Company may use forfeitures to satisfy employer contributions or reduce excess plan and administrative expenses, if any, at its discretion. There were \$2,175 and \$10,817 in unallocated forfeitures for the years ended June 30, 2024 and 2023, respectively.

Payment of Benefits

On termination of service due to retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a series of periodic payments if current Required Minimum Distribution age has been reached. Upon termination of employment prior to the normal retirement age of 65, the participant may elect to receive a lump-sum amount of the vested balance, or postpone distribution if the vested account balance exceeds \$5,000. If a participant dies or becomes disabled, the participant's employer contributions become fully vested.

Plan Expenses

Plan expenses are not separately charged to the Administrator or participants. Instead, plan assets are invested in retirement class mutual funds, which have a higher expense ratio than other classes of mutual funds. Any additional administrative fees, if any, will be satisfied by account forfeitures.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

B. Summary of Significant Accounting Policies:

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.



NOTES TO FINANCIAL STATEMENTS

B. Summary of Significant Accounting Policies (Continued):

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Reclassifications

Certain accounts in the prior year financial statements have been reclassified for comparative purposes to conform with the current year presentation.

Subsequent Events

The Plan has evaluated subsequent events through April 11, 2025, the date the financial statements were available to be issued.

C. Fair Value Measurements:

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented, and there were no changes in the methods used to measure fair value at June 30, 2024 and 2023.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

D. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

E. Tax Status:

Effective June 13, 2013, Automated Health Systems, Inc. adopted a prototype safe harbor 401(k) retirement plan of Voya Financial, Inc. which was determined acceptable under Code Section 401 by the Internal Revenue Service.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks.
