Notes to Financial Statements

November 15, 2023 and June 30, 2023

(1) Description of Plan

The following description of the Valley Forge Military Academy Foundation 403(b) Tax Deferred Annuity Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of the Valley Forge Military Academy Foundation (the Foundation) except students employed by the Foundation, leased employees, non-resident citizens receiving no income from within the United States and employees who normally work less than twenty hours per week. Such employees are eligible to participate in the once they meet certain service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's management is responsible for oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Contributions

Each year, participants may contribute pretax compensation not to exceed limits imposed by Internal Revenue Code (IRC) sections 402(g), 403(b), and 415, as defined in the plan document. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, as well as plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their elective contributions, plus actual earnings thereon.

Payment of Benefits

Depending on the type of investment and the investment provider with whom amounts are invested, on termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's interest in his or her account, a qualified optional survivor annuity, or annual installment payments not to exceed the life expectancy of the participant or the joint and last survivor life expectancy of the participant and their designated beneficiary.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Contributions from Plan participants are recorded in the period in which the employee contributions are withheld from compensation.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive insurance contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the gains and losses on investments bought and sold as well as held during the period.

Payment of Benefits

Benefit payments are recorded when paid.

Expenses

Certain expenses of the Plan are paid by the Plan as permitted in the plan document while other expenses are paid by the Foundation. Investment related expenses are included in net depreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through April 14, 2025, the date the financial statements were available to be issued.

(3) Teachers Insurance and Annuity Association of America (TIAA) Traditional Annuity

The TIAA Traditional Annuity is a guaranteed fixed annuity contract available as an investment option to plan participants. Each contract is fully and unconditionally guaranteed by TIAA. The Traditional Annuity is offered through a variety of contract types, including Retirement Annuities (RA), Group Retirement Annuities (GRA), Retirement Choice (RC), Supplemental Retirement Annuities (SRA), Group Supplemental Retirement Annuities (GSRA), and Retirement Choice Plus (RCP). The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account, and the options for receiving income upon retirement.

When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA's claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate.

The RA contract does not allow lump-sum cash withdrawals, and transfers must be spread over a period of ten annual installments (or five annual installments for withdrawals after termination of employment through election of a five-year fixed-period annuity). When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits.

One of the TIAA Traditional Annuity contracts in which the Plan invests meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

(4) Certified Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments at fair value and contract value held at November 15, 2023 and June 30, 2023, and net depreciation in fair value of investments, and interest and dividends for the period July 1, 2023 through November 15, 2023, was obtained by management and agreed to or derived from the information certified as complete and accurate by TIAA and College Retirement Equities Fund (CREF), the custodians of the Plan.

(5) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 15, 2023 and June 30, 2023.

Registered investment companies are valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

The CREF Money Market account represents a registered investment company. The investment is exchange traded and is classified within level 1 of the fair value hierarchy.

The CREF investments represent registered investment companies. The fair values of accumulation units held by these investments are based on each account's daily NAV. The accounts are exchange traded daily and are classified within level 1 of the fair value hierarchy. NAV data is also available daily to plan administrators and client investors on TIAA and CREF's website.

The fair value of the Plan's interest in the TIAA Real Estate Account (REA) is based on the fund's daily NAV, which is considered by plan management to be the best approximation of fair value. The NAV is used as a practical expedient to estimate fair value. The unit value of the fund is calculated daily and available to plan administrators and client investors on TIAA and CREF's website. Underlying holdings are primarily valued using independent appraisals or independent pricing sources. Accumulation units in the REA are available for transactions at the closing NAV on any day the New York Stock Exchange is open for business. Transfers out of the REA are limited to one per calendar quarter. Although the underlying assets of the REA cannot be quickly sold and converted to liquid assets, the TIAA General Account provides the REA with a liquidity guarantee (TIAA ensures that the REA has funds available to meet participant redemption, transfer or cash withdrawal requests executed at quoted unit values). This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Investments in TIAA Traditional Annuity contracts and TIAA Stable Value Account are reported at contract value, which approximates fair value. As these investments are contract-based, observable prices for identical or similar investments do not exist and, accordingly, these investments are valued using unobservable inputs (level 3). The contract value equals the accumulated cash contributions and interest credited to the contract, less any withdrawals. Liquidity restrictions apply to certain types of contracts that could impact the value realized upon exiting the contract.

For the period July 1, 2023 through November 15, 2023, there were no transfers into or out of investments included in level 3 of the fair value hierarchy.

(6) Related Party Transactions and Party-In-Interest Transactions

Certain investments held by the Plan are managed by TIAA and CREF, trustees as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions, for which the parties are paid a fee for investment management services. These transactions are exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment manager services are included in net depreciation in the fair value of the investment.

(7) Plan Termination

Effective November 15, 2023, the Plan merged with and into The Independent School Group Retirement Plan (ISGR Plan). Plan assets were transferred to the trustee of the ISGR Plan subsequent to the plan merger.

(8) Tax Status

The Plan adopted a TIAA Volume Submitter Profit Sharing Plan. The IRS has determined and informed TIAA by a letter dated August 7, 2017, that the Volume Submitter Profit Sharing Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

(10) Prohibited Transactions

During the prior Plan years and during the period July 1, 2023 through November 15, 2023, participant withholdings in the amount of \$39,100, were not remitted to the Plan in a timely manner. These transactions constitute prohibited transactions as defined by ERISA. The Company intends on making corrective contributions to the Plan during 2025 to compensate affected participants for lost earnings on the delinquent contributions.


