**NOTE A - DESCRIPTION OF THE PLAN**

The following description of the Glenkirk Pension Plan and Trust (the "Plan") provides only general information. Interested parties should refer to the plan document for a more complete description of the Plan's provisions.

1. **General**

The Plan is a defined contribution profit sharing plan covering all eligible employees of Glenkirk (the "Organization"). Employees are eligible to participate and make salary deferrals upon their hire date and employees are eligible to receive employer matching contributions upon completion of one year of service in which the employee works 1,000 hours and attaining age 21. Individuals who meet the eligibility for matching contributions who are also employed on the last day of the plan year are eligible to receive an annual discretionary contribution made by the Organization. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. **Contributions**

The Plan is funded by voluntary contributions of participants. Participants may contribute to the Plan, through regular payroll deductions, and participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also roll over amounts representing distributions from other qualified employee benefit plans.

The Plan is also funded by the Organization's discretionary matching contributions up to the first 2% of eligible compensation contributed by eligible employees and an annual discretionary contribution made by the Organization equal to 2% of eligible employees' compensation, for which participants must be employed on the last day of the plan year to receive. The Organization made and accrued discretionary matching and discretionary annual contributions of \$69,042 and \$90,000, respectively, for the year ended June 30, 2024.

Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

3. **Investment Options**

Participants must direct their salary deferral contributions and the Organization's contributions into a variety of investment funds made available and determined by the Plan Administrators. Participants may change their investment options at any time.

4. Participant Accounts

Each participant's account is credited with the participant's contribution, an allocation of the Organization's discretionary matching and annual discretionary contributions, and an allocation of plan earnings. Plan earnings are allocated to participants' accounts in direct proportion to their respective account balances, based on the performance of participants' investment selections. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

5. Vesting

Participants are immediately fully vested in participant and rollover contributions plus the actual earnings thereon. Participants vest in the Organization's contributions at a rate of 20% after two years of service and continue to vest at a rate of 20% for each successive year until 100% vested after six years of service. In the event of death, disability, or retirement at designated ages, participants become fully vested.

6. Payment of Benefits

On termination of service, a participant may elect to receive a single, lump-sum payment equal to the value of his or her vested account balance; installments over a specified period of time, which should not extend beyond the participant's life expectancy, through the purchase of an annuity contract; or a direct rollover distribution. In-service withdrawals are permitted at age 65 and hardship withdrawals are also permitted by the Plan.

7. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants are permitted to take loans from the Plan up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans are collateralized by the borrowers' respective vested account balances and bear interest at rates ranging from 9.00% to 9.50%. Principal and interest are paid through payroll deductions over a period not to exceed five years, unless for the purchase of a primary residence.

8. Administrative Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Investment-related expenses are included in net appreciation in value of investments.

9. Forfeitures

At June 30, 2024 and 2023, unallocated plan assets resulting from forfeited nonvested accounts totaled \$7,385 and \$21,249 respectively. These accounts will be used to reduce future Organization contributions or pay plan administrative expenses. Forfeitures of approximately \$9,000 were used to reduce employer contributions made during 2024. Subsequent to year-end, forfeitures of approximately \$17,000 will be used to reduce employer annual discretionary contributions related to the Plan year ended June 30, 2024. The employer contribution receivable balance at June 30, 2024 is stated net of forfeitures.

10. SECURE 2.0 Act

The Securing a Strong Retirement 2.0 Act ("SECURE 2.0 Act") was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2023 and later. No optional provisions have been adopted through the report date and no mandatory provisions were applicable to the Plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting. The Plan recognizes employee and the related employer matching contributions in the period in which the related employee contribution is withheld.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

2. Fair Value Measurements

Current accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1                      Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2                      Inputs to the valuation methodology include the following:

- \* Quoted prices for similar assets or liabilities in active markets;
- \* Quoted prices for identical or similar assets or liabilities in inactive markets;
- \* Inputs other than quoted prices that are observable for the asset or liability;
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3                      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan's investments measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at NAV per unit as determined by the insurance company or contract administrator. Such NAV is based on the value of the underlying assets and liabilities of the account. Participants may transfer in and out of such trusts on a daily basis without any prohibitive restrictions.

*Common/collective trusts:* Valued based on the NAV of units of the common/collective trusts. The NAV, as provided by the custodian, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common/collective trusts, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

3. Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodian. See Note B-2 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

4. Use of Estimates

In preparing the Plan's financial statements, management is required to make estimates and assumptions that affect the reported amounts of net assets, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

5. Payment of Benefits

Benefits are recorded when paid.

NOTE C - INFORMATION CERTIFIED BY THE VARIABLE ANNUITY LIFE INSURANCE COMPANY, PRINCIPAL TRUST COMPANY AND PRINCIPAL LIFE INSURANCE COMPANY

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2024 and 2023, and net appreciation in value of investments, and interest and dividends for the period from July 1, 2023 to June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by The Variable Annuity Life Insurance Company ("VALIC"), Principal Trust Company and Principal Life Insurance Company (the custodians of the Plan).

The guaranteed interest account is going to be disbursed from VALIC to Principal Life Insurance Company and Principal Trust Company over the course of five years. Approximately \$147,000 was transferred from VALIC to Principal Life Insurance Company and Principal Trust Company during the year ended June 30, 2024.

NOTE D - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS WITH INSURANCE COMPANIES

The Plan holds a fully benefit-responsive investment contract with VALIC through the Fixed Account Plus, and a fully benefit-responsive investment contract with Principal Life Insurance Company through the Principal Fixed Income Guaranteed Option which are reported at contract value as of June 30, 2024 and 2023. Contract value represents contributions made to the contracts, plus earnings, less participant withdrawals and administrative expenses.

VALIC and Principal Life Insurance Company maintain contributions in their respective general accounts. VALIC and Principal Life Insurance Company guarantee the Plan a return of principal and interest under the terms of the contracts. The interest crediting rate for contract with VALIC is updated monthly for the Fixed Account Plus and annually for the Short Term Fixed Account based upon contract provision. Interest is calculated at the lesser of 3.00% or an applicable rate defined in the contract, and may not be less than 1.00%. The interest crediting rate for the contract with Principal Life Insurance Company is updated semi-annually based upon contract provisions, and may not be less than 1.30%. VALIC and Principal Life Insurance Company's general accounts are credited with earnings on the underlying investments and are charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following: (1) the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code, (2) premature termination of the contracts, (3) Plan termination or merger, (4) changes to the Plan's prohibition on competing investment options, or (5) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.

NOTE E - TAX STATUS

The Plan has adopted a non-standardized pre-approved plan sponsored by Datair Employment Benefit Systems, Inc. The plan has received an opinion letter from the Internal Revenue Service as to the plan's qualified status. The plan opinion letter has been relied upon by this Plan. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become fully vested in their respective account balances.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE H - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by VALIC, Principal Trust Company and Principal Life Insurance Company. VALIC, Principal Trust Company and Principal Life Insurance Company are the custodians, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each investment.

The Plan issues loans to participants, which are secured by the vested balance in the participant's accounts and certain administrative fees related to the administration of the Plan were paid by the Plan or by the Organization. These transactions qualify as party-in-interest. Employees of the Organization provide administrative services to the Plan for which no fees are charged.

NOTE I - PLAN AMENDMENT AND RESTATEMENT

Effective August 1, 2023, the Plan was amended and restated. Significant provisions of the amended and restated plan document are consistent with those of the current plan document. Interested parties should refer to the plan document for a more complete description of the Plan's provisions

NOTE J - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through April 14, 2025, the date that these financial statements were available to be issued. Plan management has determined that no events or transactions, other than the item described in Note A-9 and below, have occurred subsequent to the statement of net assets available for benefits date that require disclosure in the financial statements.

The guaranteed interest account is going to be disbursed from VALIC to Principal Life Insurance Company and Principal Trust Company over the course of five years. A total of \$147,098 was transferred from VALIC to Principal Life Insurance Company and Principal Trust Company in September 2024.
