Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Sunrise Community, Inc. The Employee Pension Benefit Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1. Plan Description

General

The following description of Sunrise Community, Inc. The Employee Pension Benefit Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

The Plan, which was originally adopted effective July 1, 1993, is classified as a tax deferred annuity or 403(b) plan. The Plan was restated effective July 1, 2022, June 1, 2023 and June 1, 2024. The employees of the Plan’s sponsor, The Phineas Corporation and Subsidiaries (the “Sunrise Group” or the “Plan Sponsor”), who are not leased employees, may elect to participate in the Plan immediately. The primary purpose of the Plan is to provide employees of the Sunrise Group with financial benefits upon retirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Participants may contribute up to the maximum allowed by current law. Participant contributions are made through a salary reduction agreement. The Plan Sponsor, at its discretion, has elected to match \$0.25 for every \$1.00 of elective deferrals that do not exceed 10% of the participant’s eligible earned wages. Upon election to participate in the Plan, participants become immediately eligible for the Plan Sponsor’s elective matching contributions.

On July 1, 2022, the Plan Sponsor agreed to make defined contributions in accordance with the collective bargaining agreement (“CBA”) at the rate of nine and one-half percent (9.5%) of elective deferrals. Participants are eligible for the defined contributions once they become an Eligible Employee, as defined by the CBA, and are fully vested in these defined contributions.

Participant Accounts

Under the Plan, a separate account is maintained for each participant. Each participant’s account is credited with the participant’s contribution, employer contributions, and allocations of Plan earnings and charged with an allocation of administrative expenses, if any. Participant contributions and employer contributions are allocated, at the participant’s election, to several investment vehicles in registered investment companies and fixed interest accounts in a group variable annuity contract, held at The Variable Annuity Life Insurance Company and VALIC Trust Company Inc. (the “Plan Custodian”).

Participant Loans

The Plan provides for participants to obtain loans directly from the Plan Custodian, as opposed to borrowing from their individual accounts; accordingly, such loans are not deemed to be Plan assets. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50%, of their vested balance. Loan terms range from 1 to 5 years, or up to 10 years for the purchase of a principal residence. The loans are collateralized by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates. At June 30, 2024 and 2023, the amount collateralized for participant loans held by the Plan Custodian approximated \$480,000 and \$427,000, respectively.

When a loan is set up, an amount equal to the principal loan balance plus an amount equal to the first quarter’s interest and surrender charges are transferred to either the Loan Collateral Fund, Loan Escrow Fund, or Plan Loan Fund for the participant and are used as collateral for the loan in the event the loan is not repaid. The underlying investments of these funds are in the Registered Investment Companies, at fair value.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer-contributed portion of their accounts is based on years of continuous service, as follows:

Participants in certain collective bargaining agreements were 100% invested after the Plan restatement during the year ended June 30, 2024.

Forfeitures

Forfeitures of terminated participants' non-vested accounts are used to reduce employer matching contributions and Plan expenses. The Plan Sponsor used approximately \$46,000 of forfeiture amounts to reduce the employer contributions during the year ended June 30, 2024. As of June 30, 2024 or 2023, the amount of unallocated forfeiture balance amounted to approximately \$2,000 and \$8,000, respectively.

Payment of Benefits

Upon the death, permanent disability, or retirement of participants, distributions of benefits are made in lump-sum, partial, installment payments or annuities, as elected by the participant. There were no unpaid amounts allocated to participants electing to withdraw from the Plan at June 30, 2024 and 2023.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments held in registered investment companies are valued at quoted market prices or at net asset value ("NAV") calculated daily by the fund administrator, based upon the quoted market prices of the underlying securities held by the fund, less unpaid expenses.

Investments held in the Fixed Account Plus, Fixed Interest Option, and Short-Term Fixed Account (see Note 4) are deemed to be fully benefit-responsive investment contracts. Because these contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

The preceding methods described may produce a value calculation that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of marketable securities are reflected on a trade-date basis, and interest income is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation or depreciation in the fair value of the Plan's investments for each year is reflected in the statement of changes in net assets available for benefits as net appreciation/depreciation in fair value of investments. Realized gains and losses are calculated on a historical moving average cost basis.

Corrective Distributions

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability as of the Plan's year end and reflected as an offset to participants' contributions on the statement of changes in net assets available for benefits. Corrective distributions payable approximated \$18,000 and \$14,000 as of June 30, 2024 and 2023, respectively.

Payment of Benefits

Participant benefits are recorded when paid.

Administrative and Other Costs

During the year ended June 30, 2024, administrative costs amounting to approximately \$197,000 were charged by the Plan Custodian directly to the Plan. Certain other investment-related fees and expenses are included in net appreciation in fair value of investments. The Plan Sponsor incurred administrative expenses on behalf of the Plan in the amount of \$22,000 during the Plan year ended June 30, 2024.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles and with the Rules and Regulations for Reporting and Disclosure under ERISA requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events

The Plan Sponsor has evaluated subsequent events for recognition and disclosure through April 15, 2025, which is the date the financial statements were available to be issued.

Note 3. Plan Certification

The Plan Custodian holds the Plan's investments and executes all investment transactions. All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and collateralized loans outstanding at June 30, 2024 and 2023, net appreciation in fair value of investments, and interest and dividends for the year ended June 30, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Plan Custodian.

Note 4. Fully Benefit-Responsive Investment Contracts

The Plan has entered into fixed interest contracts with the Plan Custodian where there are three fixed interest options: Short-Term Fixed Account (“STF”), Group Fixed Unallocated Annuity Contract (“GFUA”), and Fixed Account Plus (“FAP”). These accounts are deemed fully benefit-responsive. The STF credits interest on a portfolio basis. On the portfolio basis, all amounts accumulated will be credited with the same rate of interest for the current period. The Fixed Interest Option is the only available investment option in the GFUA. The interest rate is declared monthly, with interest credited on a daily basis at an annual effective rate. The Fixed Interest Option credits interest on a portfolio basis. On the portfolio basis, all amounts accumulated will be credited with the same rate of interest for the current period. The FAP and Fixed Interest Option credit interest periodically, but not less than annually, when interest rates are declared, and will be applied to amounts accumulated in separate time periods. The Plan’s ability to receive amounts due in accordance with the fully benefit-responsive contract is dependent upon the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments. If a participating plan terminates participation in the fixed interest contracts, the lesser of the guaranteed value or the fair value will be received. The Plan Sponsor believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value.

The underlying contracts of the FAP investments include the Portfolio Director Group Fixed (“PD”) and Variable Deferred Annuity Contract, the Independence Plus Group Fixed and Variable Annuity Contract, and the V-Plan Group Fixed Annuity Contract. The underlying contracts of the STF consist of the PD.

For the GFUA, the average yield of the fund and the average yield credited to the participants are the same, since there is no ownership right to the assets in the general account, which support the obligations of the Fixed Interest Option.

The GFUA is supported by the Plan Custodian’s general account. The Plan Custodian seeks to earn a risk adjusted return in excess of the rate credited on account values. Actual investments are subject to risks which include:

- Default risk (that bonds or mortgage holders may default);
- Credit risk (that bonds or mortgage’s credit ratings may decrease, reducing the market value of investments);
- Interest rate volatility risk (that interest rates may rise, reducing the value of bonds held, or that interest rates may decrease below the rate needed to support the product guarantees); and
- Disintermediation risk and liquidity risk (that participants and/or groups may move investments out of the general account, resulting in the need to sell assets which could be below market).

The Plan Custodian incurs these risks and holds additional assets (surplus) in order to have sufficient funds to meet participant and Plan guarantees.

Note 5. Risks and Uncertainties

The Plan’s investments are not insured and are subject to credit and market risks. Financial information relating to those investments is included in these financial statements based on information provided by the Plan Custodian.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 6. Income Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the "Code"). The terms of the Plan have been prepared to conform with the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for Plan participants under Section 403(b). The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7. Fair Value Measurements

The fair value of financial instruments is presented based upon a hierarchy of levels that prioritize the inputs of valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement in its entirety.

The three levels of the fair value hierarchy are described as follows:

- Level 1** Unadjusted quoted prices in active markets for identical assets or liabilities the Plan has the ability to access at the measurement date.
- Level 2** Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Significant, unobservable inputs used for valuing the asset or liability in which little or no market data exists.

Although it has not expressed any intent to do so, the Sunrise Group has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to participants' accounts will become fully vested.
