We have performed an audit of the financial statements of uAspire, Inc. 403(b) Retirement Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of uAspire, Inc. 403(b) Retirement Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1. Description of Plan

uAspire, Inc. 403(b) Retirement Plan (the Plan), is sponsored by uAspire, Inc. (the Organization). The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. Effective July 1, 2023, the Plan changed its name from uAspire DC Plan to uAspire, Inc. 403(b) Retirement Plan.

General

The Plan is a defined contribution benefit plan formed July 1, 2007 and established to provide certain employees of the Organization with retirement benefits in accordance with Section 403(b) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective July 1, 2023, the Organization's other defined contribution plan, uAspire TDA Plan, was merged into this Plan. Furthermore, the Plan was amended and restated effective on July 1, 2023. The restatement includes the addition of pre-tax, Roth, and catch-up deferrals as available contribution types. Additionally, the definition of Eligible Compensation has been amended.

During the year ended June 30, 2024, net assets totaling approximately \$2,550,000 were transferred into the Plan from the Organization's other defined contribution plan.

Eligibility

All employees of the Organization, except students, per diem, interns, and temporary employees, are immediately eligible to participate in the Plan and make voluntary contributions. Employees must complete 12 consecutive months of service, as defined in the Plan document, to become eligible to receive employer nonelective contributions.

Participant Contributions

Eligible participants may make voluntary contributions through salary reductions up to 100% of their eligible compensation, as defined, limited to the maximum amount allowable under the provisions of the IRC. Participants who are 50 years of age or older as of June 30, 2024, may contribute an additional "catch-up" contribution. The Plan also permits Roth 401(k) contributions. Roth 401(k) deferrals are subject to federal income taxes, and the maximum allowable participant contribution combined with voluntary pre-tax deferrals may not exceed the maximum amount allowable under the provisions of the IRC. Employee rollover contributions are also permitted.

Participant Investment Account Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, a money market fund, a pooled separate account, and an annuity contract as investment options for participants.

Employer Contributions

The Organization makes a nonelective contribution equal to 5% of eligible compensation, as defined, to eligible participants each pay period.

Participant' Accounts

Each participant's account is credited the participant's contribution, the employer's contribution and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and employer contributions plus actual earnings thereon.

Payment of Benefits

Upon termination of employment, retirement, and attainment of age 59 ½, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's account in a single lump-sum, partial distributions, installment, or annuity payments, as defined, or in a rollover distribution in accordance with the Internal Revenue Service (IRS) regulations and Plan provisions. Withdrawals from the Plan are also available for special hardship reasons, as defined.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Participants may borrow up to 50% of their account balance, with a minimum of \$1,000 and a maximum of \$50,000. Participants can have a maximum of 2 loans outstanding at one time. Notes receivable from participants bear interest at market rates for similar types of loans. Loan terms range from one to five years, however, if the loan is to acquire the principal residence of the participant, the term may be extended to 10 years. Notes receivables are secured by the balance in the participant's account. Principal and interest are paid directly by the participant.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investments contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investments contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Pooled separate accounts are valued at the net asset value (NAV) of shares held by the Plan at year-end. Money market funds are valued at the closing price reported by the fund sponsor. Mutual funds are reported at fair value based on unadjusted quoted prices in active markets for each share held by the fund.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Non-benefit-responsive investment contracts are valued using a discounted cash flow value using a risk-based market discount rate.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The Organization may, at its discretion, pay certain expenses incidental to administering the Plan. In the event the Organization does not pay all or part of such expenses, the expenses shall be paid by the Plan.

Subsequent Events

The Plan has evaluated subsequent events through April 14, 2025, which is the date the financial statements were available to be issued.

Note 3. Information Certified by the Plan's Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Teachers Insurance and Annuity Association of America and College Retirement Equities Fund (TIAA-CREF), qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of June 30, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended June 30, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of June 30, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Tax Status

The Plan operates under a volume submitter agreement in connection with a volume submitter plan and custodial document sponsored by Teachers Insurance and Annuity Association of America. This volume submitter plan document has obtained an advisory letter from the IRS stating that the volume submitter satisfies the

requirements under Section 403(b) of the Internal Revenue Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

Note 5. Related-Party Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments include shares of mutual funds, a pooled separate account, annuity contracts and a money market fund managed by TIAA-CREF. TIAA-CREF is the custodian, therefore, these transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules, as defined by ERISA. Total fees paid to TIAA-CREF were \$16,076 for the year ended June 30, 2024. The Organization provides certain administrative services at no cost to the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event that the Plan terminates, all accounts will be valued as of the termination date, and all accounts will be distributed in full to the participants.

Note 7. Risks and Uncertainties

The Plan provides for various investment options in accounts which invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 8. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

Level 1 Quoted prices in active markets for identical assets or liabilities

Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

Level 3 Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Recurring Measurements

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the

TIAA Traditional Annuity Contract

The significant unobservable input used in the fair value measurement of the Plan's TIAA traditional annuity contract is the interest rate of the investment contract. Changes in the contractual interest rate would have resulted in a significant change in fair value to the extent the change deviates from changes in market interest rates. Generally, an increase (decrease) in the difference between the contractual interest rate and the market interest rate would have been accompanied by a directionally opposed change in the fair value.

Fully Benefit-Responsive Investment Contract

The Plan invests a portion of its assets in a certain annuity contract with TIAA. The TIAA Traditional Annuity is a fixed rate annuity contract, a portion of which meets the fully benefit responsive investment contract criteria and therefore is reported as contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

The TIAA Traditional Annuity provides (during the accumulation phase) for guaranteed principal, a guaranteed minimum rate of interest and the potential for additional interest, as more fully described in the contractual agreement. Contract value represents contributions made under the contracts, plus earnings, less participant withdrawals, and administration expenses. When the contract value accumulation (plan asset) is converted to an annuity (plan withdrawal), based on certain actuarial assumptions, the present value of the stream of payments is equal to the accumulation.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value. The plan administration believes the occurrence of such events that would limit the Plan's ability to transact at contract value with Plan participants is not probable.
