INDEPENDENT AUDITORS' REPORT

1. Description of Plan:

The following description of the Kelsch Associates, Inc. (NJ) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Restated:

On June 1, 2020, the board of directors of Kelsch Associates, Inc. approved the restatement of this plan to include a 401(k) plan, effective July 1, 2020.

General:

The Plan is a participant directed defined contribution plan covering all full-time employees of the Company who have 1,000 hours of service in a Plan year and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for the oversight of the Plan.

Contributions:

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, common stocks, bonds, government securities, and an insurance investment contract as investment options for participants. Contributions are automatically invested in a designated balanced fund until changed by the participant. The Company contributes 100% of the first 3% and then 50% up to 5% of base compensation that a participant contributes to the Plan. The matching contribution made to satisfy the actual deferral percentage test safe harbor contributions requirement shall be fully vested.

The profit-sharing contributions are at the option of Plan Sponsor's (the Company) board of directors and are invested in a portfolio of investments as directed by the participants or the trustee if the participants decline to choose investments. In cases in which the participants do not select their investments, the trustee places them in a target retirement fund based on the retirement age (65) of the participant.

Participant's accounts:

Each participant's account is credited with the participant's allocation of (a) the Company's matching contributions, (b) Plan earnings, and (c) forfeitures of terminated participant's nonvested accounts. Allocations are based on a percentage of participant's earnings

2. Summary of significant accounting policies:

Basis of accounting:

The financial statements of the Plan are prepared under the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value.

Use of estimates:

The preparation of the financial statements in accordance with generally accepted accounting principles requires (“GAAP”) management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Valuation of investments and income recognition:

All investments are presented at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Administrative expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

Payment of benefits:

Benefits are recorded when paid.

Risks and uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values

Risks and uncertainties (continued):

of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of June 30, 2024, and 2023. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

3. Investments:

The Plan's investments are held in brokerage accounts. During 2024, the Plan's investments (including investments bought, sold and held during the year) appreciated (depreciated) in value by (\$1,173,312). All appreciation (depreciation) was in registered investment companies.

4. Plan termination

Although the Company has not expressed the intention to do so, the Company can discontinue contributions at any time and terminate the Plan subject to the provisions for ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

5. Income tax status:

The Plan obtained its latest determination letter in October 2011, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended and restated since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

7. Fair value measurements:

Generally accepted accounting principles define fair value as establishing a framework for measuring fair value, as well as a fair value hierarchy that prioritizes the inputs to valuation techniques. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

A fair value measurement assumes that the transaction to sell the asset or transfer the liability occurs in the principal market for the asset or liability or, in the absence of a principal market, the most advantageous market. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The fair value hierarchy under FASB ASC 820 prioritizes the inputs to valuation techniques used to measure fair value into three broad levels:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities the Plan has the ability to access.
- Level 2 inputs are inputs (other than quoted prices included within level 1) that are observable for the asset or liability, either directly or indirectly.
- Level 3 inputs are unobservable inputs for the asset or liability and rely on management's own assumptions about the market value. The unobservable inputs should be developed based on the best information available in the circumstances and may include the Plan's own data.
