Independent Auditor's Report

Opinion

We have audited the financial statements of Los Angeles Machinist Benefit Trust, an employee benefit plan subject to the Employee Retirement Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

Note 1 - Description of the Plan

The following description of the Los Angeles Machinist Benefit Trust (the Plan) is provided for general information purposes only. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

General

The Plan, a multiemployer health and welfare plan, was established in 1971 for the purpose of providing health care benefits to eligible participants covered by the collective bargaining agreements between District Lodge No. 94, various contractor associations and individual employer’s signatory to the agreements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration of the Plan is the responsibility of the Board of Trustees (the Trustees) and is governed by a joint board consisting of equal representation from the participating employers and District Lodge No. 94.

Benefits

The Plan provides health and welfare benefits, medical, dental, vision, counseling, life insurance, and prescription drugs and pharmaceutical supplies, for employees and or qualified members of the family, and for qualified dependents. Prescription drug and certain dental, vision, and medical claims are self-funded by the Plan. All life and certain medical benefits are insured with premiums paid by the Plan. The claims for dental, vision, and prescription drug are processed by the Plan’s third-party claims processors under administrative services only arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan. Ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan management has entered into a stop-loss insurance arrangement in an effort to limit the Plan’s exposure for self-funded medical benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

The Plan uses a pharmacy benefits manager (PBM) which periodically makes refunds to the Plan based on the utilization pattern of specific drugs.

Contributions and Eligibility

The Plan is primarily funded by employer contributions. Participating employers contribute such amounts as specified in their respective collective bargaining agreements. During the years ended June 30, 2024 and 2023, the participating employers contributed to the Plan at a range of rates per month listed below.

Active Participants

For bargaining unit employees, an employee becomes eligible for coverage on the first day of the month for which a contribution is received on their behalf, with coverage beginning the same day. These employees will maintain eligibility during each month for which a contribution is received on their behalf.

For non-bargaining unit employees, an employee becomes eligible on the first day of the second month of their employment, providing the participating employer made the required two months' pre-payment for coverage prior to the first day of the month of coverage. These employees will maintain eligibility during each month for which a contribution is received on their behalf.

Retired Participants (Non-Medicare)

Generally, an individual is eligible for medical and prescription drug benefits, vision benefits, dental benefits, and mental health and substance abuse treatment, if the individual:

- Receives a social security disability award or pension award from a qualified pension plan that contracts with a contributing employer making contributions to this Plan;
- Worked for a participating employer that made contributions on their behalf to this Plan for at least 24 of the last 36 months immediately before retirement date, excluding any qualified disability extension period for which their employer was not contractually obligated to pay for contributions;
- Worked at least 120 months under a collective bargaining agreement for one or more participating employers for which their employer contributed at least 120 months of contributions to the Plan for Class I coverage.

Retired Participants (Medicare)

Medicare retiree coverage is available for those older than 65 years of age.

Not all employers contribute to Retiree coverage. Self-pay rates for Class 1 retirees are subsidized by employers who contribute for retiree coverage. Class 2 & 3 retirees don't receive a subsidy and pay the full rate because the employers they retired from no longer contribute to the Plan or don't allocate a portion of their contribution to help offset retiree coverage.

Under certain conditions, participants are permitted to maintain Plan coverage by making self-payments. Continuation of health care benefits to persons who could otherwise lose those benefits due to certain events, as mandated by the Consolidated Omnibus Budget Reconciliation Act, has been adopted by the Plan.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Employer Contributions, Contributions Receivable, and Allowance for Credit Losses

The Plan's policy is to recognize contributions based on the latest executed collective bargaining agreement on an individual employer basis. Employer contributions reported in the financial statements include amounts relating to contribution paid by members through June 30. Contributions due but not paid prior to year-end are recorded as contributions receivable. Management of the Plan evaluates participating employers' contributions receivable periodically for potential credit losses based on historical experience as well as current and reasonable and supportable forecasted economic conditions. As of June 30, 2024 and 2023 there was no allowance taken.

The Plan has an employer payroll audit system in place in which the employers are randomly audited to verify that they are contributing in accordance with their signed agreement. Delinquencies may arise due to these payroll audits and are recorded as contributions when collected.

Deferred Contributions

Contributions received in June for July coverage are reported as deferred contributions on the statements of net assets available for benefits.

Payment of Benefits

Claims and premiums are recorded when paid. Premiums paid are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Claim payments are recorded when submitted to the Plan by the third-party claims processor for reimbursement. Claims paid by the claims processor prior to year-end or claim payments submitted to the Plan by the third-party claims processor that are not yet paid are recorded as an amount currently payable in the accompanying statements of benefit obligations. Premiums not yet paid at year-end are included as an amount currently payable in the accompanying statements of benefit obligations.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. The Plan's Trustees determines the Plan's valuation policies utilizing information provided by the investment advisors.

Purchases and sale of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on investments bought and sold as well as held during the year.

The classification of investment earnings reported in the statements of changes in the net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Stop Loss

Premiums for stop loss insurance are included in premiums paid in the accompanying statements of changes in net assets available for benefits. Stop loss refunds received for 2024 and 2023 claims totaling \$0 and (\$5,336), respectively, are netted against claims paid in the accompanying statements of changes in net assets available for benefits. As of June 30, 2024 and 2023, there were no stop loss reimbursements receivable.

Refunds and Rebates

Refunds from the Plan's PBM are recorded when earned. Pharmacy rebates for the years ended June 30, 2024 and 2023 totaling \$265,795 and \$105,385, respectively, are netted against claims paid in self-funded benefits in the accompanying statements of changes in net assets available for benefits.

Expenses

Expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Current Benefit Obligations

As a result of the eligibility provisions of the Plan, hours worked by participants through June 30, 2024 and 2023, produced eligibility through August 2024 and 2023, respectively, for active participants. Accordingly, group insurance premiums and claims incurred are accrued on the basis of hours worked through June 30, 2024 and 2023, and eligibility through August 2024 and 2023, respectively. These amounts are recorded as amounts currently payable on the statements of benefit obligations.

The liabilities for future payment of claims incurred but not reported at June 30, 2024 and 2023, have been estimated by the Plan administrator based on prior year claims data applied to current year paid claims for July 2024, August 2024, and September 2024 for eligibility for June 30, 2024 and prior. These amounts are paid by the Plan only if claims are submitted and approved for payment and are recorded as amounts currently payable on the statements of benefit obligations.

Postretirement Benefit Obligations

Postretirement benefit obligations have been recognized for retiree health benefits for eligible participants and their beneficiaries and dependents. The amount reported as the postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits

include future benefits expected to be paid to or for (a) currently retired or terminated employees and their beneficiaries and dependents and (b) active employees and their beneficiaries and dependents after retirement from service with participating employers. The postretirement benefit obligation represents the amount that is to be funded by contributions from the plan’s participating employers, from existing plan assets, and from self-payments by the participants.

The actuarial present value of the expected postretirement benefit obligation is determined by an independent actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

For measurement purposes, a 6.25% weighted average annual rate of increase in the average per capita cost of covered health care benefits was assumed for 2024; the rate was assumed to decrease gradually to 4.00% for 2033 and to remain at that level thereafter. These assumptions are consistent with those used to measure the benefit obligations at June 30, 2024.

The weighted-average health care cost-trend rate assumption has a significant effect on the postretirement benefit obligations. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of June 30, 2024 and 2023, by \$5,495,800 and \$5,109,500, respectively.

The following are significant assumptions used to determine the postretirement benefit obligations as of June 30, 2024 and 2023:

A change in actuarial assumptions created a \$2.67 million liability decrease. The plan selection and spouse coverage rates for future retirees were updated to reflect recent experience, the initial medical trend rates were raised, demographic rates were updated to those in the latest valuation of the I.A.M. National Pension Fund, and the discount rate was raised from 5.00% to 5.25% reflecting the change in available rates of return on high quality fixed-income investments since last year.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

The contributing employers make contributions to the Plan as needed to fund claims in excess of participants' contributions. The Plan's unfunded benefit obligations at June 30, 2024 and 2023, relate primarily to the portion of postretirement benefit obligations not covered by participant contributions. Any deficiency of the Plan's net assets over the benefit obligations is funded by the contributing employers on a pay-as-you-go basis.

Concentration of Credit Risk

The Plan holds assets in various certificates of deposit and money market deposit accounts, the balances of which are periodically in excess of federally insured limits. Accounts are guaranteed by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 per depositor, per insured bank, for each account ownership category. At June 30, 2024 and 2023, the Plan had approximately \$2,516,000 and \$2,600,000, respectively, in excess of FDIC-insured limits.

Adoption of New Accounting Standard

As of July 1, 2023, the Plan adopted Accounting Standards Update (ASU) No. 2016-13, Financial Instruments – Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments (ASU 2016-13), which replaces the incurred loss methodology with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. The CECL model is applicable to the measurement of credit losses on financial assets measured at amortized cost, including contribution receivables. CECL requires entities to measure all expected credit losses for financial assets held at the reporting date based on historical experience, current conditions, and reasonable and supportable forecasts. This standard provides financial statement users with more decision-useful information about the expected losses on financial instruments.

The Plan adopted ASU 2016-13 using the modified retrospective review method for all financial assets measured at amortized cost. Results for reporting periods beginning after July 1, 2023, are presented under Topic 326 while prior period amounts continue to be reported in accordance with previously applicable GAAP. The adoption of the new standard did not materially impact the Plan's financial statements. See Accounting Policies Notes for further disclosure of the Plan's Contributions Receivable

Subsequent Events

The Plan has evaluated subsequent events through April 4, 2025, the date which the financial statements were available to be issued.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual funds (including money market mutual fund) – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Corporate bonds – valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuer with similar credit ratings.

Exchange traded funds – valued at the daily closing price as reported by the fund. Exchange traded funds held by the Plan are open-ended management investment companies that are registered with the SEC. The shares are traded throughout the day at market prices.

Note 4 - Tax Status

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS), stating that the trust is tax exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. Plan management believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore believes that the related trust is tax-exempt. No federal or state income taxes have been recorded in 2024 for unrelated business taxable income.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 - Party-in-Interest Transactions

The Plan pays fees for several arrangements with service providers and affiliated entities. These transactions are considered exempt party-in-interest transactions under ERISA.

Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would-be material to the financial statements.

Note 8 - Priorities Upon Plan Termination

Although it has not expressed any intention to do so, the Trustees has the right under the Plan to modify the benefits provided to participants, and contributions required, and to terminate the Plan subject to the provisions set forth in ERISA. Upon termination, the Trustees shall complete the following:

- a) Make provisions out of the trust fund payment of any and all obligations of the trust and the expenses incidental to such termination.
- b) Arrange for a final audit and report of their transactions and accounts for the purpose of termination of their trusteeship.
- c) Give any notice and prepare and file any reports which may be required by law.
- d) Distribute the remaining assets in such a manner as consistent with the best interests and benefits of the participants and their beneficiaries.


