### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Center for Urban Community Services, Inc. 403(b) TDA Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### ***Opinion on the Financial Statements***

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section:

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

## Notes to Financial Statements June 30, 2024 and 2023

### NOTE A - DESCRIPTION OF THE PLAN

The accompanying financial statements and supplemental schedule are those of the Center for Urban Community Services, Inc. 403(b) TDA Plan (the "Plan"), and users of these financial statements and supplemental schedule are directed to the independent auditors' report on pages 1 through 4. Likewise, the brief description of the Plan contained herein is provided solely for purposes of general information and interested persons should refer to the Plan agreement for a more complete description of the Plan's provisions. A copy of the Plan's agreement can be obtained from the Center for Urban Community Services, Inc. ("CUCS"), which is the administrator of the Plan.

#### [1] General:

The Plan is a tax-deferred annuity plan designed to meet the requirements of Section 403(b) of the Internal Revenue Code (the "Code") and is subject to the provisions of the U.S. Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan covers all eligible employees of CUCS. TIAA and CREF hold the Plan's assets, execute investment transactions for the Plan and TIAA is the Plan's recordkeeper. The Plan administrator controls and manages the operation and administration of the Plan.

#### [2] Eligibility for participation:

Employees are eligible the first day of the month following their employment. However, certain employees are excluded from participation if they fall within certain categories as defined in the Plan agreement. Qualifying participants are eligible to remit employee contributions on a bi-weekly basis.

#### [3] Contributions:

Participants may elect to contribute up to 100% of their pre-tax annual compensation, as defined by the Plan, subject to the Internal Revenue Service ("IRS") limit. Catch-up contributions are permitted under the Plan for those participants who have reached the age of 50 before the end of the calendar year and are therefore eligible to make catch-up contributions. In no event may a participant's pre-tax contributions exceed any statutory limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan does not allow for after-tax Section 403(b) contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

#### [4] Participant accounts:

The activity in each participant's account includes: (i) the participant's contribution, (ii) benefit payments or withdrawals, (iii) allocations of the earnings or losses on Plan assets, and (iv) may be charged with an allocation of administrative expenses. Allocations are based on the participant's earnings, account balance, or eligible compensation, or specific transactions as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### [5] Vesting:

Participants are fully vested in all contributions to the Plan, plus actual earnings thereon, immediately when made.

#### NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

##### [6] Notes receivable from participants:

Beginning in 2020, participants were no longer able to borrow from TIAA and use a portion of their Plan account balance as collateral for the loan as described in Note A[7]. In 2020, TIAA began offering only the opportunity to borrow through notes receivable from participants whereby participants borrow from their participant account balance under the Plan. Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50%, of their vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%, as defined. Interest rates on outstanding loan balances are 4.25% to 9.50% at June 30, 2024 and 2023, respectively. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

##### [7] Plan loans:

Participants were able to borrow from TIAA and CREF, the insurance company, and use a portion of their Plan account balance as collateral for the loan. These loans were issued as separate contracts by TIAA and CREF and do not represent loans from, or distributions of, Plan assets. Instead, loans are collateralized using a participant's TIAA Traditional Annuity account balance in an amount equal to 110% of the outstanding loan balance. A participant was able to borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 45%, of their vested account balances, subject to annuity contract and Plan provisions. Loan terms range from one to five years; however, terms may exceed five years for the purchase of the participant's primary residence, as defined. Interest rates on outstanding loan amounts as June 30, 2024 and 2023, range from 5.28% to 5.56% and 4.00% to 5.56%. Principal and interest is paid ratably by the participant to TIAA and CREF and not through a salary-reduction arrangement with CUCS. Plan loan balances outstanding from participants to TIAA and CREF were approximately \$15,800 and \$38,000 as of June 30, 2024 and 2023, respectively. As of June 30, 2024 and 2023, approximately \$17,400 and \$41,000, respectively, of the participants' TIAA Traditional Annuity account balances were pledged as a collateral.

As described in Note A[6], these Plan loans are no longer offered by TIAA, and the existing collateralized loans will remain in effect until they are paid off.

##### [8] Payment of benefits:

Upon termination of service, a participant (or a beneficiary) is entitled to receive a lump-sum amount equal to the total value of his or her account as of the most recent valuation date. If a beneficiary is not named at the time of death, 50% of the participant's balance will be paid to the surviving spouse and 50% to his or her estate. If a beneficiary is not named and there is no surviving spouse, the remaining balance is paid to the estate.

##### [9] Plan termination:

Although it has not expressed any intent to do so, CUCS has the right under the Plan to terminate the Plan, subject to the provisions of ERISA.

### NOTE B - SUMMARY OF ACCOUNTING POLICIES

#### [1] Basis of accounting:

The accompanying financial statements have been prepared using the accrual basis of accounting.

Investments held by a defined contributions plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

#### [2] Investments:

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value), in accordance with the provisions of the Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurements and Disclosures*. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value of investments.

Participants direct their contributions into any of three investment alternatives: (i) fixed annuity contracts, (ii) variable annuity contracts, and (iii) a pooled separate account. (See Notes D and E for further discussion concerning each of these investment alternatives.)

Purchases and sales of investment securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold, as well as those held during the year.

#### [3] Payment of benefits:

Benefits are recorded when paid.

#### [4] Plan expenses:

Substantially all expenses of maintaining the Plan are paid by CUCS, with the exception of service fees charged directly to the Plan in the amount of \$1,350 during 2024. Expenses that are paid by CUCS are excluded from these financial statements.

#### [5] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect (i) the reported amounts of net assets available for benefits at the date of the financial statements, (ii) the changes in net assets available for benefits during the reporting period, and (iii) when applicable, the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### **NOTE B - SUMMARY OF ACCOUNTING POLICIES (CONTINUED)**

##### **[6] Income taxes:**

The Plan is a tax-deferred annuity plan designed to meet the requirements of Section 403(b) of the Code and is subject to the provisions of ERISA. The Plan is required to operate in conformity with Section 403(b) of the Code to maintain the tax-exempt status for Plan participants under Section 403(b) of the Code. The Plan administrator believes that the Plan is currently designed and operating in accordance with the applicable requirements of Code Section 403(b) and, therefore, believes the Plan is qualified and the related accounts are tax-exempt. Therefore, no provision for income taxes has been included in the accompanying financial statements.

U.S. GAAP requires the Plan's management to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

##### **[7] Subsequent events:**

The Plan has evaluated subsequent events through April 10, 2025, the date on which the financial statements were available to be issued.

#### **NOTE C - INVESTMENT CERTIFICATION**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, TIAA and CREF has certified to the completeness and accuracy of all investments and related investment activity and notes receivable to participants and related activity in the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended June 30, 2024, and the accompanying supplemental schedule of assets (held at end of year) as of June 30, 2024.

#### NOTE D - INVESTMENTS AND FAIR VALUE MEASUREMENTS

The FASB's ASC Topic 820 provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during Plan years 2024 and 2023:

*TIAA Real Estate Account* – This is a pooled separate account/insurance company account and is a variable annuity product valued at net asset value ("NAV") per accumulation unit, as a practical expedient for measuring fair value, based on the market value of the underlying real estate holdings or other real estate related investments. Real estate holdings are valued principally utilizing external appraisals, which are estimates of property values based on the assessment of specialists and reported by TIAA. The TIAA Real Estate Account sometimes holds securities as well, and these are generally valued from independent pricing sources. Transactions out are limited to one per calendar quarter. The TIAA General Account provides the Real Estate Account with a liquidity guarantee.

*CREF Variable Annuity Accounts* – These are variable annuity accounts that invest principally in equity securities, fixed-income instruments and short-term investments in accordance with each portfolio's investment objectives. Each CREF Account is a separate portfolio with its own investment objective and strategies. Investments in a CREF Variable Annuity Account enables a unit-holder to acquire units whose accumulation unit value, or NAV used as a practical expedient to measure fair value, is calculated each business day. The value of a unit-holder's investment rises and falls with the returns on the underlying assets. Account investments are primarily valued using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments, including matrix pricing.

*CREF Money Market Account* – The CREF's Money Market Account's portfolio are portfolio securities that are valued at their amortized cost. This valuation method does not factor in unrealized gains or losses on the account's portfolio securities. Amortized cost valuation involves first valuing a security at its cost, and thereafter assuming a constant amortization to maturity of any discount or premium, regardless of the impact of fluctuating interest rates on the security's market value.

Accumulation units in CREF accounts are transacted at the accumulation unit value. Participants will be locked out of a CREF account for 90 days if a purchase-sale-repurchase within that account is made within a 60-day period, other than for the CREF Money Market Account.

*TIAA Access Annuities* – This is a separate account of TIAA and is a variable annuity registered with the Securities and Exchange Commission as an investment company under the Investment Company Act of 1940. It operates as a unit investment trust and invests in shares of underlying mutual funds. Contributions to the TIAA Access Annuity buy accumulation units, the value of which, is calculated daily. The accumulation units are valued at NAV as a practical expedient for measuring fair value. The value of a participant's investment rises and falls with the return on the underlying assets. The strategy of these investments is generally embedded in the name of the particular investments as shown on the supplemental schedule of assets (held at end of year). The name typically includes the investment style and/or market capitalization. There are no redemption fees or restrictions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (B) The strategy for these investments is described below and is generally embedded in the accounts disclosed in the accompanying supplemental schedule of assets (held at end of year):

The CREF Stock Account seeks a favorable long-term rate of return through capital appreciation and investment income by investing primarily in a broadly diversified portfolio of common stocks. Under normal circumstances, the account invests at least 80% of its assets in equity securities of foreign and domestic companies.

The CREF Social Choice Account seeks a favorable long-term rate of return that reflects the investment performance of the financial markets while giving special consideration to certain social criteria. The account is balanced, with assets divided between domestic and foreign stocks and other equities (about 60%) and bonds and other fixed-income securities, including money market instruments (about 40%). The account invests only in companies that are suitable from a financial perspective and whose activities are consistent with certain environmental, social and governance criteria.

The CREF Global Equities Account seeks a favorable long-term rate of return through capital appreciation and income from a broadly diversified portfolio that consists primarily of foreign and domestic common stocks. Under normal circumstances, the account invests at least 80% of its assets in equity securities of foreign and domestic companies.

The CREF Core Bond Account seeks a favorable long-term rate of return, primarily through high current income consistent with preserving capital. Under normal circumstances, the account invests at least 80% of its assets in a broad range of fixed-income securities. The majority of the account's assets are invested in U.S. Treasury and other governmental agency securities, corporate bonds and mortgage-backed or other asset-backed securities.

The CREF Growth Account seeks a favorable long-term rate of return, mainly through capital appreciation, primarily from a diversified portfolio of common stocks that present the opportunity for exceptional growth. Under normal circumstances, the account invests at least 80% of its assets in common stocks and other equity securities. The account invests primarily in large, well-known, established companies, particularly those with new or innovative products, services or processes that may enhance future earnings prospects.

The CREF Equity Index Account seeks a favorable long-term rate of return from a diversified portfolio selected to track the overall market for common stocks publicly traded in the United States, as represented by a broad stock market index. The account buys most, but not necessarily all, of the securities in its benchmark, the Russell 3000® Index, and will attempt to create a portfolio that closely matches the overall investment characteristics of this index.

The CREF Inflation-Linked Bond Account seeks a long-term rate of return that outpaces inflation, primarily through investment in inflation-indexed bonds, fixed-income securities whose returns are designed to track a specified inflation index over the life of the bond. Under normal circumstances, the account invests at least 80% of its assets in U.S. Treasury inflation-indexed securities.

The TIAA Access Lifecycle Accounts seek high total return over time through a combination of capital appreciation and income. Each of the Lifecycle Funds is designed to provide a single diversified portfolio managed with a target retirement date in mind. The target date is the approximate date when investors expect to begin withdrawing money from the funds. The funds' actual allocations may vary up to 10% from the current target allocations. Each of the Lifecycle portfolios invests in several underlying equity, fixed-income and direct real estate funds. The strategy of the remaining TIAA Access accounts is generally embedded in the name of the particular investment as shown on the supplemental schedule of assets held for investments. The name typically includes the investment style and/or market capitalization. There are no redemption fees or restrictions.

- (C) The TIAA Real Estate Fund seeks to obtain favorable long-term total return through capital appreciation and current income by investing primarily in equity securities of companies engaged in the real estate industry.

#### Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

#### NOTE E - INVESTMENTS AT CONTRACT VALUE

The TIAA Traditional Annuity is a fixed-rate annuity contract that is fully and unconditionally guaranteed by TIAA. The guarantees and returns of the TIAA Traditional Annuity are backed by TIAA's claims-paying ability. Liquidity restrictions apply to the TIAA Traditional Annuity under certain types of annuity contracts. The TIAA Traditional Annuity provides a guarantee of principal, a guaranteed minimum rate of interest (generally 3%) and the potential for additional interest if declared by TIAA. Additional interest, when declared, remains in effect for the "declaration year," which begins each March 1st. Additional interest is not guaranteed for future years. Contributions to a participant's account purchase a guaranteed amount of lifetime annuity income.

When a participant's account in the TIAA Traditional Annuity is annuitized based on available options, the present value of the stream of payments is equal to the account balance. The subsequent stream of annuity payments occurs outside of the Plan and does not represent an obligation of the Plan. The TIAA Traditional Annuity is fully benefit responsive and is reported at contract value. The contract value equals the accumulated cash contributions, interest credited to the contracts, and transfers, if any, less any withdrawals and transfers. The TIAA Traditional Annuity is not available for sale or transfer on any securities exchange.

The TIAA Traditional Annuity within the Group Supplemental Retirement Annuity ("GSRA") contract has no liquidity restrictions.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Code or the failure of the trust to be tax-exempt under Section 501(a) of the Code;
2. Premature termination of the contracts;
3. Plan termination or merger;
4. Changes to the Plan's prohibition on competing investment options; and
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation; and
4. A material amendment to the agreements without the consent of the issuer.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

#### **NOTE F - RISKS AND UNCERTAINTIES**

The Plan's investments are included in various investment alternatives made available by TIAA and CREF. Investment securities are exposed to various risks, such as interest-rate, market, credit, liquidity and market-perception risks, as well as risks related to the financial strength of the insurance companies. Due to the level of risk associated with any investment, it is at least reasonably possible that changes in the values of the Plan's investments will occur in the near term, and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuations of investments at June 30, 2024 may not necessarily be indicative of amounts that could be realized in a subsequent market exchange.

#### **NOTE G - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

A substantial portion of the investments are fixed and variable annuities and a pooled separate account sponsored by TIAA and CREF. TIAA is the Plan's recordkeeper, TIAA and CREF are the Plan's insurance companies; therefore, transactions related to these investments qualify as party-in-interest transactions. For 2024, the Plan paid TIAA and CREF \$1,350 for administrative fees.
