## NOTES TO FINANCIAL STATEMENTS

### Note 1. Plan Description

The following description of El Concilio Profit Sharing 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

#### General:

Effective July 1, 2002, The Catholic Council for the Spanish Speaking of the Diocese of Stockton (the “Council”) established a defined contribution 401(k) profit sharing plan for eligible employees. Effective July 1, 2016, the Plan became a “Safe Harbor” Plan. The Plan was most recently restated for the Cycle 3 Restatement effective July 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### Contributions:

Each year, participants may contribute from their pre-tax annual compensation up to the maximum limit established annually by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Council contributes 100% of the first 4% of base compensation that a participant contributes to the Plan. The Council also contributes a discretionary profit sharing contribution at the discretion of the Board of Directors of the Council. In order to receive discretionary profit sharing contributions under the Plan, the participant must have completed two years of service and be employed at the end of the plan year. The contribution is allocated to eligible participants based on the ratio of compensation to total eligible compensation. Contributions are subject to certain limitations.

#### Vesting:

All amounts credited to a participant’s salary deferral, discretionary contribution, rollover and earnings thereon and all employer’s contribution portion are fully vested and non-forfeitable at all times.

#### Participant Accounts:

The custodian of the plan maintains an account for each participant. Each participant account is credited with the participant’s contribution and allocations of (a) the Council’s contribution and (b) Plan earnings, and charged with an allocation of administrative expenses, not paid by the Council. Allocations are based on participant compensation or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

## NOTES TO FINANCIAL STATEMENTS

### **Note 1. Plan Description (Cont.)**

#### Payment of Benefits:

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various options as defined in the Plan. Similar options are available upon termination of employment. The terminated participant may provide rollover instructions to an IRA or to another qualified plan. The Plan permits a hardship distribution to a participant prior to and after separation from service in accordance with the Plan's hardship policies. The Plan permits an in-service distribution to a participant in accordance with the Plan's in-service policies.

#### Notes Receivable from Participants:

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to lesser of \$50,000 or 50% of their account balance. Loans are secured by the borrower's vested account balance and are evidenced by the borrower's promissory note. Principal and interest is paid ratably through payroll deductions. Loans bear interest at a rate equal to the prime rate plus 2%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Interest received is credited directly to the borrower's account.

### **Note 2. Summary of Significant Accounting Policies**

#### Basis of Accounting:

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation in fair value of investments presented on the statement of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Note 2. Summary of Significant Accounting Policies (Cont.)**

##### Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participants account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note is recorded as a benefit payment based upon the terms of the plan document.

##### Benefits:

Benefits are recorded when paid.

##### Administrative Expenses:

Recordkeeping and management functions by John Hancock are annual charges per participant of 0.46% and .40% on a pro-rata basis, respectively. Expenses related to specific participant transactions are charged to the respective participant's account. Other administrative expenses charged by the third party administrator and accounting fees are paid by the Council. During the year ended June 30, 2024, the Plan paid \$67,511 in administrative fees.

##### Use of Estimates:

The preparation of financial statements is in conformity with accounting principles generally accepted in the United States of America. Those standards require management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

##### Date of Management's Review of Subsequent Events:

The Plan has evaluated subsequent events through April 14, 2025, the date on which the financial statements were available to be issued. There were no material modifications to the Plan or plan provisions.

### Note 3. Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 measurements consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1), and Level 3 measurements are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There are no plan assets requiring the use of Level 1 or 3 inputs for the periods presented.

#### Level 2 Fair Value Measurements

The fair values of the pooled separate accounts and the guaranteed interest accounts are based on quoted net asset values of the shares held by the Plan at year-end.

**Note 4. Summary of Information Certified by Custodian (Unaudited)**

The Plan's investments are held and administered by John Hancock Life Insurance Company, as custodian. The custodian of the Plan has provided certifications that the following information, which is contained in or used to develop the accompanying financial statements, is complete and accurate:

Investments, at fair value as of June 30, 2024 and 2023.

Notes receivable from participants as of June 30, 2024 and 2023.

Net appreciation in fair value of investments for the year ended June 30, 2024.

Interest for the year ended June 30, 2024.

Interest income on notes receivable from participants for the year ended June 30, 2024.

**Note 5. Plan Termination**

Although it has not expressed any intent to do so, the Council has the right to terminate the Plan at any time subject to the provisions set forth in ERISA and the Internal Revenue Code. Upon termination of the Plan, the total net assets of the Plan are to be distributed to the participants in proportion to their account balances.

**Note 6. Related Party Transactions**

During the June 30, 2024 and 2023 plan years, the custodian of the plan provided participant-level services as defined by the Plan and, therefore, these transactions qualify as party-in-interest. These transactions are covered by an exemption from the "prohibited transaction" provisions of ERISA and the Internal Revenue Code.

Participants may borrow from their vested account balance. Such loan transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA and the Internal Revenue Code.

### **Note 7. Income Tax Status and Plan Amendments**

The Council adopted a non-standardized pre-approved plan provided by Central Administrative Services, Inc., DBA Hicks Pension Services. The Internal Revenue Service has determined and informed the provider of the plan by a favorable opinion letter dated June 30, 2020, that the plan is designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”). The plan’s opinion letter is being relied on by the Plan. Plan management and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the Plan’s tax returns remain open for three to four years for income tax examination.

### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
