INDEPENDENT AUDITOR'S REPORT

To the Participants and Trustees of

Opinion

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of Plumbers and Steamfitters Managed Health Care Plan (the “Plan”) are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation, Transactions and Income Recognition

Investments are carried at fair value, which is determined, presented and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC 820”), *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the “exit price”) in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan’s assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

Level 3 - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities’ own judgments and estimations, or some other pricing method using unobservable inputs.

Inputs and Valuation Methods

In determining fair value, FASB ASC 820 allows various valuation approaches. The specific method used for the Plan’s investment class is presented below:

Mutual Funds: The fair value of mutual funds is generally based on quoted market prices in active markets (Level 1).

Valuation Methods, Consistency

The valuation techniques used in the accompanying financial statements have been consistently applied.

Transactions and Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the gains and losses on investments bought and sold as well as held during the year. Certain investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Contributions Receivable

Employer contributions due and not paid prior to year-end are recorded as employer contributions receivable. Allowance for credit losses is considered unnecessary and is not provided. Contributions due as a result of payroll audits have been recorded net of an allowance equal to the amount due because collectability is uncertain. Therefore, delinquent contributions are recorded when received. Reciprocity is recorded when employer contributions, income or payments are identified.

Payment of Benefits

Premiums paid are recorded as premium payments in the accompanying statements of changes in net assets available for benefits.

Benefit Obligations

Accumulated eligibility credits include the Plan's estimated future liability as of June 30, 2024 and 2023, for group insurance premiums. The liability is based on actual premiums and related administrative expenses for eligibility earned as of June 30, 2024 and 2023, to provide coverage for July through August. Accumulated eligibility credits also include the Plan's estimated "hours bank" liability as of June 30, 2024 and 2023, based upon the total hours banked as of June 30, 2024 and 2023 converted to equivalent hours of coverage and multiplied by the estimated monthly cost to provide benefits, including administrative costs.

Post-retirement benefit obligations are actuarially determined based on claims experience, census data and other factors.

Reciprocity Agreements

In 2004, the Plan entered into a United Association Health & Welfare Fund Reciprocal Agreement which applies to all reciprocation between all signatory health and welfare funds. Signatory funds provide benefits for employees in the plumbing and pipe-fitting industry who are employed by employers bound to the collective bargaining agreements with the United Association of Journeymen and Apprentices of the Plumbing and Pipe Fitting Industry of the United States and Canada or one of its affiliated state or provincial associations, district councils or local unions. In accordance with these agreements, the Plan is required to remit funds received and is entitled to receive funds from participating employers on behalf of temporary employees to and from the employees' participating local unions. For the years ended June 30, 2024 and 2023, the Plan remitted \$244,239 and \$1,065,968 and received \$1,824,303 and \$1,892,864 of reciprocal cash in accordance with these agreements with the participating local unions, respectively. Reciprocal payments received are included in employer contributions in the statements of changes in net assets available for benefits.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Recently Adopted Accounting Standards

In June 2016, the FASB issued an Accounting Standards Update ("ASU") 2016-13, *Financial Instruments - Credit Losses* (Topic 326) amending the accounting for credit losses on financial statements. This methodology replaced the incurred loss methodology with the expected credit losses using a wide range of reasonable and supportable information. The amendment affects loans, debt securities, trade receivables, net investments in leases, off-balance-sheet credit exposure and other financial instruments recorded at amortized cost.

The Plan adopted the new standard effective July 1, 2023, using the modified retrospective approach. Upon adoption, there was no cumulative-effect adjustment to the opening balance of net assets.

Risks and Uncertainties

The post-retirement benefit obligation of the Plan is calculated based on certain assumptions pertaining to interest rates, participant demographics and other assumptions, all of which are subject to change. Due to the inherent uncertainty of the assumption process, it is at least reasonably possible that changes in these assumptions in the near term would be material to the disclosure to the financial statements of the post-retirement benefit obligation of the Plan.

The Plan invests in mutual funds. Such investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Leases

The Plan categorizes leases with contractual terms longer than twelve months as either operating or finance. Finance leases are generally those leases that allow the Plan to substantially utilize or pay for the entire asset over its estimated life. All other leases are categorized as operating leases. Leases with contractual terms of 12 months or less are not recorded on the statements of net assets available for benefits. The Plan had no finance leases during 2024 and 2023.

Options to extend lease terms, terminate leases before the contractual expiration date, or purchase the leased assets, are evaluated for their likelihood of exercise. If it is reasonably certain that the option will be exercised, the option is considered in determining the classification and measurement of the lease. The Plan has included a right of early termination clause in its lease with Vaca 343 MT LLC in that the Vaca 343 MT LLC and the Plan each have the unconditional right to terminate the lease early, without penalty or payment of any kind, by delivering to the other party not less than 90 calendar days' prior written notice of the early termination date of the lease. Therefore, the lease with the Vaca 343 MT LLC is considered a short-term lease and is not required to be recorded on the statements of net assets available for benefits. See Note 9 for additional information on these leases.

2. DESCRIPTION OF THE PLAN

The Plan was established pursuant to a trust agreement, dated April 22, 1994, between United Association of Plumbers and Steamfitters, Local Union No. 343 (the "U.A. Local No. 343") and certain employer associations. The purpose of the Plan is to provide welfare benefits for eligible Plan participants and their dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

General eligibility rules under the Plan are as follows:

- a. All active employees covered by collective bargaining agreements negotiated by the union requiring standard contributions by contributing employers to the Plan.
- b. Initial eligibility requires 300 hours to be worked in covered employment in a period of six months.
- c. Generally, to maintain eligibility, an employee must work or have an accumulated in hour bank reserve of at least 135 hours in each eligibility month.

The Plan provides eligibility using a skip-month method whereby hours worked in one month are utilized to provide coverage for benefits starting the first day of the second following month. Hours reported in excess of those necessary to provide an active employee with monthly coverage are accumulated in an “hours bank” to provide eligibility during periods of unemployment or disability.

Plan provisions allow a participant to accumulate up to six months of coverage in their hours bank. A participant is required to have 135 hours in their hours bank in order to receive eligibility for a month.

Medical, drug and vision benefits are provided through service agreements with Kaiser Foundation Health Plan, Inc., United Healthcare of California, and Vision Service Plan. Life, accidental death and dismemberment benefits, and dental benefits are provided under a group insurance policy with Metropolitan Life Insurance.

Continuation of health care benefits to persons who would otherwise lose those benefits due to certain events, as mandated by the Consolidated Omnibus Budget Reconciliation Act (“COBRA”), has been adopted by the Plan.

The cost of the post-retirement benefits is shared by the Plan’s participating employers and retirees. In addition to deductibles and co-payments, for the years ended June 30, 2024 and 2023, 7.8% and 8.8%, respectively, of the estimated cost of providing post-retirement benefits in the current and prior year is through retiree contributions.

Participants should refer to the Summary Plan Description for a more complete description of the Plan. The Plan’s Board of Trustees has the right under the Plan to modify or discontinue any benefit provided.

3. PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

4. TAX STATUS

The Plan obtained its latest determination letter, dated October 22, 1996, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan’s administrator and the Plan’s counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax exempt as of the financial statements date.

Accounting principles generally accepted in the United States of America require management to evaluate the tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service. The Plan’s administrator has analyzed the tax positions taken and has concluded that, as of June 30, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. FUNDING POLICY

The Plan is financed by contributions from employers and retirees and by participants electing COBRA coverage. The monthly employer contribution rate is specified in the collective bargaining agreements. The rate for retiree and COBRA coverage is determined annually by the Board of Trustees.

8. RELATED ORGANIZATIONS

U.A. Local No. 343 is a sponsor of the Plan and also provides administration services to the Plan. For each of the years ended June 30, 2024 and 2023, the Plan remitted \$104,964 and \$100,836, respectively, to reimburse U.A. Local No. 343 for administrative expenses incurred on behalf of the Plan. The reimbursement amount is based on time studies of the estimated costs incurred by U.A. Local No. 343 to administer the Plan.

Members of the Plan's Board of Trustees are also members of the Board of Trustees of U.A. Local No. 343 Defined Benefit Plan. Retirees receiving a pension from U.A. Local No. 343 Defined Benefit Plan may elect to have their monthly contributions to the Plan deducted from their pension checks and transferred directly to the Plan. As of June 30, 2024 and 2023, the amounts due from U.A. Local No. 343 Defined Benefit Plan to the Plan totaled \$0.

The Plan has a sublease agreement with Vaca 343 MT LLC (the “LLC”), whose sole member is U.A. Local No. 343 Defined Benefit Plan. As of June 30, 2024 and 2023, the amount due to Vaca 343 MT LLC totaled \$0. Additional information regarding the lease is disclosed in Note 9.

9. OBLIGATIONS UNDER OPERATING LEASE

The Plan entered into a ten-year lease (with an option to extend for five additional years) with Vaca 343 MT, LLC. The lease expires on November 30, 2029, with an option to extend until November 30, 2034. The LLC’s only member is the UA Local No. 343 Defined Benefit Plan (the “DBP”). The Plan and the DBP share a common Board of Trustees. The Plan’s annual rent expense under this lease was \$99,000 and \$96,000, for the years ended June 30, 2024 and 2023, respectively. The lease contains a mutual termination clause, yielding it a short-term lease under accounting principles generally accepted in the United States of America. However, should the lease be fulfilled throughout the remaining stated terms, the future minimum rental payments are as follows:

10. POST-RETIREMENT BENEFIT OBLIGATIONS

The Plan provides health care coverage to certain retired participants and their dependents.

The amount reported as the post-retirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees’ service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants. Post-retirement benefits include future benefits expected to be paid to or for: (1) currently retired or terminated employees and their beneficiaries and dependents, and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active employee’s full eligibility date, the post-retirement benefit obligation is the portion of the expected post-retirement benefit obligation that is attributed to that employee’s service in the industry rendered to the valuation date.

The actuarial present value of the expected post-retirement benefit obligations is determined by an actuary and is the amount that results from applying actuarial assumptions to historical benefits cost data to estimate future annual benefits costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the post-retirement benefit obligations as of June 30, 2024 and 2023, by \$20,975,918 and \$23,571,562, respectively.

The statements of changes in benefit obligations for the years ended June 30, 2024 and 2023, include changes in post-retirement obligations of approximately (\$6,465,455) and \$1,478,693 primarily due to an update to future medical cost assumptions, self-pay rate assumptions, and mortality table and medical inflation.

11. SUPPLEMENTAL ACCOUNTS

During 2004, the Board of Trustees of the Plan approved formal rules regarding supplemental accounts. Supplemental accounts are not vested and can only be used as provided for in the Plan rules. Supplemental accounts are intended primarily to be used to make retiree welfare payments under this Plan. Benefits will be paid to an eligible Plan participant or surviving eligible dependent after incurring a qualified expense and submitting a claim with supporting documents. Benefits will be paid once a year, at a date designated by the Board of Trustees. The supplemental accounts may be forfeited under certain circumstances, as described in the Plan's formal rules.

Employers have contributed to the Plan an additional contribution to fund participant supplemental accounts to be utilized by participants which are included in overall employer contributions. As of June 30, 2024 and 2023, participants' supplemental accounts totaled \$1,432,483 and \$1,501,981, respectively. These amounts are included in the Plan's assets in the accompanying financial statements as of June 30, 2024 and 2023.

12. OTHER POST-RETIREMENT BENEFIT

Defined Contribution Pension Plans and Other Pension Plans - The Plan's employees are covered by one multiemployer defined contribution pension plan. Employer contributions to the defined contribution plan for the years ended June 30, 2024 and 2023, totaled \$52,813 and \$41,725, respectively.

Multiemployer Post-Retirement Plans Other than Pensions - The Plan contributes to the Plumbers and Steamfitters Managed Health Care Plan, which provides medical, dental, prescription drug and other benefits to retirees formerly employed by the Plan. Contributions to the plan for the years ended June 30, 2024 and 2023, totaled \$4,435 and \$3,663, respectively.

13. SUBSEQUENT EVENTS
