## INDEPENDENT AUDITOR'S REPORT

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. We are required to be independent of Youth Opportunity Center, Inc. 403(b) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our *ERISA Section 103(a)(3)(C)* audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an *ERISA Section 103(a)(3)(C)* audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental schedules of assets held at end-of-year and delinquent participant contributions as of June 30, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplemental information required by the *Department of Labor's Rules and Regulations for Reporting and Disclosure* under *ERISA*. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the *Department of Labor's Rules and Regulations for Reporting and Disclosure* under *ERISA*.

## NOTES TO FINANCIAL STATEMENTS

**1. DESCRIPTION OF PLAN**

The following description of Youth Opportunity Center, Inc. 403b Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General* – The Plan is a defined contribution plan covering all employees of Youth Opportunity Center, Inc. (the Company), who have met eligibility requirements. The Plan became effective on July 1, 1993, and was restated effective July 1, 2020. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974 (ERISA)*.

*Eligibility* – Employees become eligible to make elective deferrals on their date of hire. Employees become eligible for employer matching after completing one year of service and attaining the age of twenty-one.

*Voluntary and Matching Contributions* – Participants may make voluntary contributions up to the IRS limits as defined in the Plan. Eligible employees are automatically enrolled at a 2% deferral rate unless an election is made to not participate. Participants direct the investment of their contributions, as well as all Company contributions, into various investment options offered by the Plan.

The Company matches 100% of the participant's elective deferrals up to 3% of compensation.

*Participant Accounts* – Each participant's account is credited with the participant's contribution, allocations of the Company's matching contribution, and Plan gains or losses. Allocations are based on participant contributions, earnings, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting* – Participants are fully vested in their contributions and actual earnings thereon. However, vesting in Company matching contributions is based on years of service. Prior to normal retirement age, a participant's interest in these contributions becomes 100% after five years of service.

*Participant Loans* – The Plan does not permit participant loans.

*Forfeitures* – Forfeitures, consisting of the portion of employer contributions not vested as of a participant's date of termination, are used to reduce employer contributions, or pay Plan expenses. There were unallocated forfeitures of \$50,224 as of June 30, 2024, and \$44,668 as of June 30, 2023. During the Plan years ended June 30, 2024 and 2023, no forfeitures were used to reduce employer contributions and pay Plan expenses.

*Benefit Distributions* – Benefits generally are distributed upon the participant's termination, normal retirement, disability retirement, or death. Benefits are payable either in a lump sum in an amount equal to the sum of the participant's individual vested account or in installments equal to the sum of the participant's account. In-service distributions are permitted after a participant has attained age 59½. Hardship distributions are permitted subject to the provisions of the Plan document.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting* – The financial statements of the Plan are prepared using the accrual method of accounting.

*Estimates* – The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan’s administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits* – Benefits are recorded when paid.

*Subsequent Events* – The Plan’s administrator has evaluated subsequent events through the date on which the financial statements were made available to be issued. The date is the same as the independent auditor’s report date.

#### 3. PLAN TERMINATION

While the Company has not expressed any intent to terminate the Plan, it may do so at any time, subject to the provisions set forth in *ERISA*. In the event of Plan termination, participants would become fully vested in their employer contributions as of the termination date and payment of benefits would be made as provided in the Plan agreement.

#### 4. INCOME TAX STATUS

Individually designed 403(b) plans currently are not required to submit plans to the Internal Revenue Service for determination. However, the plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the *Internal Revenue Code*.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

#### 6. ADMINISTRATION EXPENSES

The expense of administering the Plan shall be paid either by the Company or by the Plan. For the years ended June 30, 2024 and 2023, the Plan incurred administrative fees of \$68,819 and \$74,269, respectively. The Company also incurred expenses related to the administration of the Plan. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

#### 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### 8. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or 2 inputs were not available. There were no Plan assets requiring the use of Level 2 or 3 inputs for the periods presented.
