Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the 2024 Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Krystal Biotech, Inc. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Description of Plan

The following description of Krystal Biotech, Inc. Medical Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General: Effective July 1, 2021, the Plan provides health benefits covering substantially all employees of Krystal Biotech, Inc. (the Company or Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's fiscal year runs from July 1 to June 30 each year.

The Plan provides medical benefits to all full-time employees of the Company working at least 30 hours per week, along with their eligible dependents, as defined in the Plan document. Eligible employees must enroll for coverage within 30 days of initial eligibility or they will not be permitted to enroll until an annual enrollment period is held, or a qualifying life event occurs, as defined in the Plan document. The Plan fully insures the medical benefits and prescription costs. The Company purchases annual insurance contracts for these insured benefits. Premiums for these insured benefits are paid to the insurance company from the general assets of the Company.

Self-Insured Benefits: All medical benefits are self-insured by the Company. The claims are processed by the Plan's third-party administrators under administrative services only (ASO) arrangements. The third-party administrators pay claims directly to or on behalf of participants. The payments for claims are paid by the Plan's trust which is funded by the general assets of the Company. Despite the Plan's utilization of third-party administrators for claims processing, the ultimate responsibility for payments to providers and participants is retained by the Plan.

Stop-Loss Coverage: The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount) as well as its aggregate exposure for all medical claims. The stop-loss coverage amount is \$45,000 per person with an aggregate limit of \$1,000,000 through June 30, 2024. The total stop-loss recoveries in 2024 was \$520,938 which is netted against payments for claims, net on the statement of changes in net assets available for benefits.

Contributions: Participants are required to make pre-tax contributions to the Plan to fund a portion of the cost of their medical benefits. Amounts required to be contributed by participants are determined annually in accordance with the Plan document. The remainder of the funding required to pay benefits under the Plan is paid by the Company, including any deficit in net assets of the Plan.

COBRA Insurance – The Plan allows for coverage for a specified time period under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA). If a participant's medical coverage terminates because of a life event known as a "qualifying event," then the participant and eligible family members may have the right to purchase continued coverage for a temporary period of time. Each qualifying individual pays their premium directly to the third-party administrator. COBRA claims and other related expenses are paid by the third-party administrator. COBRA deposits were \$1,574 in 2024.

Termination of the Plan: Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the Company must pay the claims incurred and expenses of the Plan due up to the date of termination plus extended benefits, if any, provided under the Plan. Also, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than that for the exclusive benefit to the Plan's participants.

Note 2 - Significant Accounting Policies

Basis of Accounting: The financial statements are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investment is stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements are discussed in Note 3. Purchases and sales are recorded on the trade-date basis. Interest income is recorded on the accrual basis

Payment of Benefits: Claim payments are recorded when paid by the third-party administrator.

Benefit Obligations: Plan benefit obligations at June 30, 2024 for claims incurred by active participants but not reported are calculated by an actuary retained by the Plan's management using historical claim information.

Risks and Uncertainties: At times, the Plan's cash balance may exceed amounts insured by the Federal Deposit Insurance Corporation. The Plan does not believe it is exposed to any significant credit risk as a result.

Administrative Expenses: Substantially all administrative expenses of the Plan, including but not limited to costs related to claims processing, are paid from plan assets. Certain other administrative expenses of the Plan, including legal, accounting, and certain recordkeeping services, are paid by the Company.

Income Taxes: FASB ASC 740, Income Taxes, requires Plan management to evaluate tax positions taken by the Plan and disclose a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent Events: Subsequent events have been evaluated through April 11, 2025, which represents the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements

FASB ASC Topic 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

Note 3 - Fair Value Measurements (Continued)

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset and liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's investments as of June 30, 2024 and 2023 consisted of interest-bearing cash, which are held in a bank administered by the trust fund. The fair market value is equal to cost and, as such, no appreciation or depreciation of value is recognized.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurements at the reporting date.

Note 3 – Transactions with Parties-In-Interest (Continued)

As discussed in Note 1, the Plan has arrangements with service providers and, therefore, these transactions qualify as party-in-interest transactions. Transactions resulting in plan assets being transferred to or used by a related party are prohibited under ERISA unless a specific exemption exists. These transactions are party-in-interest transactions under ERISA. However, these transactions are exempt under Section 408(b)(8) and are not prohibited by ERISA. As discussed in Note 2, expenses of administering the Plan are paid from plan assets or by the Company pursuant to provisions of the plan document.

Note 4 – Plan Tax Status

The Plan is funded through a non-qualified trust under Internal Revenue Code (IRC) 419(a). The trust files Form 1041 U.S. Income Tax Return for Estates and Trusts. Plan management believes that the Plan is being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 - Benefit Obligations

FASB ASC Topic 965, *Health and Welfare Benefit Plans*, requires disclosure of the following plan obligations at June 30, 2024 and 2023. Claims incurred but not reported to the Plan for active participants was approximately \$230,723 at June 30, 2024 and \$154,873 at June 30, 2023. The claims incurred but not reported to the Plan is an estimate that is calculated by the Plan’s actuary. The estimate is based on the group specific monthly paid claim averages, with adjustments for claim outliers. The Plan does not offer postemployment benefits.
