Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

1. DESCRIPTION OF PLAN:

The following description of the Center for Human Services, Inc. Employee Pension Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan invested primarily in mutual funds and a group annuity contract under Internal Revenue Service (IRS) Code Section 403(b)(7) and is subject to the Employees Retirement Income Security Act of 1974 (ERISA). The Plan sponsor is the Center for Human Services, Inc. (the Organization). All employees are immediately eligible to participate in the Plan through elective deferrals. The Finance Committee is responsible for oversight of the Plan, determines the Plan's investment offerings, and monitors investment performance with the assistance of an investment advisory firm.

In September 2023, the Plan acquired all assets of the Chariton Valley Association Retirement Plan. Total assets transferred in were \$654,712. As a result of the merger, all employees previously eligible at Chariton Valley Association were eligible to be a part of the Plan.

CONTRIBUTIONS

Each year, participants may contribute up to a maximum of 100 percent of their annual compensation, as defined in the Plan and subject to the annual limits of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year or have at least 15 years of service with the Organization are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Deferral elections, which can be either pre-tax or after-tax Roth, may be modified two times a year, which becomes effective on July 1st and January 1st. However, a deferral election may be revoked at any time.

The Organization may, at its discretion, make matching contributions to eligible participants' accounts. The matching contributions are applied based on the participants' elective deferrals, up to a maximum of 4% of compensation. In addition, the Organization may elect to make non-elective contributions to the Plan, which is unrelated to a participant's elective deferrals in that year. Non-elective contributions are allocated by groups based upon years of service. To be eligible for matching and non-elective contributions the employee must have completed 1,000 hours of service during the Plan year.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's contribution and (b) Plan earnings and charged with an allocation of Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN, continued:

VESTING

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Organization's contribution to their accounts and earnings thereon is based on years of continuous service. A participant is 20% vested after 1 year, 40% after 2 years, 60% after 3 years, 80% after 4 years and 100% vested after 5 years of continuous service. Participants are considered to have one year of service for vesting purposes if, during a Plan year, the participant is credited with 1,000 hours of service.

PARTICIPANT LOANS

Participants may borrow from their accounts a minimum of \$1,000 up to fifty percent (50%) of their non-forfeitable account balance. The loans are secured by the balance of the participant's account and bear interest at a rate determined to be reasonable by the Plan administrator after a review of interest rates charged for similar types of loans by other lenders. Principal and interest are paid ratably through payroll deductions or ACH repayment agreement. A participant may have no more than one loan outstanding at any point in time. Loans may not be refinanced.

PAYMENT OF BENEFITS

Upon termination of employment for any reason and at any age, including retirement, a participant with a vested account balance of \$1,000 or less will receive a lump-sum distribution of cash. Terminated participants with a vested account balance of between \$1,001 and \$5,000 will receive a lump-sum distribution of cash, if an election has been made to do so. Distributions will be made as soon as administratively possible. For a terminated participant whose vested account balance exceeds \$5,000, the participant may elect to receive a lump-sum amount equal to the value of his/her account or roll over the distribution into another qualified retirement plan or individual retirement account.

FORFEITURES

Forfeitures of terminated participants' non-vested accounts are used for reducing employer contributions or paying administrative expenses. As of June 30, 2024 and 2023, the forfeited non-vested account totaled \$53,691 and \$88,994, respectively. Forfeitures of \$49,544 were used to reduce employer contributions during the plan year ended June 30, 2024.

2. SIGNIFICANT ACCOUNTING POLICIES:

BASIS OF ACCOUNTING

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted (“GAAP”) in the United States of America.

ESTIMATES

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurement and Note 5 for a discussion of fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants represent participant loans and are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when received. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when paid. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. The notes are secured by the balance in the participant's account and bear interest at rates of 5.25%-9.50%. The outstanding notes receivable balances totaled \$170,342 and \$113,159, as of June 30, 2024 and 2023, respectively. No allowance for credit losses has been recorded as of June 30, 2024 and 2023.

ACCRUED EXPENSES

Accrued expenses represent administrative expenses incurred by the Plan but not yet paid. These were paid from the forfeitures account subsequent to June 30, 2024.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

2. SIGNIFICANT ACCOUNTING POLICIES, continued:

ADMINISTRATIVE EXPENSES

Certain expenses of maintaining the Plan, such as accounting and audit fees, fidelity bond and fiduciary liability insurance premiums, are paid by the Organization and are excluded from these financial statements. Fees related to the administration of benefits paid to participants that are charged directly to the participant's account are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments. Expenses paid by the Plan as of fiscal year ended June 30, 2024 were \$16,341.

3. INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTION:

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, VOYA Institutional Trust Company has certified the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, and the supplemental Schedule H, Line 4i-Schedule of Assets (Held at End of Year), as of June 30, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended June 30, 2024.

4. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology included quoted market prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted process that are observable for the assets or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

4. FAIR VALUE MEASUREMENTS, continued:

The asset fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the fair value hierarchy used for assets measured at fair value. There have been no changes in methodology used at the fiscal years ended June 30, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are considered to be actively traded.

5. VOYA GROUP ANNUITY CONTRACT:

The Plan has a fully benefit-responsive group annuity contract with VOYA. VOYA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and the specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measure attribute for the portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value.

Contract value, as reported to the Plan by VOYA, represents contributions made under the contract, plus earnings, less withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at the year ended June 30, 2024 and 2023 was \$543,914 and \$359,554, respectively. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1.00%. The 2024 crediting interest was 1.00%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured breach of the Plan's investment guidelines, (2) a material amendment to the contract without the issuer's consent, (3) a violation of a material obligation under the contract, or (4) a material misrepresentation. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contracts do not permit the insurance company to terminate the agreements prior to the scheduled maturity date.

6. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent (100%) vested in their account balances and the Plan administrator would facilitate the distribution of account balances in lump sum payments.

7. TAX STATUS:

The Plan has adopted a volume submitter plan document sponsored by Nyhart. The volume submitter plan document has obtained an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017, which states that the volume submitter document satisfies the applicable provisions of the Internal Revenue Code. The Plan has not received a determination letter from the IRS; however the Plan administrator and the Plan's counsel believe that the Plan is designed in compliance with the applicable requirements of the Internal Revenue Code.

8. PARTIES-IN-INTEREST:

VOYA Institutional Trust Company (VOYA) is the contract administrator and recordkeeper of the Plan and VOYA Financial, Inc. provides trustee and custodial services. Plan investment transactions in the VOYA family of mutual funds qualify as party-in-interest transactions. Fees paid to VOYA for the year ended June 30, 2024, amounted to \$16,341.

9. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. SUBSEQUENT EVENTS:

Subsequent events were evaluated through April 15, 2025, which is the date the financial statements were available to be issued. Subsequent events after that date have not been evaluated.
