Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Hart United, Inc. Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Hart United, Inc. Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Supplemental Schedule Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(1) Description of the Plan

The following description of the Hart United, Inc. Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Adoption Agreement for a more complete description of the Plan's provisions.

(a) *General*

The Plan is a defined contribution 401(a) plan established by Hart United, Inc. (the “Organization” or the “Employer”) as of June 19, 1991. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) *Eligibility*

Employees of the Organization are eligible to participate in the Plan on the first day of the calendar month following eligibility requirements. All full-time employees of the Organization are eligible with the exception of leased employees and residents of Puerto Rico.

(c) *Employee Contributions*

Employees that have attained age 21 and completed 60 days of service are eligible to contribute to the Plan through voluntary payroll deductions, up to 100% of pre-tax annual eligible compensation not to exceed Internal Revenue Service established limits. Employees may also make after-tax Roth contributions. Employees attaining 50 years of age or older before the end of the year are allowed to make catch-up contributions not to exceed Internal Revenue Code (IRC) established limits.

Rollover contributions to the Plan are also permitted.

(d) *Employer Contributions*

The Employer may, in its sole discretion, make a profit sharing contribution to the Plan on behalf of eligible employees that have attained age 21 and completed 1 year of service, provided they have completed at least 1,000 hours of service during the Plan year. Such contributions will be allocated to the participant's account in the ratio that each participant's eligible compensation bears to the Plan compensation of all eligible participants. The Plan was amended effective July 1, 2023 to change the eligibility requirement from 2 years of service to 1 year of service and to change the eligibility computation period to Plan year. The Employer profit sharing contributions were \$45,000 and \$166,186 for 2024 and 2023, respectively.

The Plan allows employer matching contributions and safe harbor contributions for employees that have attained age 21 and have completed 1 year of service. The Employer will make safe harbor contributions to the Plan in the amount of 3% of eligible compensation. The safe harbor employer contributions were \$159,144 and \$144,413 for 2024 and 2023, respectively.

(e) Participant Accounts

Each participant's account is credited with the participant's allocation of (a) the participant's contribution; (b) the Employer's contributions; and (c) Plan earnings. Allocations are based on participant's eligible compensation relative to total eligible compensation, deferred contribution amount or account balances as defined by the Plan.

The benefit to which a participant is entitled is that which can be provided from the vested balance in the participant's account. Participants direct all contributions invested in investment options offered by the Plan.

(f) Vesting

Participants are immediately vested in all contributions.

(g) Payment of Benefits

Upon termination due to death, disability or retirement, a participant may elect to receive either a lump-sum distribution or various annuity options. The benefits paid are the vested balance of the participant's account. The Plan allows participants to receive benefits in cases of hardships.

If the vested amount of an account payable to a participant or beneficiary does not exceed \$5,000 at the time such individual becomes entitled to a distribution, such vested account shall be paid in a lump sum.

If the value of a participant's vested account balance exceeds \$5,000 and the account balance is immediately distributable, the participant must consent to any distribution of such account balance.

(h) Notes Receivable

Participant loans are not permitted by the Plan except for cases of financial hardship which are evaluated on a case by case basis by the Employer.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Summary of Significant Accounting Policies (continued)

(b) Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

(c) Risks and Uncertainties

The Plan invests in securities, which in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

(d) Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Quoted market prices are used to value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold, as well as held during the year.

(e) Payment of Benefits

Benefits are recorded when paid.

(f) Administrative Expenses

In general, all Plan expenses are paid for by the Organization.

(g) Subsequent Events

The Plan has evaluated subsequent events through March 26, 2025, which is the date that the financial statements were available to be issued.

(3) Information Prepared and Certified by the Trustee

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the trustee of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for plan benefits as of June 30, 2024 and 2023, the schedule of assets held for investment purposes as of June 30, 2024 and the related investment activity reflected in the statements of changes in net assets available for plan benefits for the years ended June 30, 2024 and 2023.

(4) Fair Value Measurements

Generally accepted accounting principles in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual funds: Valued at quoted market prices at year-end.

Fixed annuities: Valued at contract cost, which equals accumulated cash contributions and interest credited to the contracts less any withdrawals.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Related Party Transactions

The Plan uses a number of service providers. Such providers are considered parties-in-interest under ERISA.

(6) Plan Amendment and Termination

Although it has not expressed any intention to do so, the Organization has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. Additionally, the Organization may amend the Plan at any time without the consent of any participant or beneficiary, provided that no amendment deprives any participant of the participant non-forfeitable accrued benefit.

(7) Withdrawing Participants

All participants who have withdrawn from the Plan and requested their benefits have been paid as of June 30, 2024.

(8) Tax Status

The Plan is based on a prototype plan and is relying on the prototype sponsor's opinion letter from the Internal Revenue Service dated September 30, 2014. This letter states that the prototype and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.



