Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Uncommon Schools, Inc. 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1. DESCRIPTION OF PLAN

The following description of Uncommon Schools, Inc. 403(b) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a 403(b) defined contribution plan covering substantially all eligible employees of Uncommon Schools, Inc. (the Plan Sponsor) and New York State affiliated school employers (collectively, the School). The Plan was established July 1, 2009. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Investment Committee and Plan Administrator determine the appropriateness of the Plan's investment offerings, monitor investment performance, and report to the School's Board of Directors.

b. Eligibility

Employees are eligible to participate in the Plan and receive the Plan Sponsor's discretionary matching contributions immediately upon their hire date and attaining the age of twenty-one. The Plan excludes those employees who normally work less than 20 hours per week, residents of Puerto Rico and hourly employees. Effective January 1, 2025, long-term part-time employees who worked 500 hours of service in the previous two consecutive years are eligible to participate in the Plan.

c. Contributions

Each year, eligible participants may contribute a percentage up to 100% of pre-tax annual compensation, subject to annual Internal Revenue Service (IRS) limitations as defined by the Plan. Participants may also elect to contribute a percentage of their eligible compensation into the Plan on a post-tax basis (Roth contributions). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions).

The discretionary matching contribution is a dollar-for-dollar match up to \$3,500 for all eligible participants, except for Rochester employees. For the Rochester schools, the Plan Sponsor match is based on months of service. For participants hired for 23 months or less, the match will be dollar-for-dollar up to a maximum of \$3,500. For participants hired for twenty-four to forty-seven months, the match will be dollar-for-dollar up to a maximum of \$4,000. For participants hired more than forty-eight months, the match will be dollar-for-dollar up to a maximum of up to \$5,000.

During plan year 2024, the Plan Sponsor made discretionary matching contributions of \$2,666,519. Additional profit-sharing amounts may be contributed at the option of the Plan Sponsor's Board of Directors, however there were no profit-sharing contributions made in 2024.

Effective January 1, 2024, the Plan was amended for an automatic enrollment provision at 3% of eligible compensation with auto-escalation of 1% each year up to a maximum of 10%. This amendment is only applicable to Rochester employees.

d. Participant Accounts

Each participant's account is credited with the participant's contributions and Plan Sponsor's discretionary matching contributions, plus an allocation of the Plan Sponsor's discretionary matching contribution and Plan earnings, and is charged with administrative expenses, as required. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

e. Notes Receivable from Participants

Participants may, at their option, borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. The loans are secured by the balance in the participant's account. Participants may have one loan outstanding at any time. Loan terms range from one to five years, unless for the purchase of a primary residence, which is no longer than thirty years. The interest rate is set at the prime rate plus 2% at the time of the loan. Principal and interest are paid ratably through payroll deductions.

f. Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions and actual earnings thereon. Participants become fully vested upon death or disability. A participant is fully vested in the Plan Sponsor's contributions and earnings thereon after one and one-half years of credited service. A year of service is defined as attaining at least 1,000 hours of service during the plan year. Effective October 3, 2022, the vesting of Plan Sponsor contributions changed to one year of service.

g. Payment of Benefits

The Plan provides for a normal retirement benefit to be paid to participants who have reached the age of 65, with no option for early retirement. Upon termination of service, a participant receives a lump-sum amount equal to the value of his or her account or as annual or more frequent installments over a period that does not extend beyond the life expectancy of the participant. There are also retirement benefits available upon late retirement, disability and death. Beneficiaries are entitled to receive benefit payments on behalf of the participant upon the death of the participant. The Plan requires balances up to \$5,000 be paid out to participants upon termination. Effective January 1, 2024, the involuntary force-out distribution amount was increased from \$5,000 to \$7,000 per the SECURE 2.0 Act.

The Plan allows in-service withdrawals upon attainment of age 59 ½. A participant may also request a withdrawal upon demonstration to the Plan Administrator that they are suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to Section 403(b) of the Internal Revenue Code (the Code) or standards established by the Secretary of the Treasury or their delegate.

h. Forfeitures

Forfeitures represent non-vested Plan Sponsor contributions forfeited by participants who terminate their employment or who withdraw from the Plan. Forfeited non-vested amounts may be used to reduce future Plan Sponsor contributions. The Plan had \$321,368 and \$141,736 of unallocated forfeitures as of June 30, 2024 and 2023, respectively. There were \$43,729 of forfeitures used to reduce Plan Sponsor contributions and pay for plan expenses during the plan year ended June 30, 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive group annuity investment contracts which are reported at contract value (see Note 9). Mutual funds are stated at quoted market prices on public exchanges, which represent the net asset value (NAV) of shares held by the Plan at year-end. Non-benefit-responsive investment contracts are reported at fair value.

Units held by the Plan in the pooled separate account and variable annuities are based on each fund's daily NAV as a practical expedient, which is considered by the Plan's management to be the best approximation of fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisor and qualified institutions (see Note 4).

Investment contracts held by a defined contribution plan are required to be reported at fair value except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowances for credit losses have been recorded as of June 30, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. For the year ended June 30, 2024, there were \$66,376 of defaulted loans included in benefits paid to participants in the accompanying statement of changes in net assets available for benefits.

Contributions

Contributions from plan participants and the Plan Sponsor discretionary matching contributions are recorded in the year in which the contributions are withheld from compensation. The discretionary profit-sharing contributions are recorded when such contributions are authorized by the School's Board of Directors.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to Plan recordkeeping, investment advisory services, the administration of notes receivable from participants, and processing of distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of investments.

Subsequent Events

Subsequent events have been evaluated through April 10, 2025, which is the date the financial statements were available to be issued. Excepted as disclosed in note 1b, there were no events that met the criteria for recognition or disclosure in the financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTIONS

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF)(collectively, TIAA and CREF) and Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC, (collectively, Empower Retirement), the qualified institutions, have certified to the completeness and accuracy of all investments and notes receivable from participants reported in accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of June 30, 2024, and the related investment transactions and investment income and interest income on notes receivable from participants reported in the accompanying statement of changes in net assets available for benefits for the year ended June 30, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of June 30, 2024.

4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs).

The fair value hierarchy is as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are measured using Level 1 inputs.

Variable annuities: The fair value of accumulation units held by the Plan in variable annuity accounts are based on each account's daily NAV as a practical expedient, which is considered by the Plan Sponsor to be the best approximation of fair value. The NAV is used as a practical expedient to estimate the fair value, unless it is probable that all or a portion of the variable annuities will be sold for an amount different from NAV. As of June 30, 2024 and 2023, the Plan had no plans to sell the variable annuities at amounts different from NAV. Variable annuities are not actively traded. Data for NAVs is available daily to Plan Administrators and client investors via the TIAA and CREF website, and provides sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of individual underlying holdings. Underlying holdings are primarily valued using market quotations or prices obtained from independent pricing sources. Redemption frequency and notice period are available on a daily basis. There are no unfunded commitments from participants in the Plan who invest in these accounts.

TIAA traditional annuity contract - non-benefit-responsive: Investments in the TIAA traditional annuity contract that are non-benefit-responsive investment contracts are reported at fair value. As these investments are contract-based, observable prices for identical or similar investments do not exist and, accordingly, these investments are valued using unobservable inputs (Level 3). The fair value equals the accumulated cash contributions and interest credited to the contract, less any withdrawals.

Pooled separate account: The fair value of the Plan's interest in the TIAA Real Estate Account (a pooled separate account) is based on the fund's daily NAV per share as a practical expedient, which is considered by Plan management to be the best approximation of fair value. The NAV is used as a practical expedient to estimate the fair value, unless it is probable that all or a portion of the pooled separate accounts will be sold for an amount different from NAV. As of June 30, 2024 and 2023, the Plan had no plans to sell the pooled separate accounts different from NAV. The unit value of the fund is calculated daily and is available to Plan Administrators and client investors on TIAA and CREF's website. Underlying holdings are primarily valued using independent appraisals or independent pricing sources. Although the underlying assets of the fund cannot be quickly sold and converted to liquid assets, the TIAA general account provides the fund with a liquidity guarantee whereby TIAA ensures that the fund has funds available to meet participant redemption, transfer or cash withdrawal requests. The redemption notice period is available on a daily basis whereas redemption frequency is on a quarterly basis. There are no unfunded commitments from participants in the Plan who invest in this account.

There have been no changes in the methodologies used at June 30, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (a) These funds invest in a combination of equity securities and debt securities to achieve a long-term rate of return and capital appreciation.
- (b) This fund invests in high quality, short-term instruments to achieve high current income and capital preservation.
- (c) This fund invests in various types of domestic stocks in the large, mid-sized or smaller capitalization groups to seek long-term capital growth.
- (d) This fund invests in foreign equities and in fixed income securities to achieve a long-term rate of return.
- (e) These funds invest in various types of debt securities to achieve a long-term rate of return while preserving capital.
- (f) This fund invests in real estate properties, other real estate-related investments, and securities. Underlying real estate holdings are valued principally using external appraisals. Underlying securities are generally priced using values obtained from independent pricing sources. Redemptions are permitted daily, except participant transfers out of the fund are limited to one per calendar quarter.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested and all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

6. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated March 31, 2017, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the Code. The Plan Administrator timely adopted the restated prototype plan. The Plan Administrator believes that the Plan is currently being operated in accordance with the Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions' however, there are currently no audits for any tax periods in progress.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, notes receivable from participants and transactions with investment funds managed and held by qualified institutions are considered party-in-interest transactions.

The Plan also allows for a revenue sharing credit, which is used to offset certain amounts owed to the qualified institution for its administrative services to the Plan. During plan year 2024, the Plan paid the qualified institution for administration of contracts, participant loans, processing of distributions, advisory and recordkeeping services of \$204,445, which is presented net of \$42,696 of the revenue sharing credit in the accompanying statement of changes in net assets available for benefits. There were no revenue sharing credits available as of June 30, 2024 and 2023.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that these changes could materially affect the amounts reported in the statements of net assets available for benefits.

9. GROUP ANNUITY INVESTMENT CONTRACT HELD WITH EMPOWER LIFE & ANNUITY INSURANCE COMPANY OF NEW YORK

The Plan has a contract with Empower Life & Annuity Insurance Company of New York (the insurance company) (Empower Annuity). Contributions are held in the Empower Annuity general account and are maintained in a group annuity account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is considered fully-benefit-responsive and reported at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. However, there are certain events that limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (1) premature termination of the contract by the Plan, (2) plant closings, (3) layoffs, (4) Plan termination, (5) bankruptcy and (6) early retirement incentives. The insurance company may not terminate the contract at any amount less than contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the insurance company. Such interest rates are reviewed on a quarterly basis for resetting.

Failure to segregate and remit contributions within the specified time period is a prohibited transaction. The School computed and funded the lost earnings on the 2022, 2021 and 2020 deferrals and loan repayments and submitted an application through the Voluntary Fiduciary Correction Program (VFCP) during March 2025.
