NOTE 1 – DESCRIPTION OF PLAN

The following is a brief description of the Community Services & Employment Training, Inc. Retirement Plan (the Plan) which was established by Community Services & Employment Training, Inc. (the Organization), to provide retirement benefits to eligible company employees. The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan became effective January 1, 1988. The Plan is a defined contribution plan covering all full-time employees of the Company, except leased employees, employees classified as trainees, members of a collective bargaining unit and nonresident aliens with no U.S. source income, who have one year of service and are age 18 or older. The Plan is subject to the provisions of ERISA. The Plan was restated for final Cycle 3 regulations effective July 1, 2021. Effective July 1, 2023, the Plan was amended to allow in-service distributions upon normal retirement date, discretionary employer matching contributions and expand employee classes excluded from participation to account for leased employees. The Plan's trustees are responsible for oversight of the Plan. The trustees determine the appropriateness of the Plan's investment offerings, monitor investment performance and report to the Organization's Board of Directors.

Contributions

Each year, participants may contribute up to 100% of pre-tax or after-tax annual compensation, as defined in the Plan. Deferral contributions are subject to an annual maximum as defined by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation. The Plan also has an auto escalation feature whereby participants that were automatically enrolled will have an annual 1% increase in deferrals up to a maximum deferral rate of 5%.

The Organization may elect to contribute an employer matching contribution or a discretionary non-elective contribution to the Plan each year. For each of the plan years ended June 30, 2024 and 2023, the Organization did not elect to make employer matching contributions. The discretionary non-elective contribution for the plan years ended June 30, 2024 and 2023, was 4% of eligible employees' compensation for 1 to 5 years of service, 5% of eligible employees' compensation for 6 to 7 years of service, 6% of eligible employees' compensation for 8 to 10 years of service and 7% of eligible employees' compensation for 11 or more years of service. During the years ended June 30, 2024 and 2023, the Organization made discretionary non-elective contributions of \$510,613 and \$446,777, respectively, to the Plan.

Contributions are subject to certain annual limitations. Participants direct the investments of their contributions and their account balances into various investment options offered by the Plan.

Participant accounts

Each participant's account is credited with the participant's contributions as well as allocations of the Organization's matching and non-elective contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Payment of benefits

Upon retirement, death, disability or termination of service due to other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account, or a partial distribution or installment distribution to satisfy the required minimum distribution rules. The participants may make a direct rollover of their taxable distributions to another employer's qualified retirement plan or individual retirement account. A participant may receive a distribution of salary deferral amounts in the event of certain financial hardships.

Forfeited accounts

At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$3 and \$612, respectively. These accounts may be used to reduce future employer contributions or reduce administrative expenses of the Plan. For the years ended June 30, 2024 and 2023, employer contributions were reduced \$18,333 and \$54,107, respectively, by forfeited nonvested accounts.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding increase to distribution. The Plan distributed the 2024 excess contributions to the applicable participants subsequent to September 15, 2024. The Plan distributed the 2023 excess contributions to the applicable participants subsequent to September 15, 2023.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Investment related expenses are included in the net appreciation of fair value of investments.

Reclassifications

Certain amounts in the prior year financial statements have been reclassified in order to be comparable with the current year presentation.

Subsequent events

Plan management has evaluated subsequent events through April 10, 2025, the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 - FULLY BENEFIT RESPONSIVE INSURANCE CONTRACT

The Plan holds an insurance contract that meets the fully benefit-responsive insurance contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive insurance contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Contract value was \$72,803 and \$47,534 at June 30, 2024 and 2023, respectively.

The insurance contract held by the Plan is a guaranteed insurance contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed by the Plan. The crediting rate is based on a formula established by the contract issuer. The average interest crediting rate for the years ended June 30, 2024 and 2023, was 1.33% and 1.10%, respectively. The crediting interest rate may change or stay the same each quarter and applies to all money deposited in the group contract holder's account regardless of when it was deposited.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include termination of contracts, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and liberalization of plan withdrawal or transfer rules.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 - RELATED-PARTY TRANSACTIONS

The Plan's assets were managed by Empower. Plan management includes recordkeeping and investment services related to contributions received, plan earnings and distributions. The services to the Plan qualify as party-in-interest transactions. Fees associated with each managed fund are built into the expense ratio for that fund. Investment management and advisory fees paid by Empower related to the Plan totaled \$43,278 and \$38,338 for the years ended June 30, 2024 and 2023, respectively. LPL Financial provides investment advisory services. These services to the Plan qualify as party-in-interest transactions. Third party administrative services and recordkeeping fees are paid for by the Plan. Third party administrative compensation and recordkeeping fees paid by Empower was \$29,308 and \$26,623 for the years ended June 30, 2024 and 2023, respectively.

Administrative functions are jointly performed by the employees of the Organization and third party administrators. No employee receives compensation from the Plan. The independent auditor's fees are paid directly by the Organization.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

NOTE 8 - TAX STATUS

The IRS has determined and informed the Organization by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

NOTE 8 – TAX STATUS (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 – ALLOCATION OF ASSETS

Net assets available in the amount of \$1,963,608 and \$1,392,693 have been allocated to the accounts of terminated employees at June 30, 2024 and 2023, respectively. Non-vested amounts to be forfeited in future years total \$100,431 and \$131,850 of net assets available for benefits at June 30, 2024 and 2023, respectively.

NOTE 10 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
