**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees (as defined below) of Lake Forest Graduate School of Management ("the School"). As such, all contributions made to the Plan are allocated to individual participant accounts and invested in funds offered by the Plan as directed by the respective plan participant. Once a participant satisfies the requirements to receive a distribution from the Plan, the vested balance in the participant's account is available to be distributed to them in a form and manner as prescribed by the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions: All employees are immediately eligible to make voluntary salary deferrals to the Plan on their first day of employment. Employees who have attained age 21 and have completed one year and 1,000 hours of service besides non-resident aliens, employees who work less than 20 hours a week, collective bargaining employees, faculty, and temporary employees are eligible for the School's contribution. The employer match contribution rate was 3%, subject to the maximum compensation limit for each participating employee, as defined in the Plan. The School did not make any non-elective Employer Contributions for the year ended June 30, 2024.

Rollover Contributions: A participant may contribute amounts distributed or transferred from another qualified plan, as defined in the Plan.

Investments: The assets of the Plan are held by Teachers Insurance and Annuity Association of America ("TIAA") and College Retirement Equities Fund ("CREF," collectively, "TIAA and CREF") and Charles Schwab Trust Bank. Participants direct the investment of the contributions into various investment options offered by the Plan. The Plan currently offers fixed and variable annuity accounts as investment options for participants.

Vesting: A participant is at all times 100% vested in employee contributions, including catch up and rollovers. A participant becomes 100% vested in the School's Contributions after completing three years of vesting service.

Participant Accounts: Individual account balances are maintained for each participant. Each participant's account is credited with the participant's contribution, rollover and the School's Contributions and net Plan earnings and losses. Participant accounts are also charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balance, whichever is less. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing as determined by the Plan administrator. Principal and interest are paid through payroll deductions.

Benefits: Payments of benefits are made to participants or their beneficiaries upon death, retirement, disability, or termination of employment. Benefits are payable in a qualified joint and survivor annuity, annuities allowed under the funding vehicle contracts, installments, and lump-sum payments. Benefits owed to terminated participants are included in net assets available for benefits. Hardship and other in-service withdrawals are permitted if certain criteria are met.

Forfeitures: Participant forfeitures of the School's Contributions are used to offset future School's Contributions. No forfeitures were used to reduce the School's Contributions during the plan year ended June 30, 2024.

Administrative and Investment Management Expenses: Certain plan recordkeeping and custodian fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan are paid by the School.

Subsequent Events: Effective July 1, 2024 the employer match was decreased from 3% to 1%. Plan management has evaluated subsequent events for recognition and disclosure through April 15, 2025, which is the date the financial statements were available to be issued.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits: Benefits are recorded when paid.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks as well as the risks associated with global events. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 - RIGHTS UPON PLAN TERMINATION**

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 4 – CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF and Charles Schwab Trust Bank (the custodians of the Plan).

**NOTE 5 - FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

- Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

*Mutual Funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Variable Annuity Contracts:* The fair values of the Plan's investments held in variable annuity contracts are determined by obtaining quoted prices on the NASDAQ stock market (Level 1 inputs).

*Variable Annuity Separate Account:* The fair values of the variable annuity separate account TIAA Separate Account VA-3 and its various sub-account separate accounts are based on the net asset values reported by the separate account managers as of the financial statement dates and recent transaction prices. The investment objective of each of the sub-accounts of TIAA Separate Account VA-3 separate accounts is

generally reflected in the name of the sub-account. The separate account sub-accounts seek long-term total return, mainly through capital appreciation and investment income through investment in mutual funds that invest in domestic equities, international equities, and debt securities. Withdrawals or transfers from the sub-accounts may be made on a daily basis. Transfers from the sub-accounts to the TIAA Traditional Annuity, to the TIAA Real Estate Account, to another TIAA annuity or CREF Account must generally be at least \$1,000. Generally, variable annuity accounts have individual prospectuses which describe the underlying investments and the investment objectives of the contracts.

*Guaranteed investment contracts (not fully benefit-responsive):* The TIAA Traditional Annuity Contracts are individual guaranteed fixed annuity investment contracts issued by TIAA ("Issuer"). Due to certain liquidity restriction provisions, some of the individual annuity contracts within the TIAA Traditional Annuity contract held by the Plan are not fully benefit-responsive and, accordingly, are measured at fair value.

TIAA and Plan management have determined contract value to be the most reasonable estimate of fair value for these contracts. Contract value equals the contributions deposited into the contracts, plus interest credited to the contracts, less contract withdrawals, and it reflects the value at which participant transactions are executed under the contracts. The contract value reflects the theoretical transfer (exit) value available to the Plan and Plan participants.

The contract values are guaranteed by TIAA. Based upon recent credit ratings for TIAA, management believes no adjustment to contract value is required related to credit quality. Since investment contracts are not transferable, there is no market from which to obtain observable market prices for the contracts held by the Plan or comparable contracts (Level 3 inputs). During the year ended June 30, 2024, there were purchases and sales of \$92,213 and \$(119,504), respectively, of these level 3 investments held by the Plan.

The plan administrator is responsible for the review of the fair value estimates of plan assets. The plan administrator and management, or its designee, reviews the fair value pricing methodology employed by TIAA and CREF for the Plan's guaranteed investment contracts to ensure a reasonable measure of market valuation has been utilized. The valuation approach is reviewed on an ongoing basis to ensure market values reported represent a reasonable exit price.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative expenses of the Plan are paid to Charles Schwab Trust Bank and Howard Simon, the recordkeeper, which qualify as party-in-interest transactions. The Plan also holds variable annuity contracts and individual fixed annuity investment contracts issued by TIAA and CREF and a money market fund issued by Charles Schwab & Co, Inc. and managed by Charles Schwab Investment Management, Inc., both affiliates of Charles Schwab Trust Bank. These transactions as well as notes receivable from participants qualify as party-in-interest transactions. Additionally, while certain administrative functions are performed by officers or employees of the School, no such officer or employee receives compensation from the Plan.

**NOTE 7 - TIAA TRADITIONAL INDIVIDUAL FIXED ANNUITY ACCOUNTS**

The TIAA Traditional Annuity is a guaranteed fixed annuity contract available as an investment option to plan participants. Each contract is fully unconditionally guaranteed by TIAA. The TIAA Traditional Annuity is offered through a variety of contract types, including Retirement Annuities (RA), Supplemental Retirement Annuities (SRA), and Group Supplemental Retirement Annuities (GSRA). Participants with RA contracts have certain restrictions over the availability of lump sum withdrawals from the contracts as well as over the number of installments in which participant-initiated transfers and participant-initiated withdrawals are made. Based on these provisions, the RA contract is considered to be non benefit-responsive. As there are no comparable restrictions over the SRA and GSRA contracts, those contracts are considered benefit-responsive. Participants in the Plan hold investments in both non benefit-responsive and benefit-responsive contracts through the TIAA Traditional Annuity.

Participants who chose to allocate a portion of their retirement savings to the TIAA Traditional Annuity make contributions that purchase a specific amount of lifetime income based on the contractual rate of interest guaranteed by TIAA's claims paying ability. The TIAA Traditional Annuity also provides an opportunity for participants to receive additional amounts, which the TIAA Board of Trustees may declare on a year-by-year basis. These additional amounts, when declared, remain in effect for the 12 month "declaration year" that begins each March 1 for accumulating annuities and January 1 for lifetime payout annuities; they are not guaranteed for future years. Together the guaranteed minimum and additional amounts make up the crediting interest rate. The guaranteed interest rate for TIAA Traditional Annuity contracts, RA, SRA, and GSRA is 3.00%. For accumulating contracts, the interest crediting rate was 5.50-6.50% and 5.00-6.25% for RA contracts for the years ended June 30, 2024 and 2023, respectively. The crediting interest rate for SRA and GSRA contracts for the years ended June 30, 2024 and 2023 was 4.75-5.75% and 4.25-5.50%, respectively.

When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of change in net assets available for benefits.

There are no conditions specified in any of the contracts under which participant withdrawals and transfers would be restricted or made at a value other than contract value or the annuity or lump-sum benefit, as defined in the contracts. The contracts do not provide any provisions that would allow the Issuer to terminate the contracts between the Issuer and the participants.

**NOTE 8 - TAX STATUS**

The Internal Revenue Services issued an advisory letter dated March 31, 2017, indicating that the volume submitter plan adopted by the Plan Sponsor as then designed was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original volume submitter document Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 9 – TERMINATED PARTICIPANTS**

Included in net assets available for benefits are amounts allocated to individuals who have elected to withdraw from the Plan, but who have not yet been paid. Plan assets allocated to these participants were \$563,585 and \$0 at June 30, 2024 and 2023, respectively.
