INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
The Arc of Ouachita 403(b) Thrift Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the 403(b) Thrift Plan of The Arc of Ouachita (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1 – Description of Plan

The following description of the 403(b) Thrift Plan of The Arc of Ouachita (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of The Arc of Ouachita (the Arc). A participant must be at least age eighteen in order to receive employer matching contributions, and an employee must have six months of eligibility service to participate in the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year participants may contribute up to 100% of their compensation as defined in the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified retirement plans. Participants direct the investment of their contributions and any employer matching or retirement contributions into various investment options offered by the Plan. The Plan offers investments in investment contracts sponsored by the Plan's Custodian in its General Account and in a variety of mutual funds in its Separate Accounts. The Arc contributes the lesser of 100% of the salary reduction amount that the participant contributes to the Plan or 3% of his or her base compensation. Additional profit sharing amounts may be contributed at the option of the Arc's board of directors which may be invested in the above funds as directed by the participants. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Arc's contribution, and, (b) investment earnings (losses), and charged with an allocation of administrative and/or investment expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately fully vested in their contribution accounts plus the earnings thereon. Vesting in the Arc's portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Participant Loans

Participant loans are not permitted under the Plan.

Payment of Benefits

On termination of service due to reasons other than death or retirement, a participant may withdraw all or part of the participant's vested account in a single sum or leave all or a part of the vested account in the Plan and defer receipt of the benefit and the account will continue to accumulate interest or share in the investment experience of the funds in which the vested account is invested. The participant can elect to receive the vested account as income under an annuity or a Specified Payments Option if the participant is age 55 or older. If the vested account balance is \$1,000 or less, the participant will receive a single-sum payment at termination of employment.

If a participant dies before reaching retirement, the beneficiary can elect to receive the death benefit in a single sum or use the account to purchase a guaranteed lifetime annuity subject to applicable tax laws. If a participant dies after annuity payments have begun, a death benefit, if any, will be paid in accordance with the term of the annuity the participant chose at retirement.

A participant may elect to retire and receive benefits after reaching the age of 55 in the form of various annuities offered under the Plan or in the form of a lump sum payment.

In-Service Withdrawals

Subject to certain limitations, a participant may withdraw all or part of his or her vested amounts if the participant incurs a disability or if the employee has attained age 59½. Hardship withdrawals are also available under the Plan.

Forfeitures

Forfeitures will be reallocated to the accounts of participants employed on the last day of the plan year in the ratio the participant's compensation bears to the total compensation of all participants for the year. As of June 30, 2024 and 2023, forfeited non-vested accounts totaled \$39,407 and \$34,906 respectively.

Note 2 – Summary of Significant Accounting Policies

Date of Management's Review

Subsequent events were evaluated through April 15, 2025, which is the date the financial statements were available to be issued.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments in insurance company general accounts are reported at contract value. Investments in insurance company pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to settle a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further information regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

All expenses of maintaining the Plan other than administrative expenses paid to Mutual of America Life Insurance Company are paid by the Arc.

Note 3 – Plan Termination

Although it has not expressed any intent to do so, the Arc has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the balance of each participant's account would become 100% vested.

Note 4 – Fair Value Measurements

The Plan's investments in insurance company general accounts are reported at contract value. The Plan's investments in insurance company pooled separate accounts are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs are generally based on similar assets in active markets; and Level 3 inputs using unobservable inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The Plan has no investment assets measured using Level 2 or Level 3 inputs.

Level 1 Fair Value Measurements

The fair value of the pooled separate account is based on quoted prices in active markets of the underlying mutual fund shares held in that investment fund at year-end.

The investment at contract value is not included in the fair value hierarchy but is included to permit reconciliation of investments to the amounts shown in the financial statements.

Note 5 – Investment Contract with Insurance Company

The Plan has entered into a group annuity investment contract with Mutual of America. Mutual of America maintains the contributions in a General Account comprised of the Interest Accumulation Account and the Separate Account comprised of numerous fund-of-fund investments. Participants select the funds in which their accounts are invested. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Amounts placed in the Interest Accumulation Account are credited with interest at a rate determined by Mutual of America and is subject to change at Mutual's discretion but not below certain minimums as stated in the contract. The current rate of interest is 2.85%.

The value of the Interest Accumulation Account under the contract is equal to the total of all amounts allocated under the contract by participants plus all interest accrued thereon, minus the sum of any withdrawals, transfers and administrative charges. The value of any investment fund under the contract is equal to the number of accumulation units credited to the Investment Fund multiplied by the accumulation unit value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at June 30, 2024 and 2023 was \$140,151 and \$141,002 respectively.

The Arc may discontinue the contract by notice to Mutual of America and is effective 30 days after such notice is received. Mutual of America may discontinue this contract if: (1) the Arc fails to remit administrative charges within 31 days after payment is due, (2) the Arc fails to meet the requirements of the contract or to abide by its terms, (3) the Arc refuses to accept a modification of the contract that is necessary to comply Federal, State or ERISA requirements, (4) the class of group annuity contracts to which the contract belongs is discontinued, or (5) the Arc elects not to utilize appropriate electronic media to transmit and receive information and data with respect to the contract. The Plan administrator does not believe there has been an occurrence of any such event which would cause the Plan to discontinue the contract with Mutual of America.

Note 6 – Tax Status

The Internal Revenue Service has not yet established a process for issuing determination and opinion letters for individually designed 403(b) plans. The Plan is operating under a prototype plan of Mutual of America. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC). Management of the Plan believes the plan is no longer subject to IRS examination for years prior to 2022.

Mutual of America is the Plan's Custodian and holds the Plan's investment assets and executes investment transactions. The Plan's administrators have obtained a certification from the Plan Custodian that the information provided by the Plan Custodian is complete and accurate with regard to investment assets and related transactions.

Note 8 – Disclosures Regarding Concentrations and Uncertainties

A significant amount of the Plan's investments are invested in contracts and mutual funds managed by Mutual of America. Due to the nature of these investments, there is no guaranty or insured portion of the investment. All of the investment would be considered at risk. However, by diversification of the investment portfolio, the Plan Administrator has attempted to minimize the risk of loss the Plan would suffer due to market volatility.

Note 9 – Exempt Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Mutual of America, and Mutual of America is the Custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Mutual of America amounted to \$999 for the year ended June 30, 2024.
