INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Partnership for Children of Essex 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended June 30, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Partnership for Children of Essex 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEARS ENDED JUNE 30, 2024 AND 2023

1. DESCRIPTION OF PLAN

General --- The following description of the Partnership for Children of Essex 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan, which became effective on July 1, 2004, restated as of July 1, 2015 and formally amended thereafter, is a defined contribution plan covering substantially all full-time employees of Partnership for Children of Essex (the "Organization"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Board of Trustees is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

CARES and SECURE Act --- The Plan has implemented certain requirements by the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), which laws change the Plan to, among others, allow certain eligible individuals to receive coronavirus-related relief for loan repayment, suspend required minimum distributions, and delay the commencement date for required minimum distributions. Written amendments to the Plan to reflect these operational changes have been adopted in accordance with applicable law and IRS guidance.

Eligibility --- The Plan is not available to non-resident aliens who do not receive any compensation from U.S. sources or employees who normally work less than 20 hours per week. Eligible employees are automatically enrolled in the Plan upon hire and can begin to make salary deferrals. Employees become eligible to participate in employer contributions after completing 12 consecutive months of service and attaining 1,000 hours during that period of time and are age 21 or older.

Contributions --- Eligible participants may elect to contribute any percentage of their compensation to the plan, not to exceed a maximum amount established by the Internal Revenue Code (IRC). Additionally, employees age 50 and over are allowed to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan has an automatic deferral feature. Under the provision, all newly eligible employees are automatically enrolled in the Plan at management's designated percentage of 2% annually, unless the employee changes their deferral amount online or through a salary deferral election change sheet. Contributions are invested in a designated balanced fund until changed by the participant. The Plan permits the Organization to make discretionary contributions annually. Employer contributions for the plan years ended June 30, 2024 and 2023 was 6% of participants' eligible compensation amounting to \$386,445 and \$294,677, respectively. The Organization can make changes to its discretionary contribution percentages for these employees upon management's discretion.

Participant accounts --- Each participant's account is credited with the participant's contributions and the Organization's matching contributions, as well as any discretionary contributions. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (CONT.)

Vesting --- Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service.

The following is a schedule of the vesting percentages by years of service:

Notes receivable from participants --- Participants may borrow from their fund accounts a minimum of \$1,000 up to the maximum amount that may be borrowed from a qualified pension plan without being subject to income tax (currently, \$50,000 or, if less, 50% of the value of a participant's non-Roth vested account balance). This amount may be further limited by the provisions of the contract or if participants have other loans under this Plan. Conversely, amendments provided by The CARES Act permit increases to the maximum loan amount to qualified individuals. The loans are secured by the balance in the participant's account. The loan interest rate is set at 2 percent above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions for loans held by Principal Trust Company Corporation ("Principal"). Loans held by The Variable Annuity Life Insurance Company ("VALIC"), are paid directly by the participant to VALIC.

Payments of benefits --- On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum annual amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 10-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Hardship withdrawals --- Upon proof, to the satisfaction of the Plan administrator of an immediate and heavy financial need, amounts contributed by the employee may be withdrawn for a hardship purpose. Any amounts distributed due to a hardship must be distributed in a lump-sum. Distributions are subject to the applicable provisions of the Plan agreement.

Forfeited accounts --- Forfeitures are the nonvested amounts in the accounts of participants who terminate service. At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$6,898 and \$6,634, respectively. These accounts will be used first to pay administrative expenses and then any remaining amounts are used to reduce future employer contributions. Also, in 2024 and 2023, administrative expenses and employer contributions were reduced by \$1,175 and \$38,538, respectively, from forfeited nonvested accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting --- The financial statements of the Plan are prepared on the modified cash basis of accounting. Therefore, with the exception of appreciation or depreciation in the market value of investments, income and expense items are recognized only as cash is received or paid and receivables (other than loans receivable from participants), payables and accrued expenses are not reflected.

Use of estimates --- The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition --- Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's board determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance companies.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants --- Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when earned. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of June 30, 2024 and 2023.

Payments of benefits --- Benefits are recorded when paid.

Expenses --- Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. For the years ended June 30, 2024 and 2023, total administrative expenses charged to the Plan were \$38,176 and \$39,371, respectively.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

3. FAIR VALUE MEASUREMENTS (CONT.)

Level 2 Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's Level 1 assets invested in mutual funds as of June 30, 2024 and 2023 was \$4,459,856 and \$3,809,494, respectively.

4. GROUP ANNUITY CONTRACTS WITH NATIONAL INSURANCE COMPANIES

The Plan holds traditional fully benefit-responsive guaranteed investment contracts ("Contract(s)") with VALIC and Principal, totaling \$148,175 and \$183,860, as of June 30, 2024 and 2023. The insurance companies maintain the contributions in respective general accounts at the company level. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. For each of the Contracts offered under the Plan, the insurance companies have specified that the crediting rate may not be less than -0- percent. The crediting rate is reviewed on a regular basis for resetting. The guaranteed investment contracts do not permit the insurance companies to terminate the agreement prior to the scheduled maturity date.

4. GROUP ANNUITY CONTRACTS WITH NATIONAL INSURANCE COMPANIES (CONT.)

The Contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by VALIC and Principal, represents contributions made under the contract(s), plus earnings, less participant withdrawals or transfers of all or a portion of their investment at the contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contact with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without consent of the issuer.

5. RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are shares of funds managed by VALIC and Principal and/or their subsidiaries. VALIC and Principal are the custodians of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Purchases and sales of these funds are open market transactions at fair market value. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA and applicable exemptions promulgated thereunder. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100 percent vested in their employer contributions.

7. TAX STATUS

The Internal Revenue Service (“IRS”) has determined and informed the service provider of the Organization by a letter dated March 31, 2017, that the prototype Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the Plan is no longer subject to tax examinations for federal income taxes three years from the latest filing date. The Organization had failed to file an annual Form 5500 for the Plan through the year ended June 30, 2019. During 2020, the Organization remediated the filings (refer to Note 10 for further details).

8. INFORMATION PREPARED AND CERTIFIED BY CUSTODIANS

Certain information related to investments and disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2024 and 2023, and net appreciation in fair value of investments for the years ended June 30, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company and Corebridge Retirement Services (formerly known as AIG Retirement Services), who represents the Variable Annuity Life Insurance Company (“VALIC”) and its subsidiaries VALIC Financial Advisors, Inc. and VALIC Retirement Services Company, which are all are members of Corebridge Financial, Inc. (formerly known as American International Group, Inc. (“AIG”)) (the custodians of the Plan).

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

10. DELINQUENT FILER VOLUNTARY COMPLIANCE PROGRAM (“DFVCP”)

Prior to July 23, 2020, the Organization failed to file an annual Form 5500 for the Plan, since 2014 when 403(b) plans became subject to these requirements. On July 23, 2020 the Plan administrator remediated the delinquent filings through a VFCP under the Department of Labor’s Delinquent Filer Voluntary Compliance Program and paid related penalties. However, the IRS could impose penalties up to \$15,000 per year for non-filing. The Plan’s financial statement is prepared on a modified cash basis of accounting and therefore, these amounts have not been accrued. Further, although estimateable, management believes it is not probable the amounts will be owed to the IRS.

Delinquent Filer Voluntary Compliance Program (“DFVCP”) --- The Organization failed to file the Form 5500 from 2014 through 2017. As detailed in Note 10, on July 23, 2020, the Organization rectified the filings. As of April 15, 2025, the Organization has not received notice from the IRS and Department of Labor regarding the total assessed penalties owed.
