## INDEPENDENT AUDITOR'S REPORT

To the Retirement Plan Committee of  
East Tennessee Children's Hospital Association, Inc.:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Pension Plan for Employees of East Tennessee Children's Hospital (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. #### NOTE A--DESCRIPTION OF PLAN

The following brief description of the Pension Plan for Employees of East Tennessee Children's Hospital (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

*General:* The Plan is a defined contribution money purchase pension plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Employees of East Tennessee Children's Hospital Association, Inc. (the Hospital) who are 21 years of age or older, have completed one year of service (1,000 hours of service in a twelve-month period), and are employed on the last day of the specified period are eligible to participate in the Plan. The Hospital's Board of Directors passed a resolution on April 18, 2017, that, effective June 30, 2017, the Plan was frozen to new participants and future contributions, and all participants became fully vested in their account balance. Beginning July 1, 2017, in conjunction with this resolution, participants were permitted to reallocate their account balances to various investment options offered by the Plan. Prior to this date, investments were not participant-directed.

*Participant Accounts:* Each participant's account is credited with an allocation of Plan earnings and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the vested benefit of their account balance.

*Payment of Benefits:* Upon death, disability, or termination of employment for any reason, a participant may elect to receive their vested account balance as a lump-sum payment or as a direct rollover into an IRA or another eligible retirement plan. Effective April 1, 2022, the Plan was restated and amended to allow in-service distributions for participants who reach age 59 1/2. Partial distributions are not permitted.

#### NOTE B--SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting:* The accompanying financial statements are prepared on the accrual basis of accounting.

*Use of Estimates:* The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition:* The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

*Payment of Benefits:* Benefits are recorded when paid. There were no significant amounts allocated to accounts of participants who have elected to withdraw from the Plan, but have not been paid as of June 30, 2024.

*Administrative Expenses:* Administrative expenses related to maintaining participant accounts and third-party administration are paid by the Plan and deducted from participant funds. Plan expenses related to legal and accounting fees may be paid by the Hospital or the Plan.

#### NOTE C--INFORMATION CERTIFIED BY THE TRUSTEES

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by Empower Trust Company, LLC and Great-West Trust Company, LLC, the trustees of the Plan, and was not subjected to any auditing procedures performed by the Plan's independent public accountants:

- The investments from participants as shown in the accompanying Statements of Net Assets Available for Benefits of \$47,624,042, as of June 30, 2024, and \$48,002,668, as of June 30, 2023.
- Interest and dividends and net appreciation in fair value of investments as shown in the accompanying Statement of Changes in Net Assets Available for Benefits of \$1,528,105 and \$3,197,399, respectively, for the year ended June 30, 2024.
- All investment-related information in the accompanying Supplemental Schedule H, Line 4i - Schedule of Assets Held at Year End as of June 30, 2024.

As of August 1, 2022, Great-West Trust Company, LLC's name legally changed to Empower Trust Company, LLC.

#### NOTE D--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy based on valuation inputs. The three levels of the fair value hierarchy are described as follows:

- *Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2:* Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for similar assets and liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.
- *Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the valuation hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value.

*Registered Investment Companies:* Valued at the closing price reported on the active market in which the funds are traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used at June 30, 2024 and 2023.

#### NOTE E--ANNUITY INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into an annuity investment contract with Great-West Life and Annuity Insurance Company (Great-West). Great-West maintains the funds in a general account. Great-West is contractually obligated to repay the principal and a specified interest rate that is guaranteed by the issuer. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The Guaranteed Interest Fund is a group fixed annuity contract, in which the value is derived from the contract provisions. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The contractually guaranteed minimum interest rate will never be less than 0%. Participant-initiated withdrawals from the annuity investment contract to a competing fund are not permitted. Participants are restricted from making a transfer into the Guaranteed Interest Fund for up to 30 calendar days from the date of the most recent transfer from the Guaranteed Interest Fund. Withdrawals from the account due to surrender of the contract by the Plan sponsor may be made at contract value over a 5-year period, a lump-sum payment at contract value at a specified time period, or in the form of a lump-sum payment subject to a market value adjustment.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. The Plan administrator believes no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer, and that also would limit the ability of the Plan to transact at contract value with the participants.

#### NOTE F--RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are units of interest in an annuity contract secured by the general assets of Great-West or other related organizations; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan directly to Great-West totaled \$129,931 during the year ended June 30, 2024. These fees are included in administrative expenses on the Statement of Changes in Net Assets Available for Benefits.

#### **NOTE G--PLAN TERMINATION**

Although it has not expressed any intent to do so, the Hospital has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

#### **NOTE H--TAX STATUS**

The Internal Revenue Service has determined and informed the Hospital by a letter dated June 30, 2020, that the Plan was designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that, more likely than not, would not be sustained upon examination by the applicable authorities. The Plan administrator has evaluated the tax positions taken by the Plan and determined there are no uncertain tax positions as of June 30, 2024, that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

#### **NOTE I--RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and could materially affect the participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### **NOTE J--SUBSEQUENT EVENTS**

Subsequent events have been evaluated through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued. During this period, management did not note any material recognizable subsequent events that required recognition or disclosure in the financial statements.
