We have performed audits of the accompanying financial statements of JCCS, PC 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the JCCS, PC 401(k) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

Junkermier, Clark, Campanella, Stevens, P.C. (JCCS, PC or the Company) established the Plan effective December 1, 1983. The Plan was restated, effective July 1, 2022. The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility**

Contributions to the Plan have separate eligibility requirements:

- Safe Harbor contributions and elective salary deferrals – Employees who have attained the age of 21 are eligible for immediate entry into the Plan.
- Discretionary company matching and non-elective contributions – Employees who have attained the age of 21 and have been employed by the Company for 12 months, providing they have completed 1,000 hours of service during that 12-month period are eligible for entry the first day of each quarter once eligibility requirements are met.

**Contributions**

Participants may contribute to a traditional or Roth account from compensation up to a combined annual maximum of the lesser of 100% of eligible compensation or the Internal Revenue Service limits. The total elective salary deferral may not exceed the limits under Internal Revenue Code (IRC) Section 402(g), as adjusted annually. Participants who have obtained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or defined contribution plans (rollover). The Plan includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant makes an affirmative election otherwise.

The Company makes company contributions based on the eligibility guidelines noted above. The safe-harbor non-elective contributions are equal to 3% of eligible annual participant compensation and are 100% vested upon contribution. Additional matching or non-elective amounts may be contributed at the discretion of the Company’s Board of Directors. To receive the discretionary matching or non-elective contribution, a participant must be employed on the last day of the plan year or have worked in excess of 500 hours. The non-elective contribution was 7% of eligible annual compensation for each of the years ended June 30, 2024 and 2023. No discretionary matching contribution was made for either year.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings, and (c) forfeitures of terminated participants' non-vested accounts. Each participant may direct the trustee as to how the assets of their contributions are to be invested among the available investment asset classes. The benefit to which a participant is entitled is the benefits that can be provided from the participant's vested account.

**Participant's Investment Options**

Upon enrollment in the Plan, a participant may direct their own contributions as well as the employer contributions. There are various investment options available, and participants may change their investment options at any time. Participants may change their deferral contribution amounts at any time by contacting John Hancock.

**Notes Receivable from Participants**

The Plan permits participant loans on employee vested funds. Loans are made in accordance with the Plan's loan policy and applicable Internal Revenue Service and Department of Labor regulations. Interest rates will be equal to 2% above the USA Today prime rate, the day the loan is made. Participants must pledge sufficient collateral for the loan. Loans are generally repaid through payroll deductions and require full repayment ratably over not more than five years, unless the loan was taken for the purchase of the participant's principal residence. Participants may have only one loan outstanding in any 12-month period, loans must be paid in full for 60 days before a new loan may be issued, and the original loan amount cannot exceed 50% of the participant's vested balance, or \$50,000, whichever is less but cannot exceed the employee's contributed amount of their account on the date of the loan.

**Payment of Benefits**

On termination of service, a participant may elect to receive an annuity, installment payments, ad-hoc, or a lump-sum amount equal to the value of his or her account. Distribution of benefits upon termination becomes automatic if the participant's account balance is less than \$5,000. Employees who reach retirement age but continue to work for the Company are eligible for in-service distributions under the same provisions as a retiree or terminated participant. Generally, certain minimum distributions are required for participants who have separated from service and have reached the required minimum distribution age.

**Vesting**

Participants are immediately vested in their elective deferrals and safe-harbor contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching and non-elective profit-sharing contributions and earnings thereon is based on covered years of service. A participant is 20% vested after two years of covered service and vesting increases 20% for each year of covered service thereafter. A participant is 100% vested after six years of covered service.

**Forfeitures**

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents forfeiture. The non-vested employer contributions, except safe-harbor non-elective contributions which are 100% vested, will be allocated to the remaining participants' accounts. The total amount of forfeitures to be reallocated to participant accounts was \$0 and \$16,780 for the plan years ending June 30, 2024 and 2023, respectively. The forfeiture balances were reallocated to eligible participant accounts in conjunction with the funding of the respective year's employer non-elective profit-sharing contribution.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America (GAAP), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Retirement Plan Advisory Committee, which also acts as the Trustee of the Plan, oversees the investment managers for the Plan and determines the Plan's valuation policies. The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefit distributions are recorded when paid.

**Administrative Expenses**

Investment and asset management fees, including trading costs are paid by the Plan. All other fees associated with the Plan are paid by the Company and are excluded from these financial statements. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**NOTE 4 FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). The three levels of the fair value hierarchy under FASB Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds:* Valued at the net asset value (NAV) of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 INCOME TAX STATUS**

The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a significant uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**NOTE 6 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50% or more of such an employer or relatives of such persons. Some Trustees of the Plan are also participants in the Plan. They are eligible to participate in the same manner as all other participants in the Plan.

The Company, which is the Plan Sponsor and third-party administrator of the plan, provides certain administrative services at no cost to the Plan.

John Hancock provides certain administrative services to the Plan pursuant to the service agreement between the Company and John Hancock. For the years ended June 30, 2024 and 2023, the Plan paid fees to John Hancock in the amounts of \$25,282 and \$24,642, respectively.

**NOTE 7 AMENDMENT AND TERMINATION**

Although it has not expressed any intent to do so, the Company reserves the right at any time to amend or terminate the Plan subject to the provisions of the Plan and ERISA. If the company terminates contributions or the Plan is terminated, all participants become fully vested.

**NOTE 8 RISKS AND UNCERTAINTIES**

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
