## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of  
the Cooper Realty Company Employee Benefit Plan

### Opinion

We have audited the accompanying financial statements of Cooper Realty Company Employee Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits – cash basis as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits – cash basis for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements present fairly, in all material respects, the net assets available for benefits of Cooper Realty Company Employee Benefit Plan as of June 30, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with the basis of accounting described in Note 2.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. ## NOTES TO FINANCIAL STATEMENTS

June 30, 2024 and 2023

---

### NOTE 1 – DESCRIPTION OF PLAN

The following description of the Cooper Realty Company Employee Benefit Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan provides medical care benefits covering all electing eligible employees of Cooper Realty and Affiliates (the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Benefits

The Plan provides health benefits (hospital, surgical, doctor prescribed drugs, and major medical) covering electing eligible full-time employees of the plan sponsor. Full-time employees of the plan sponsor who have completed 90 days of employment plus an administrative period are eligible to participate in the Plan. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Participants in the Plan can also elect coverage of eligible dependents by paying the related additional cost. Coverage was extended to participants' dependents until age 26 and the pre-existing conditions limitation under the Plan no longer applies to dependent children under the age of 19. There is no lifetime maximum benefits limit. Benefits up to \$125,000 a year per participant are to be paid from funds provided by the plan sponsor. Benefits in excess of this amount are covered by an insurance policy.

The Plan utilizes a pharmacy benefits manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

#### Self-insured Benefits

All Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processor under an administrative service only (ASO) arrangement. The claims processor pays claims directly to or for participants and is then reimbursed by either the Plan's trust or the general assets of the Company. Despite the Plan's utilization of a third-party claim's processor, ultimate responsibility for payments to providers and participants is retained by the Plan. Benefits are paid solely in the form and amount pursuant to the terms of the program.

#### Contributions

The Plan is funded through contributions made by the Company, participating employees and the purchase of aggregate and specific excess loss insurance. Participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The Plan sponsor makes contributions to the Plan as needed to fund claims in excess of participants' contributions.

### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The Plan pays the administrative fees and expenses charged by the claims administrator, as well as other expenses of administering the Plan.

### Stop Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The accompanying Statements of Net Assets Available for Benefits and Statements of Changes in Net Assets Available for Benefits have been prepared on the cash basis of accounting. This basis differs from generally accepted accounting principles primarily because the Plan has not recognized receivables from the plan sponsor and participants and payables for unpaid claims and their related effects on earnings.

The preparation of financial statements requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Actual results could differ from those estimates.

The Plan maintains cash balances at a bank. Those accounts are insured by the Federal Deposit Insurance Corporation up to an aggregate of \$250,000 per institution. At times deposits may exceed these insured limits. The Plan maintains its cash with high quality financial institutions which the Plan believes limits these risks.

Plan obligations at June 30 for health claims incurred by active participants but not reported at that date are estimated by the Plan's management. Such estimated amounts are reported in Note 3 to the financial statements.

Premiums paid by the Company are recorded as payments to insurance carriers in the accompanying statement of changes in net assets available for benefits; and claim payments are recorded when paid by the third-party claims processor.

Premiums for stop loss insurance are recognized when paid as deductions from net assets in the accompanying statements of changes in net assets available for benefits.

Refunds due from the Plan's PBM are recorded when collected.

The Plan is exempt for federal income tax purposes. The Plan files an annual information return (Form 5500) with the Department of Labor.

### Date of Management's Review

The plan sponsor evaluated the Plan's June 30, 2024 financial statements for subsequent events through April 14, 2025, the date the financial statements were available to be issued. The plan sponsor is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

### NOTE 3 – PLAN BENEFIT OBLIGATIONS

Health claims payable represents claims processed and approved for payment but not paid as of year-end. Plan liabilities for health claims incurred and reported but not paid as of June 30, 2024 and 2023 were estimated to be \$68,703 and \$304,918, respectively.

Plan obligations at June 30 for claims incurred but not reported are estimated based on claims data provided by the Plan's third-party claims administrators. Claims IBNR includes claims that are being processed but have not yet been approved. These amounts are paid by the Plan only if claims are submitted and approved for payment. The 2024 estimate was determined by claims paid from July 1, 2024 through December 31, 2024 with service dates prior to July 1, 2024. The 2023 estimate was determined by claims paid from July 1, 2023 through October 31, 2023 with service dates prior to July 1, 2023. The Plan based its estimate on the average of the prior year historical lagging of claims paid in the first six months after year end. Other plan obligations for health claims incurred but not reported as of June 30, 2024 and 2023 were estimated to be \$1,049,501 and \$673,926, respectively.

#### **NOTE 4 – RELATED PARTY AND PARY-IN-INTEREST TRANSACTIONS**

Plan expenses that are paid directly by the Company qualify as party-in-interest transactions. As described in Note 1, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

#### **NOTE 5 – PLAN MODIFICATION AND TERMINATION**

Although it has not expressed any intention to do so, the Plan sponsor has the right under the Plan to modify benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. The provisions of the Plan will continue in effect for the purpose of payment of plan benefit expense claims incurred on or before the date of termination, but not paid on or before the date of termination.

#### **NOTE 6 – EXCESS LOSS INSURANCE**

In accordance with general practice with self-insurance, the Company purchases excess loss insurance to cover risks in excess of what it is prepared to accept. The policy covers claims exceeding \$125,000 per individual with a maximum aggregate benefit of \$1,000,000. Excess loss insurance does not discharge the Company from its primary liability to the covered participants. Consequently, failure of the insurer to honor its obligation could result in additional claims to the Company.
