## INDEPENDENT AUDITOR'S REPORT

To the Board of Directors  
403(b) Thrift Plan of Juneau Youth Services, Inc.

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of 403(b) Thrift Plan of Juneau Youth Services, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits in liquidation as of June 30, 2024 and December 31, 2023, and the related statements of changes in net assets available for benefits in liquidation for the period from January 1, 2024 to June 30, 2024 and the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024, December 31, 2023, and for the period from January 1, 2024 to June 30, 2024 and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects,

the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting***

As further discussed in Notes 1 and 2 to the financial statements, the Board of Directors of Juneau Youth Services, the Plan's sponsor, approved a plan of liquidation on May 1, 2023, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 and 2024 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the 403(b) Thrift Plan of Juneau Youth Services, Inc. (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on December 1, 1989, as a defined contribution plan covering all full-time employees of Juneau Youth Services, Inc. (the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Termination

The Company was acquired by SouthEast Alaska Regional Health Consortium in April 2023. In connection with the acquisition, the Company's Board of Directors made a resolution to terminate the Plan effective May 1, 2023, at which time all employee and employer contributions into the Plan were ceased. All participants were notified of the Plan termination. Upon Termination, participants became 100% vested in the Company's contributions. The liquidation of the Plan was completed on June 30, 2024. The Plan's assets of participants who did not request a distribution were converted to individual annuities on June 30, 2024. The description of the Plan that follows describes the Plan prior to termination, effective May 1, 2023.

Contributions

Each year, participants may contribute up to the legal limit of pretax annual compensation as defined in the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated retirement fund and their deferral rate will automatically increase by 1% in each subsequent Plan year following the Plan year in which automatic enrollment contributions commenced, up to 6%. The Company's contributions to the Plan are allocated to all eligible participants based on a participant's earnings and consist of employer matching contributions and employer base contributions. Employer matching contributions are allocated at an amount equal to 50% of the participant's salary reduction contributions, not to exceed 4% of the participant's compensation received during the Plan year in which the participant was eligible to receive employer contributions. Employer base contributions are determined using a fixed percentage rate of 2.5% of the participant's compensation received during the Plan year in which the participant was eligible to receive employer contributions. Only participants who complete one year of service, have worked at least 1,000 hours during this one year of service, and are at least 18 years of age are eligible to receive employer contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (1) the Company's contribution and (2) Plan earnings. Allocations are based on the Company's contribution for each participant and their account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Distributions from the Plan are made when a participant retires, dies (in which case payment

shall be made to his or her beneficiary, or if none, his or her legal representative), or otherwise terminates employment with the Company. Hardship withdrawals are permitted under certain circumstances.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon, while vesting in the Company's contribution is based on years of continuous service. A participant is not vested on any portion of employer contributions until they have completed three years of credited service, at which point they become 100% vested.

Payment of Benefits

Upon termination of service due to death, hardship or retirement, a participant may elect to receive benefits by various methods. Participants should consult the Plan agreement for detailed information concerning distribution options.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at 4.60%. Principal and interest are paid ratably through monthly payroll deductions. The loan term may generally not be longer than five years.

Forfeited Accounts

As of June 30, 2024 and December 31, 2023, forfeited, non-vested accounts totaled \$-0- and \$-0-, respectively. Forfeited accounts will first be used to reduce Plan expenses and the remainder will be used to reduce employer contributions. During 2024 and 2023, employer contributions were reduced by the forfeited, non-vested accounts in the amount of \$-0- and \$13,427, respectively.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

As a result of the Board of Directors of the Company's decision to terminate the Plan effective May 1, 2023, the liquidation basis of accounting was used in presenting the statement of net assets available for benefits in liquidation and the statement of changes in net assets available for benefits in liquidation as of June 30, 2024 and for the period January 1, 2024 through June 30, 2024 and as of and for the year ended December 31, 2023.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The Plan's fully benefit-responsive guaranteed investment contract (FBRGIC) was recorded at face value, which approximated fair value for the insurance company's general account, as provided by Mutual of America Life Insurance Company. The FBRGIC was considered a cash equivalent (subject to credit and market risk) and was not subject to the fair value hierarchy (see Note 3). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in

the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Management considers the notes receivable to be fully collectible at year-end. Accordingly, no allowance for doubtful accounts has been recorded.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Payments of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the amounts in the financial statements and the accompanying notes. Actual results may vary from these estimates.

**NOTE 3 – FULLY BENEFIT-RESPONSIVE GUARANTEED INVESTMENT CONTRACT**

The Plan offers participants the option to invest in a traditional fully benefit-responsive guaranteed investment contract with Mutual of America Life Insurance Company totaling \$-0- at June 30, 2024 and \$1,942,993 at December 31, 2023. Mutual of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at face value, which management has determined approximates fair value for the purpose of valuing the investment in liquidation. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Mutual of America, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract.

**NOTE 4 – FAIR VALUE MEASUREMENT**

FASB ASC 820, *Fair Value Measurement and Disclosure*, defines fair value as the exchange price that would be received on the measurement date to sell an asset or the price paid to transfer a liability in the principal or most advantageous market available to the entity in an orderly transaction between market participants. FASB ASC 820 also establishes a three-level fair value hierarchy that describes the inputs that are used to measure assets and liabilities. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2024 and at December 31, 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These

funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumption to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Fair values for level 1 investments are determined by reference to quoted market prices and other relevant information generated by market transactions.

**NOTE 5 – INCOME TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The terms of the plan have been prepared to conform to the listing of 403(b) plans that have been pre-approved by the Internal Revenue Service. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 – INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at June 30, 2024 and December 31, 2023, and investment income for the period from January 1, 2024 to June 30, 2024 and for the year ended December 31, 2023 that is

disclosed in the accompanying financial statements and supplemental schedules was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Mutual of America Life Insurance Company, the certifying custodians of the Plan.

**NOTE 7 – TRANSACTIONS WITH RELATED PARTIES OR PARTIES IN INTEREST**

Certain Plan investments are in shares of mutual funds managed by Mutual of America Life Insurance Company. Mutual of America Life Insurance Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$509 for the period from January 1, 2024 to June 30, 2024 and \$173 for the year ended December 31, 2023.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. There was one investment that individually represented more than 10% of the investments held as of December 31, 2023. See the supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) for the complete listing of investments held as of that date.

**NOTE 9 – NONEXEMPT PROHIBITED TRANSACTIONS**

During 2022 and 2023, the Plan's management determined that certain elective deferrals withheld from employees' payroll were not remitted to the Plan by the Plan sponsor within the time period required by the Department of Labor. The Plan sponsor determined the lost earnings of these deposits and remitted such earnings to the Plan in 2024. These transactions constitute prohibited transactions as defined by ERISA.
