Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. We are required to be independent of the Mar-Val Food Store No1 Inc 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTE 1. DESCRIPTION OF PLAN

The following description of the Mar-Val Food Store No1 Inc 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

Effective July 1, 2023, the Plan was amended to change the name of the Plan from the Incentive Promotions, Inc. 401(k) Profit Sharing Plan to the Mar-Val Food Store No1 Inc 401(k) Profit Sharing Plan. The Plan is a defined contribution plan covering all full-time employees of Mar-Val Food Stores 4 Inc, CalNorthMarkets LLC, and Mar-Val Emporium Inc (the “Company”). The three companies comprise a controlled group and therefore the Plan is a single employer plan. Employees are eligible after completing six months of service and attaining age 21. The Plan has semi-annual entrance dates of January 1st and July 1st and participants are eligible to participate effective with the first plan entrance date following completion of their first six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to the maximum allowed by law of pretax annual compensation, as defined by the Plan. The contributions are allocated to the investment choices as selected by the participants. Contributions are subject to certain limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Matching Contributions

The Company makes a contribution of 100% of the employee’s salary deferrals that do not exceed 4% of the employee’s compensation, plus 600% of the employee’s salary deferrals that exceed 4% of compensation but that do not exceed 5% of compensation as defined by the Plan which excludes bonuses and taxable benefits as defined in the Plan documents as long as the employee is actively employed (as defined in the Plan documents).

Discretionary Contributions

The Company may make a discretionary Profit Sharing Contribution which is based on the ratio of a participant’s compensation to total compensation for all participants. In order to receive an allocation of discretionary employer contributions, an employee must have worked 1,000 hours during the Plan Year, and be employed on the last day of the Plan Year. A profit sharing contribution was made for the year ended June 30, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in all their contributions and earnings. The employer contributions have a six year vesting schedule, which starts at 20% after two years of service and increases by 20% each year so that at the end of six years an employee is fully vested in the employer contributions and earnings.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's account or periodic payments over the participant's life expectancy. For termination of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or elect to leave it in the plan.

Notes Receivable from Participants

Participants may borrow from their funds accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participants Notes fund. Loan terms range from 1-5 years. These loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Interest rates range from 5.25% to 10.50%. Principal and interest is paid ratably through payroll deductions.

Investment Options

Upon enrollment in the Plan, a participant may direct all contributions in 5% increments into any of the mutual fund investment options in the Plan. The investment options are mutual funds held by registered investment companies offered by John Hancock Trust Company.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, of which the Plan has none.

Investment Valuation and Income Recognition

Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. Securities traded on the national securities exchange are valued at the last reported sales price on the last business day of the plan year. Investments traded in the over-the-counter market and listed securities for which no sale was reported on that date are valued at the average of the last reported bid and asked prices.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual bases. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of June 30, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Expenses

Certain expenses of maintaining the Plan like the annual audit are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the recordkeeping and investment advisor are charged directly to participant accounts and are included in contract administrator fees and other fees. All other investment related expenses are reflected as charges against net appreciation of fair value of investments as not paid directly by the Plan.

Payment of Benefits

Benefits are recorded when paid.

Forfeited Accounts

Forfeitures of matching contributions are used to reduce the amount of employer matching contributions and pay certain administrative expenses. Forfeitures of profit sharing contributions are reallocated as an additional profit sharing contribution. At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$30,471 and \$47,640, respectively. Forfeitures totaling \$40,087 were used to reduce the Employer contributions and pay administration fees.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Subsequent Events

In preparing the financial statements, management has evaluated events and transactions for potential recognition or disclosure through April 11, 2025, the date the financial statements were available to be issued.

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at June 30, 2024 and 2023.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. The fair values of common stock, corporate bonds, and U.S. Government securities are based on quoted market prices.

NOTE 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in employer contributions.

NOTE 6. TAX STATUS

The Employer adopted a Prototype Non-Standardized Profit Sharing Plan #002 submitted by Associated Pension Consultants and received a letter dated June 30, 2022, from the Internal Revenue Service that it had determined the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan was restated effective July 1, 2020. The Plan Administrator and the Plan's pension consultant who drafted the prototype plan believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal and California taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8. RELATED PARTY, PARTY IN INTEREST, AND PROHIBITED TRANSACTIONS

The Plan assets are in mutual funds held by John Hancock Trust Company which is a custodian, as defined by the Plan and accordingly, transactions with John Hancock Trust Company qualify as party-in-interest transactions according to applicable regulations.

Fees incurred for investment management services, recordkeeping and information management are based on percentages provided to the Plan and as such John Hancock Trust Company do not report a dollar amount for these fees and are indirect compensation as defined for Form 5500 reporting and satisfies reporting requirement under alternative reporting as it properly discloses the indirect compensation to the Plan. The Plan paid \$47,640 directly to the third-party administrator and \$31,919 to the custodian during the year ending June 30, 2024. The Plan Sponsor pays directly any other fees related to the Plan's operations.

The late deposit of certain employee deferrals and loan repayments results in a prohibited transaction. In the plan year ending June 30, 2024, deposits consisting of employee deferrals and loan repayments of \$141,986 were remitted late, as disclosed in the supplemental schedule of delinquent participant contributions. The Plan has not yet corrected lost earnings for these late deposits. In years prior to 2024, deposits totaling \$610,270 were remitted late, for which lost earnings were deposited into the Plan during the plan year ended June 30, 2024.
