The supplemental Schedule of Assets (Held at End of Year) as of June 30, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Plan Description and Summary of Significant Accounting Policies

---

The following description of The Minnesota Coaches Family of Companies Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General Information

The Plan is a defined contribution plan which was established on July 1, 2019 and covers all eligible employees of Metro Bus Service, Inc., Round Trip Services, Inc., Family Bus Service, Inc., Ready Bus Company, Inc., Ottertail Transportation, Inc., and Faribault Transportation Service, Inc., and their affiliates (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Merger

In January 2023, the assets of the following retirement plans were merged into the Plan: Profit Sharing Plan of Metro Bus Service, Inc. Employer Group; Round Trip Services, Inc. Employer Group Profit Sharing Plan; Profit Sharing Plan of Family Bus Service, Inc. Employer Group; Profit Sharing Plan of Ready Bus Company, Inc.; and Ottertail Transportation, Inc. Employer Group Profit Sharing Plan. As a result, assets totaling \$18,455,438 were transferred into the Plan at that time.

#### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Participation

Under the terms of the Plan, employees are eligible to make elective deferrals on the first day of the first calendar quarter that begins at least 30 days after the date of hire. Employees are eligible to receive discretionary nonelective contributions if they have completed 500 hours of service during the computation period and are employed as of the last day of the Plan Year.

#### Contributions

Each year, participants may contribute from 1% to 100% of pretax compensation not to exceed the limits of the Internal Revenue Code (IRC), as defined in the Plan. Participants who have attained the age of 50 before the end of the Plan year are also eligible to make catch-up contributions in any amount up to the limits prescribed by law. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their elective deferral contributions into various investment options offered by the Plan. Effective January 1, 2023, participants may also contribute post tax compensation.

#### Contributions (Continued)

The Company may contribute to the Plan discretionary nonelective contributions. The Company's nonelective contribution, if any, is allocated to participants eligible to share in the contribution based upon a percentage calculated by dividing the participant's eligible plan compensation by the total eligible plan compensation of all eligible participants.

Effective August 1, 2022, participants direct the investment of their nonelective contributions. Prior to that date, the Plan's trustees directed the investment of nonelective employer contributions into various investments offered through a brokerage investment platform. The Company's contributions do not exceed the maximum deduction allowable under the regulations of the IRC.

#### Participant Accounts

Each participant's account is credited with the participant elective deferrals, nonelective profit sharing contributions and an allocation of Plan earnings, and is charged with administrative expenses for certain transactions as defined by the Plan. Allocations of earnings are credited in accordance with the earnings reported by the funds in which the participant has invested.

#### Notes Receivable from Participants

The Plan does not allow for participants to borrow from their fund accounts.

#### Vesting and Forfeitures

Participants are immediately vested in any amounts rolled over from other qualified plans, other than those related to the Plan through common ownership. Additionally, the salary deferral portion of participant accounts is 100% vested at all times.

Vesting in Company contributions is based upon years of service. A participant is zero percent vested after one and two years of service and is 100% vested after three years of credited service. A participant who terminates employment before fully vesting, forfeits that portion of their allocation of the Company's contributions in which they had not yet fully vested.

A participant will be immediately 100% vested upon death, disability or the later of reaching normal retirement age or the fifth anniversary of the date on which the employee first became eligible to participate in Company contributions, as defined in the plan document.

#### 1. Plan Description and Summary of Significant Accounting Policies (Continued)

---

##### Payment of Benefits

A participant is eligible for a distribution of the vested portion of their profit sharing account after terminating employment and incurring a one-year break in service. A participant is eligible for a distribution of their elective deferral account when their employment with all contributing employers has been terminated, or when they have reached normal retirement age.

If a participant's combined account balance exceeds \$5,000, he or she may elect to defer the benefit payment in accordance with Plan guidelines. If a participant's vested account balance is less than \$7,000, the Plan may distribute the vested account balance without the written consent of the participant. The participant has the option to take the distribution in cash or as a rollover. If no election is made, the Plan will make the distribution to an individual retirement account for the participant.

In-service distributions, including hardship distributions, are allowed from a participant's elective deferral and rollover portions of their account balances. Benefit payments are recorded upon distribution to participants.

##### Investment Valuation and Income Recognition

Investments are reported at fair value, which is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

All purchases and sales of securities have been recorded on a trade-date basis. Income is recorded as earned. The increase or decrease in the fair value of investments represents the net difference between the current value of securities held at the beginning of the year or cost of securities purchased during the year and the current value of securities held at the end of the year.

##### Administrative Expenses

The plan sponsor pays most costs and expenses incurred in connection with the operation of the Plan. Administrative expenses paid by the plan during the year ended June 30, 2024 and 2023 were for management of certain plan investments. These expenses are included on the statements of changes in net assets available for benefits.

##### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### Regulatory Changes

The Plan suspended required minimum distributions for 2020 as allowed under the Coronavirus Aid, Relief and Economic Security (CARES) Act. The Plan was not amended for this change since it is not required to be amended until the year ended June 30, 2026. Management intends to amend the Plan for this change prior to that date. No other changes to Plan provisions related to the CARES Act were in effect for the years ended June 30, 2024 and 2023.

#### Subsequent Events

In preparing these financial statements, Plan management has evaluated events and transactions for potential recognition or disclosure through April 11, 2025, the date the financial statements were available to be issued.

---

### 2. Certification of Investments

---

The Trustees of the Plan have appointed The Standard Insurance Company (The Standard, formerly Minnesota Life Insurance Company) as Custodian of the Plan's assets. The Standard has supplied the plan administrator with certifications as to the completeness and accuracy of total assets of the Plan invested by the Custodian aggregating \$23,134,200 and \$19,542,295 as of June 30, 2024 and 2023, respectively, and the related investment income of \$2,626,013 and \$601,634 for the years then ended, respectively. Such amounts and all related financial data are included in the accompanying financial statements and supplemental schedule based on such certification from The Standard.

Under the terms of the Custodial agreement, the Custodian manages investment funds on behalf of the Plan. The Custodian has been granted discretionary authority concerning the purchases and sales of the investment funds.

---

### 3. Fair Value Measurements

---

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

#### 3. Fair Value Measurements (Continued)

---

The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Observable market-based inputs or unobservable inputs that are corroborated by market data. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

**Pooled separate accounts:** Pooled separate accounts are valued based upon the unit value of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although they are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. Forfeitures

---

Terminated participants forfeit their non-vested balance upon the earlier of the receipt of their vested benefits or after incurring five consecutive one-year breaks in service. Forfeitures can be used to pay plan expenses or can be allocated to the remaining participants in the Plan based on the percentage of the participant's compensation compared to the compensation of all eligible participants. For the plan years ended June 30, 2024 and 2023, forfeited non-vested accounts totaled \$4,127 and \$3,696, respectively. Forfeitures in the amount of \$5,106 were used to pay plan expenses during the year ended June 30, 2024. There were no forfeitures used to pay plan expense or allocated to participants during the year ended June 30, 2023.

As of June 30, 2024 and 2023, forfeited non-vested amounts totaling \$2,787 and \$3,711, respectively, were available to pay plan expenses or to be allocated to the participants.

---

#### 5. Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

---

#### 6. Concentration Risk

---

Individual investments representing 20% or more of the total investments subject the Plan to potential concentration risk. As of June 30, 2024 and 2023, investments over the 20% threshold were as follows:

#### 7. Plan Tax Status

---

The Plan administrator and the Plan's tax counsel believe that the Plan was, and is, designed and being operated in compliance with applicable requirements of the Internal Revenue Code.

Plan management evaluates all significant tax positions as required by generally accepted accounting principles in the United States of America. As of June 30, 2024, management does not believe that the Plan has taken any tax positions that would require the recording of any additional tax liability, nor does management believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan's tax returns are subject to examination by the appropriate regulatory authorities as of June 30, 2024 and generally remain open for three years.

---

#### 8. Risks and Uncertainties

---

The Plan's assets are invested in a variety of investments in exchange traded funds and mutual funds with registered investment companies. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the value of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### 9. Party-in-Interest Transactions

---

Transactions resulting in Plan assets being transferred to or used by a party-in-interest are considered prohibited transactions under ERISA unless a specific exemption exists. The plan custodian manages certain Plan investment transactions; therefore, the transactions qualify as party-in-interest transactions and are indicated as such on the supplemental Schedule of Assets Held at End of Year. However, the transactions are not considered prohibited transactions as ERISA regulations provide for a specific exemption for such transactions. Additionally, certain employees of the Company provide to the Plan certain accounting and administrative services for which no fees are charged.

---

#### 10. Reconciliation of Financial Statements to Form 5500

---

The financial statements are prepared on the accrual basis of accounting whereas the Form 5500 is prepared on the cash basis of accounting. The following is a reconciliation of net assets available for benefits per the financial statements to the Form 5500 as of June 30, 2024 and 2023:
