INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Oostburg Concrete Products, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Oostburg Concrete Products, Inc. 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - modified cash basis for the years then ended, and the related notes to the financial statements - modified cash basis.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the plan's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

Other Matter - Basis of Accounting

We draw attention to Note 1 of the financial statements, which describes the basis of accounting. The financial statements were prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than GAAP. Our opinion is not modified with respect to this matter.

ERISA-Required Supplementary Information

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and is derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the 2024 financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion,

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - Oostburg Concrete Products, Inc. 401(k) Plan ("the plan") follows the modified cash basis of accounting. Under that basis, certain additions and the related assets are recognized when received rather than when earned and certain deductions are recognized when paid rather than when the obligation is incurred. That basis differs from accounting principles generally accepted in the United States of America ("GAAP") primarily because the plan has not recognized contributions receivable and the related effect on changes in net assets in the accompanying financial statements.

Accounting estimates - The preparation of financial statements requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through April 4, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits - modified cash basis.

Key parties of the plan - Oostburg Concrete Products, Inc. is the plan sponsor, employer and plan administrator. Northwestern Wisconsin Associates, Inc. is the third party administrator and maintains plan documents and tax counsel that performs various compliance tests. Empower Annuity Insurance Company of America is the investment agent that holds custody of plan assets and Empower Retirement, LLC is the recordkeeper that maintains investment and participant records. The two Empower entities discussed above are collectively referred to as "Empower". Harbour Investments, Inc. is the plan's investment advisor. Three participants of the plan are the plan trustees.

Investments - The plan sponsor determines the investments available to plan participants. Participants direct their contributions and transfer existing balances amongst these investment options. Earnings on investments bought, sold and held during the years are reflected in the statements of changes in net assets available for benefits - modified cash basis. Participants should refer to the investment account summaries and prospectuses for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

The following is a description of the valuation methodology used for investments measured at fair value.

Pooled Separate Accounts - The pooled separate accounts ("PSAs") are valued at net asset value ("NAV") as provided by Empower, which is generally based on the fair value of the underlying investments held less their liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the separate account intends to sell the investment for an amount different than the reported NAV.

The plan administrator determines by level, within the fair value hierarchy, the plan's investments at fair value as set forth below.

- (a) The objectives of these funds are to provide for capital appreciation and/or income consistent with the risk and return of the fund type summarized above utilizing domestic equity market segments.
- (b) The objectives of these funds are to provide for capital appreciation and/or income utilizing international equities, including global growth and emerging market segments.
- (c) The objectives of these target date funds are to provide for capital appreciation and current income utilizing a risk profile consistent with the target date of the funds.

Investment at contract value - The plan has a fully benefit-responsive guaranteed investment contract through an annuity contract, issued by Empower. Empower maintains the contributions in its general account. The issuer is contractually obligated to repay the principal and a declared amount of interest. The contract provides two declared interest rates; a current rate, determined at least monthly, and a guaranteed minimum floor rate, determined at least annually.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by the issuer, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal of all or a portion of the investment at contract value at any time.

In the event the plan sponsor elects to liquidate the full amount invested in this account, the plan may be subject to a market value adjustment. The contract does not have a maturity date and there are no contract provisions that require a distribution at contract value at any specified time. The contract will continue in full force until all investment assets have been distributed or no further payments are due.

The plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the plan to transact at contract value with the issuer. As of the date these financials are available to be issued, the plan sponsor is not aware of any events that would limit the ability of the plan to transact at contract value with the contract issuer or limit the ability of the plan to transact at contract value with the participants.

2. DESCRIPTION OF PLAN

The following description of the plan provides general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

General - The plan was established on June 1, 1994 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees who have attained the age of twenty-one and have completed one year of service (defined as 1,000 hours) are eligible to participate in the plan. An employee can enter the plan on the first day of the plan quarter after meeting the eligibility requirements.

Contributions - Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). Roth elective deferral contributions are also allowed under the plan.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. An employer matching contribution may be made equal to a discretionary percentage, determined by the employer's board of directors, of the employee's elective deferral contributions. No such contributions were made in 2024 or 2023.
- d. Profit sharing contributions may be made at the discretion of the employer's board of directors. In order to share in the profit sharing allocation, participants must work at least 1,000 hours of service during the plan year in which the contributions relate and be employed on the last day of the plan year. These requirements are waived upon death, disability or termination of employment on or after attainment of normal retirement age. Discretionary profit sharing contributions received by the plan totaled \$245,000 in 2024 and \$180,000 in 2023. These contributions were allocated to participant accounts based on 2023 and 2022 eligible wages, respectively. The 2024 profit sharing contributions declared totaled \$270,000 and will be paid in 2025.

Participant accounts - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected by the participants. Each participant's account is credited with the participant's elective deferral contributions and rollover contributions and an allocation of employer contributions. Participants are allowed to transfer funds between the various investment options daily and change their deferral percentage each pay period.

Vesting - Participants are always 100% vested in their elective deferral and rollover contributions and related earnings. Participants begin vesting in employer contributions and related earnings upon two years of service, at which time they are 20% vested. Participants then vest at the rate of 20% for each year thereafter. Upon death, disability or attainment of normal retirement age while still employed, participants become 100% vested.

Payment of benefits - Benefit payments may commence upon termination of employment, death or disability or attainment of early retirement age (defined as 55). Distributions are in the form of a single lump sum payment. In addition, hardship withdrawals are permitted by the plan under certain circumstances. In-service withdrawals can commence upon attaining the age of 59½.

Forfeitures - Forfeited nonvested employer contribution amounts may be used to pay plan administrative fees or reduce employer contributions. There were no forfeitures used in 2024 or 2023. Unapplied forfeitures were \$28,000 and \$24,000 as of December 31, 2024 and 2023.

Administrative fees - Certain administrative fees of the plan are paid by the plan sponsor and not included in these financial statements. Certain other fees are paid using plan assets and recorded as administrative expenses in these financial statements. Administrative expenses paid by the plan consist of participant directed charges for distribution processing fees and nonparticipant directed charges for program and administrative fees. Nonparticipant directed charges are allocated on an account value basis.

Note receivable from a participant - Participant loans are no longer permitted effective January 1, 2023. As of December 31, 2024, there was one loan outstanding, which was initiated prior to January 1, 2023. As of December 31, 2024, the note receivable from a participant had a repayment schedule through April 2027 with an interest rate of 5.50%. The note receivable from a participant is valued at its unpaid principal balance plus any accrued but unpaid interest, which approximates fair value.

3. PARTY-IN-INTEREST TRANSACTIONS

The plan's investments are managed by Empower. Empower is the investment agent as defined by the plan, and therefore, transactions between the plan and Empower qualify as party-in-interest transactions. In addition, as part of an administrative services agreement between the plan sponsor and Empower, Empower receives indirect compensation from the plan's underlying investment providers for services Empower provides to the funds. This revenue is used to offset certain amounts that would otherwise be owned by the plan to Empower for its administrative services to the plan. There are also certain other plan expenses that Empower charges that are paid directly. Direct fees paid by the plan to Empower were insignificant in 2024 and 2023. The note receivable from a participant is also considered to be a party-in-interest transaction. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the employer has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their employer contributions and related earnings.

5. INCOME TAX STATUS

The plan is operating under a Northwestern Wisconsin Associates non-standardized pre-approved profit sharing plan that received a favorable opinion letter on June 30, 2020. The opinion letter received from the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. As a result, the plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. The plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain positions taken that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.
