Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Assumption Home 401(k) Plan & Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and December 31, 2023, and the related statements of changes in net assets available for benefits for the period ended June 30, 2024 and year ended December 31, 2023, and the related notes to the financial statements.

NOTE 1 DESCRIPTION OF PLAN

The following description of The Assumption Home 401(k) Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Assumption Home, Inc. (Employer). The Plan was originally effective January 1, 1998. The Plan was last amended and restated effective January 1, 2024. Effective January 1, 2024, the Employer was acquired by another Company and thus the Plan was restated to freeze the Plan of any future contributions and change the vesting for all participants to 100%. Effective June 30, 2024, the Plan transferred its assets into The Benedictine Health System Employees Retirement & 401(k) Plan (see Note 6 and 9).

Prior to January 1, 2024, the Plan covers all employees who meet certain eligibility requirements. An employee is eligible for the deferral and matching contribution portions of the Plan upon obtaining 90 days of service and age 21. The Plan excludes reclassified employees, nonresident aliens, employees covered by a collective bargaining agreement, leased employees, interns, temporary employees and residents of Puerto Rico. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Effective January 1, 2024, the Plan is frozen and ceased all contributions.

Prior to January 1, 2024, the Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) or Roth contributions to the Plan. The Plan includes an auto-enrollment provision whereby all eligible participants that don't have an affirmative election in place of at least 2%, or have not made an election, are automatically enrolled in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant. Participants can opt-out at any time. Those that are automatically enrolled will have that percentage increased annually by 0.5% until their deferral rate reaches 15%. Participants must opt-out each year if they do not want to have that automatic increase to their deferral rate. The Plan allows participants age 50 and older to make catch-up contributions.

Prior to January 1, 2024, the Employer may, at its discretion, elect to make a discretionary matching contribution and/or a discretionary nonelective contribution to the Plan. A participant must be employed on the last day of the Plan year, in order to be eligible for the discretionary nonelective contributions, unless the employee terminates due to death or disability. The Employer authorized a discretionary matching contribution of 50% of deferrals up to a maximum of 6% of compensation deferred for the year ended December 31, 2023. There was no discretionary nonelective contributions authorized for the year ended December 31, 2023.

Contributions (Continued)

Prior to January 1, 2024, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans or conduit IRA's. Participants direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a collective fund as investment options for participants. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer discretionary contributions, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Prior to January 1, 2024, vesting in the Employer discretionary matching and discretionary nonelective contribution portions of their accounts, plus actual earnings thereon, is based on years of continuous service. Participants vest at a rate of 50% per year beginning with the second year of credited service. A participant is 100% vested after three years of credited service.

Notwithstanding the above, a participant's account will become fully vested upon reaching normal retirement (age 65), death, or disability.

Benefit Payments

Upon termination of service, death, disability, or retirement (age 65), the participant will receive the value of the vested interest in his or her account in the form of a lump sum or installments. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent, and the benefit payment will be rolled into an individual retirement account in the participant's name. The Plan also allows for in-service distributions if a participant reaches age 59½, and hardship distributions subject to Plan provisions.

Forfeited Accounts

Forfeited nonvested accounts can be used to reduce Employer contributions, pay Plan expenses, or reallocated as additional Employer contributions. Forfeited nonvested accounts as of June 30, 2024, and December 31, 2023 totaled \$8,049 and \$6,104, respectively. Forfeitures in the amount of \$-0- and \$17,080 were used to reduce Employer contributions during the period ended June 30, 2024, and year ended December 31, 2023, respectively. Forfeitures in the amount of \$3,790 and \$2,960 were used to pay Plan expenses during the period ended June 30, 2024, and year ended December 31, 2023, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Benedictine Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian, and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Employer, as provided by the Plan document. Expenses paid directly by the Employer are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through April 11, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Alerus Financial, N.A., the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all the investment information reflected on the accompanying statements of net assets available for benefits as of June 30, 2024 and December 31, 2023, the statements of changes in net assets available for benefits for the period ended June 30, 2024 and year ended December 31, 2023, and the supplemental schedule of assets (held at end of year) as of June 30, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at June 30, 2024 and December 31, 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Fund: Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Employer contributions.

Effective June 30, 2024, the Plan transferred its assets into The Benedictine Health System Employees Retirement & 401(k) Plan.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter from the IRS on the prototype plan indicating that the Plan is designed in accordance with the applicable section of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

The Plan investments are managed by Alerus Financial, N.A., the qualified institution of the Plan; therefore, the investment transactions qualify as party-in-interest transactions.

NOTE 9 PLAN TRANSFER

Effective June 30, 2024, the Plan authorized the transfer of assets from the Plan into The Benedictine Health System Employees Retirement & 401(k) Plan. On July 3, 2024, assets in the amount of \$2,496,839, were transferred into The Benedictine Health System Employees Retirement & 401(k) Plan. These assets are presented as due to successor plan as of June 30, 2024.
