## Report of Independent Auditor

To the Investment Committee of the Board of Trustees

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Charlotte Latin Schools, Inc. Retirement Income Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. **Note 1—Description of the Plan**

The following brief description of the Charlotte Latin Schools, Inc. Retirement Income Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

*General* – The Plan is a defined contribution plan and was established by Charlotte Latin Schools, Inc. (the “School”, “Employer”, or “Plan Sponsor”) on July 1, 1986, and was amended and restated effective January 1, 2009. The Plan was amended effective January 1, 2024 to allow Roth elective deferrals, Roth rollover contributions, and in-plan Roth conversion contributions. In addition, the Plan was amended effective May 1, 2024 to remove the one year of service requirement related to Employer matching and non-elective contributions. All employees, except those who are excluded according to the Plan’s provisions, are eligible to participate in the Plan for purposes of making salary deferral contributions to the Plan. An excluded employee is an employee who normally works less than 20 hours per week or an employee who is a student services described in Section 3121(b)(10) of the Internal Revenue Code (“IRC”). The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (“ERISA”).

*Administration* – The Plan is administered by the School, which serves without compensation. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

*Contributions* – Participants may contribute a percentage or dollar amount of annual compensation subject to IRC limitations. Once eligible, participants may also contribute amounts representing distributions from other qualified retirement plans, 403(b) tax sheltered annuity plans, government 457(b) plans, and traditional individual retirement accounts. Matching Employer contributions are discretionary and are calculated on a monthly basis for all participants who elect to make salary deferral contributions to the Plan. The amount of the matching contribution, if any, is based upon years of service as follows: 0 (or more) – 4%; 6 (or more) – 5%; 16 (or more) – 6%; 25 (or more) – 7%. The School also makes a non-elective contribution to participant accounts equal to 4% of participants’ salary. All full-time employees receive the 4% non-elective contribution after one year of service. The one year of service provision was removed effective May 1, 2024. Thus, for periods after May 1, 2024, employees become eligible for Employer contributions once they are eligible to participate in the Plan.

*Catch-Up Contributions* – For the year ended June 30, 2024, if a participant is eligible to make deferrals and turns 50 before the end of the calendar year, the participant may defer an additional \$7,500 into the Plan as a contribution subject to certain IRC limitations. Catch-up contributions are eligible for matching contributions made by the Employer. If a participant has worked at least 15 years for the Employer, the participant may make a special catch-up contribution. If a participant qualifies for both types of catch-up deferrals, the contributions will be allocated first as special catch-up contributions.

*Participant Accounts* – Each participant’s account is credited with the participant’s contributions, related School matching and non-elective contributions, and an allocation of Plan earnings and charged with participant distributions and an allocation of administrative expenses, if not paid by the School, and an allocation of Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting Requirements* – Participants are immediately fully vested in their voluntary contributions, including catch-up contributions, rollover contributions from other plans, all Employer contributions, and earnings thereon.

*Investment Options* – Upon enrollment in the Plan, a participant may direct 100% of their allocation of contributions with Transamerica Life Insurance Company, Inc. (“TLIC” or the “qualified institution”). Within TLIC, participants may select between several investment options.

**Note 1—Description of the Plan (continued)**

*Notes Receivable from Participants* – Participants may borrow directly from the funds held by TLIC a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. According to the Plan document, participants may borrow from all contributions that are part of their vested account except for rollovers, Employer matching, and non-elective contributions. Loans are secured by the balance in the participant's account and bear interest rates ranging from 4.50% to 9.50% with maturities through March 2032 as of June 30, 2024. The repayment period from the date of the loan ranges from a period of one to five years as negotiated at the time the loan is made. However, the five-year repayment limitation is extended to 10 years when the loan is used to purchase a principal residence. Principal and interest is paid through an automatic draft of the participant's checking account by the Plan administrator.

*Benefits Paid to Participants* – Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount, equal to the value of the participant's vested interest in his or her account, a lifetime annuity, or various other annuities that are dependent on time of death and payout schedule elected. For termination of service for other reasons, distribution of the value of the participant's vested interest in his or her account will begin as soon as possible after the participant's request. In-service distributions are allowed, subject to certain limitations and restrictions, prior to a participants' termination of employment provided the participant has attained age 59½.

*Forfeitures* – The Plan has no forfeitures, as both employee and Employer contributions to the Plan are immediately fully vested.

**Note 2—Summary of significant accounting policies**

*Basis of Accounting* – The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of June 30, 2024 and 2023, no allowance for credit losses has been recorded. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

*Investment Valuation and Income Recognition* – Investments in the Plan are reported at fair value, except for fully benefit-responsive investments, which are reported at contract value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned. Net appreciation in fair value and contract value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Note 2—Summary of significant accounting policies (continued)**

*Risks and Uncertainties* – Investment securities in general, are subject to various risks, such as interest rate, credit, and overall market volatility. Due to the levels of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

*Benefits Paid to Participants* – Benefits paid to participants are recorded when paid.

*Administrative Expenses* – Except as discussed in Note 6, Plan administration expenses are paid by the Plan Sponsor.

*Fair Value Measurements* – U.S. GAAP describes three levels of inputs that may be used to measure fair value as follows:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Plan used appropriate valuation methodologies based on the available inputs to measure fair value of its investments. The following is a description of the valuation methodology used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

*Mutual Funds* – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is classified within Level 1 of the valuation hierarchy based on the underlying assets of the account, which are traded on an active market.

*Money Market Funds* – These investments are public investment vehicles valued using \$1 for NAV. The underlying assets are generally comprised of short-term securities representing high-quality, liquid debt, and monetary assets. The money market funds are classified within Level 2 of the valuation hierarchy.

The preceding method described above may produce a fair value calculation that may not be indicative of realizable value or reflective of future market values. The Plan believes its valuation method is appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

*Excess Contributions Payable* – The Plan is required to return contributions received during the Plan year in excess of the IRC limits. As of June 30, 2024 and 2023, there were no excess contributions payable.

**Note 3—Information certified by the qualified institution (unaudited)**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Transamerica Life Insurance Company, Inc., the qualified institution of the Plan, has certified the following data included in the accompanying financial statements and supplemental schedule of assets (held at end of year) as complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of June 30, 2024 and 2023.
- Investment interest and dividends, interest income earned on notes receivable from participants, and net appreciation in fair value and contract value of investments as shown in the statement of changes in net assets available for benefits for the year ended June 30, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of June 30, 2024.

The Plan’s independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**Note 5—Investment contracts with insurance company**

The Plan has benefit-responsive investment contracts with TLIC. TLIC maintains the contributions in general and pooled separate accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contracts are included in the financial statements at contract value as reported to the Plan by TLIC. The investment contracts are made up of a wide variety of underlying investments such as equities, preferred stock, bonds, mortgage-backed securities, derivatives, real estate, and mutual funds.

The Plan's investment in funds held in insurance company general account consists of units of Transamerica Guaranteed Investment Option. These investments aim to provide a guaranteed stream of income for life or some other fixed period of time based on accumulated savings allocated to the purchase of an annuity under these investment options. These investments have no unfunded commitments or redemption frequency restrictions. These investments may not be transferred directly to competing options. Amounts transferred out to noncompeting options are subject to a surrender charge in certain circumstances.

Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a monthly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-off of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe any events, which would limit the Plan's ability to transact at contract value with participants, are probable of occurring. The guaranteed investment contract does not permit TLIC to terminate the agreement prior to the scheduled maturity date.

**Note 6—Party-in-interest transactions**

Plan investments are shares of mutual funds, money market funds, and funds held in insurance company general account that are held by TLIC. Notes receivables from participants also qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services of TLIC, as well as participant loan fees, amounted to \$88,391 for the year ended June 30, 2024. Other indirect fees are included in net appreciation in fair value and contract value of investments within the statement of changes in net assets available for benefits.

**Note 7—Tax status**

The Plan has not obtained a determination letter from the Internal Revenue Service (“IRS”) stating the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on the IRS approval of the standardized volume submitter 403(b) plan adopted by the Plan. The IRS has determined and informed the qualified institution by a letter dated March 31, 2017 that the volume submitter 403(b) plan was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize tax liability (or assets) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of June 30, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8—Plan termination**

The School believes the Plan will continue without interruption but reserves the right to discontinue the Plan. In the event such discontinuance results in termination of the Plan, the Plan provides that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant’s respective account at the effective date of such termination. Distribution of participant account balances would occur as soon as administratively feasible upon termination of the Plan.

**Note 9—Subsequent events**

Effective April 1, 2025, the Plan merged into The Independent School Group Retirement Plan.

The School has evaluated subsequent events through April 14, 2025, which is the date the financial statements were available to be issued.
