## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of

***Basis for Opinion***

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTE A - DESCRIPTION OF PLAN**

The following description of the Chicago Historical Society Defined Contribution Pension Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General*

The Plan is a defined contribution plan that was established on July 1, 1990, which covers all eligible regular employees of the Chicago Historical Society (the Society) who have one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

*Contributions*

Participants may contribute up to 100% of pretax compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Employee rollover contributions are considered 100% vested regardless of years of service.

The amount of annual contributions made to the Plan by the Society, if any, is determined by the Board of Trustees. For fiscal year 2024, the Board of Trustees approved a contribution to the Plan based on 2% of participants' eligible earnings for 2024. These contributions were received by the Plan after each fiscal year end. Contributions are not to exceed the maximum amount deductible under the Internal Revenue Code of 1986 (IRC). Participants direct the investment of their contributions and the Society's contributions into various investment options offered by the Plan.

*Participant Accounts*

Each participant's account is credited with the participant's contributions, including rollover contributions, and the Society's contribution, if any, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are principally based on participant account balances.

*Vesting*

Participant contributions are considered 100% vested regardless of years of service. Vesting in the Society's contributions is based on years of continuous service, on a five-year graded schedule, as follows:

*Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account. The loan interest rate, which is determined annually, is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through monthly payroll deductions.

*Payment of Benefits*

The Plan provides for the distribution of participants' accounts upon normal or early retirement, disability, death or hardship. Distributions will be made in the form of a single lump-sum payment upon consent by the participant, unless a distribution is required to be made sooner under the IRC.

Upon a participant's termination of employment with the Society prior to their normal or early retirement, vested benefits will be paid in a lump sum upon consent by the participant, unless the participant's balance is less than \$5,000 and the participant does not consent within 30 days of notification.

Normal retirement is the date on which a participant attains age 65 and has completed a five-year period of service. Early retirement is permitted at age 55 or after, if a participant has completed a five-year period of service.

*Forfeited Accounts*

At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$4,497 and \$3,176, respectively. These accounts will be used to offset administrative expenses and employer contributions.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

*Use of Estimates*

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on the investments bought and sold, as well as held during the year.

*Payment of Benefits*

Benefits are recorded when paid.

*Investments*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

The Plan invests in several investment securities that are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities may occur. The changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 or 2023. Delinquent participant loans are reclassified as distributions based on the terms of the Plan agreement.

*Administrative Expenses*

Certain administrative expenses relating to the operations of the Plan, such as trustee, accounting, legal and other fees, are paid directly by the Plan. These may be allocated to participant accounts or offset by forfeitures, as permitted by the Plan.

**NOTE C - INFORMATION CERTIFIED BY TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of June 30, 2024.
- Investment (loss) income (other than other income) and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended June 30, 2024.
- The supplemental schedule of assets (held at end of year) as of June 30, 2024.
- Great West Trust Company held the Plan's investment and notes receivable from participants as shown in the statements of net assets available for benefits as of June 30, 2023.

**NOTE D - FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board (FASB) has issued guidance that defines fair value, establishes a framework for measuring fair value under current accounting pronouncements that require or permit fair value measurements, and enhances disclosures about fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the FASB guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Stable value fund - Valued at the net asset value (NAV) of units of the collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust to ensure that the securities liquidations will be carried out in an orderly business manner.

Mutual funds - Valued at the quoted NAV of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not indicate net realizable value or reflect future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - PLAN TERMINATION**

Although it has not expressed any such intent, the Society has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Society may determine, subject to the provisions under ERISA.

**NOTE F - TAX STATUS**

The IRS has determined and informed the Society by a letter dated March 31, 2014, that the Plan and the related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G - SUBSEQUENT EVENTS**

The Society evaluated the Plan's June 30, 2024, financial statements for subsequent events through April 15, 2025, the date the financial statements were available to be issued.
