Opinion

1. Description of Plan:

The following brief description of the Public Employee Supervisors' Union Dental Plan Trust ("the Plan") provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions. The final Plan agreement has yet to be executed.

General

The Plan provides several health benefits covering substantially all active members of the Public Employees Supervisors' Union ("the Sponsor"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits

The Plan provides health and welfare benefits such as dental, disability, group life and accidental insurance, hospitalization, surgical, major-medical, and optical benefits, to full-time employees of the Sponsor (with at least 1,000 hours of service each year). Participants elect levels of coverage desired and the corresponding member cost is deducted by their employer.

Current dental and disability claims are provided under group insurance contracts and some self-insurance plans. The medical benefits are provided under a self-insurance plan when applicable. Benefits are recognized when paid.

Contributions

Per the Collective Bargaining Agreement dated December 31, 2007, Essex County is to contribute the amount of \$189,720 annually. This Plan has been funded through December 31, 2024, with the amount unchanged. The Plan received this amount for the years ended June 30, 2024 and 2023. Participants contributed \$42,902 and \$43,181 for the years ended June 30, 2024 and 2023, respectively, to obtain enhanced dental benefits.

Contingencies

Loss contingencies from legal proceedings and claims may occur from a wide range of matters, including government investigations, lawsuits, product and environmental liability, contractual claims and tax matters. Accruals are recognized when it is probable that a liability will be incurred and the amount of loss can be reasonably estimated. Gain contingencies are not recognized until realized. Legal fees are expensed as incurred.

Fund termination

Although it has not expressed any intent to do so, the trustees reserve the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, the net assets of the Plan will be allocated, generally to provide benefits in the following order: All claims submitted for eligible benefits will be paid in full based upon the applicable plan payment schedule and then any remaining vendor invoices will be paid.

Basis of accounting

The Plan's policy is to prepare its financial statements on the accrual basis of accounting in accordance with generally accepted accounting principles (GAAP).

2. Summary of Significant Accounting Policies:

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Claims incurred but not reported

Actuarial present values are computed assuming annual interest of 0.0% as of June 30, 2024 and June 30, 2023. These amounts include a liability for estimated medical reimbursements. The claims incurred but not reported were \$34,850 and \$37,400 at June 30, 2024 and 2023, respectively.

Cash and cash equivalents

Cash and cash equivalents include checking accounts held at banks. The Plan considers all highly liquid debt instruments with a maturity of three months or less considered to cash equivalents. There were no cash equivalents as of June 30, 2024 or 2023.

Fair value of financial instruments

The Plan's financial assets and liabilities measured at fair value on a recurring basis consist of investments, receivables, advance from related party and accrued expenses. The carrying value amount of receivables, advance from related party and accrued expenses approximate fair value because of the short-term maturity of such investments. We have categorized our assets and liabilities that are valued at fair value on a recurring basis into a three-level fair value hierarchy in accordance with U.S. GAAP. Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets and liabilities (Level 1) and lowest priority to unobservable inputs (Level 3).

Assets and liabilities recorded in the balance sheets at fair value are categorized based on a hierarchy of inputs, as follows:

Level 1 -- Unadjusted quoted prices in active markets for identical assets or liabilities.

Level 2 -- Quoted prices for similar assets or liabilities in active markets or inputs that are observable for the asset or liability, either directly or indirectly through market corroboration, for substantially the full term of the financial instrument.

Level 3 -- Unobservable inputs for the asset or liability.

The Plan had no Level 2 or 3 assets or liabilities that were required to be valued at fair value as of June 30, 2024. See Note 7 for Level 1 investments.

3. Benefit Obligations:

Dental and disability costs incurred by participants are covered by insurance contracts. It is the present intention of the Sponsor and the Plan to continue obtaining insurance coverage for benefits. The maximum annual benefit provided for medical/optical benefits combined is \$425 for calendar year 2024 and 2023. The benefit is administered by the Plan. All administrative costs are paid by the Plan.

4. Income Taxes:

The Plan is qualified pursuant to Section 501(c)(5) of the Internal Revenue Code (IRC) and accordingly, the Plan's net investment income is exempt from income taxes. Plan management and Plan's counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, however, the Plan document has not yet been executed by the Plan's Trustees. The Plan has not been audited by the tax authorities and the tax years 2021, 2022 and 2023 are still open and subject to tax authorities' examination.

5. Concentrations and Credit Risk:

The Plan maintains various cash accounts with various financial institutions. Accounts are insured by the Federal Deposit Insurance Corporation up to \$250,000. In the normal course of business, the Trust may have deposits that exceed the insured balance. There were no uninsured cash balances at June 30, 2024 and 2023.

6. Advance from Related Organization:

The Plan received an advance from the labor organization that benefits under the Plan. The advance is non-interest bearing and has no specific repayment terms.

7. Certificates of Deposit:

Certificates of deposit, valued at fair value, at June 30, 2024 and 2023 consist of three deposits at banks and savings and loan associations, with interest rates ranging from 4.80% to 4.90% with maturities of eighteen months or less. These three deposits total \$171,647 and \$166,982, which were not in excess of federally insured limits at June 30, 2024 and 2023, respectively. These investments are considered Level 1 in the fair value hierarchy.

8. Commitments:

The Plan entered into an office usage agreement for rental of office space for a period of 12 months from October 2018 through September 2019 for a monthly usage fee of \$800. After that date the lease continued on a month to month basis for the same fee. Rent expense for both years ended June 30, 2024 and 2023 was \$9,600.

9. Fair Value Measurements:

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 "Fair Value Measurements and Disclosures", establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). All investments held by the Plan are considered level 1.

10. Parties-in-Interest Transactions:

The Plan's investments are held at Santander Bank, Flagstar Bank and Columbia Savings Bank, thus each is a party in interest. Also, certain other professionals, officers and employees of the Plan, perform administrative functions and are compensated by the Plan. Such transactions are not deemed prohibited party-in-interest transactions because they are covered by statutory or administrative exemptions from the IRS and ERISA's rules on prohibited transactions.

11. Date of Management Review and Subsequent Events:

Management has evaluated subsequent events through April 8, 2025, the date on which the financial statements were available to be issued. There were no subsequent events that were material to be disclosed or recorded in the financial statements upon the issuance of the report.
