The financial statements comprise the statement of net assets available for benefits as of June 30, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

NOTES TO FINANCIAL STATEMENTS JUNE 30, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of Carey Services, Inc. Employees Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 403(b) plan covering substantially all employees of Carey Services, Inc. (the Company). Employees are eligible to participate in the Plan on their date of hire. Participation is voluntary. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100% of eligible compensation, as defined in the Plan, but no less than \$200 and limited to a maximum as established by the Internal Revenue Service (IRS). The Plan allows eligible participants to make catch-up contributions in accordance with the IRS regulations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participants who are at least 21 years of age with at least two years of service and are active employees as of the last day of the plan year are eligible to receive the Company's matching contributions. The entry dates upon meeting the service and age requirements for the match are July 1 and January 1 of each plan year. Participants receive an employer matching contribution equal to 100% of the employee's contribution capped at a percentage of compensation detailed below.

<u>Years of service</u>	<u>Match %</u>
At least two years of service but less than 10 years of service	2.00%
At least 10 years of service but less than 20 years of service	2.50%
20 or more years of service	3.00%

The Plan also allows for additional discretionary employer contributions as determined by the Company's Board of Directors on an annual basis.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contribution and an allocation of the Company's contributions and of Plan earnings and charged with his or her withdrawals and administrative expenses, as applicable. Allocations are based on participant contributions, eligible compensation, participant account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Compensation

Participant compensation is defined by the Plan under Internal Revenue Code Section 3401(a) wages, which is generally wages subjected to withholding.

Vesting

Participants are immediately vested in their contributions and employer-matching contributions plus actual earnings thereon. Thus, employer-matching contributions are non-forfeitable.

Loans to Participants

During 2021, the Company amended the Plan to allow for loans to participants. However, the loans are not between the Plan and the participant, but rather between the custodian, Lincoln National Life Insurance Company (Lincoln) and the participant. One outstanding loan per participant is permitted and is limited to 50% of the participant's vested balance not to exceed \$50,000. Qualified Disaster Recovery Assistance loans are permitted in certain circumstances up to the lesser of \$100,000 or 100% of the participant vested balance.

The repayment period ranges from 3 to 5 years for general purpose loans and up to 20 years for loans to purchase a primary residence. The loan agreement with Lincoln requires a portion of the participant's account balance in the Plan to be transferred to a loan reserve account to serve as collateral sufficient to cover the outstanding balance in the event of default. The investments held for collateral of approximately \$34,000 and \$20,000 are included in fixed account investment contract as of June 30, 2024 and 2023, respectively. The interest rate on the loans ranges from 4.5% to 7.0% while the participant's return on the funds in the loan reserve account is 4.5%. As of June 30, 2024 and 2023, there were 8 and 6 loans outstanding due through 2029 totaling \$34,000 and \$20,000, respectively. Loan payments are made outside the Plan directly between the participant and Lincoln. Delinquent loans are reclassified as distributions based upon the terms of the plan document.

Notes Receivable from Participants

During March 2024, the Plan retained Principal Trust Company (Principal) as a custodian. With Principal, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at the prime rate, as defined. Principal and interest are paid ratably through payroll deductions each pay period. A participant may have one loan outstanding at a time.

Other Receivables

Other receivables consist of investments being transferred from Lincoln to Principal that have not fully settled in the participants' accounts as of June 30, 2024.

Payment of Benefits

Upon a participant's retirement, disability or death, a participant (or their beneficiary) is eligible to receive an amount equal to the value of the participant's vested interest in his or her account. Upon termination of service for other reasons, a participant is eligible to receive a distribution of their account balance attributable to employee contributions and earnings thereon with the remainder of their account distributable to them upon reaching age 59 ½. Benefit amounts under \$1,000 are automatically distributed to participants upon termination. Participants may elect to receive their vested account balances as a single lump sum, installment payments or as an annuity. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59 ½.

Plan Termination

Although the Company has not expressed intent to discontinue the Plan, it may do so at any time, upon resolution by Company's Board of Directors. The Plan provides that in the event of termination of the Plan, all amounts credited to the participant accounts will be paid as directed in the plan agreement and the applicable regulations.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are maintained in pooled separate accounts and represent the number of participation units owned by the Plan. The Plan values its investments at fair value for financial reporting purposes (except for fully benefit-responsive investment contracts which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Changes in fair value of investments are reflected in the statement of changes in net assets available for benefits in the year in which such changes occur. Changes in fair value of investments include the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the plan sponsor and are excluded from these financial statements. Fees related to the certain participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net change in the fair value of investments.

Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is April 14, 2025.

3. INVESTMENTS AND INFORMATION CERTIFIED BY THE PLAN'S CUSTODIANS

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln National Life Insurance Company (Lincoln) and Principal Trust Company (Principal), the custodians of the Plan, have certified to the completeness and accuracy of all investments and notes receivable from participants information reflected on the accompanying statements of net assets available for benefits as of June 30, 2024, the schedule of assets at June 30, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended June 30, 2024. Additionally, Lincoln has certified to the completeness and accuracy of all investments information reflected on the accompanying statements of net assets available for benefits as of June 30, 2023.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of June 30, 2024 and 2023:

- Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds group annuity contracts. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of these traditional investment contracts was \$1,774,347 and \$2,198,919 at June 30, 2024 and 2023, respectively.

The traditional investment contracts held by the Plan are guaranteed investment contracts. The contract issuers are contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuers but may not be less than 0.15 percent. The crediting rate is reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer.

6. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under the DOL's regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Transactions with parties-in-interest included administrative fees for the Plan's custodians, Lincoln and Principal; fees paid to the Plan's third party administrator, Trinity Pension Consultants Inc.; fees paid to the Plan's investment advisor, Wilshire Advisors LLC; and auditing fees paid to Blue & Co., LLC. Certain expenses of the Plan are paid by the plan sponsor. The Company pays the majority of expenses of the Plan, including administrative and accounting fees. These expenses qualify as party-in-interest transactions.

7. TAX STATUS

The Plan is based on a volume submitter 403(b) plan which has received a favorable opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017, that states the volume submitter plan is designed to qualify as being exempt from Federal income taxes. The Plan administrator has not separately applied for a determination letter from the IRS. However, the Plan sponsor believes that the Plan was designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, no income taxes have been provided.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. Management has concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements.

The Plan is subject to routine audits by taxing jurisdictions. However, as of the date the financial statements were available to be issued, there were no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. ACCOUNTING RECORDS

The Plan has not maintained sufficient accounting records and supporting documentation with regard to certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009. As such, the extent to which the financial statements have been affected as a result of the exclusion of these custodial accounts and annuity contracts, if any, has not been determined.
