Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Bedford Stuyvesant New Beginnings Charter School 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). 1. Description of Plan

The following description of Bedford Stuyvesant New Beginnings Charter School 401(k) Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all the employees of Bedford Stuyvesant New Beginnings Charter School (the “Employer”). Employees who are 21 years or older are eligible to participate in the Plan upon their date of hire. Entry dates for employees are the first day of each month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute up to 100% of their eligible compensation on a pre-tax or after-tax (Roth) basis, subject to the limitations established by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into the various investment options offered by the Plan.

The Employer makes a safe harbor matching contribution equal to 100% of each participant’s elective deferrals not to exceed 6% of the participant’s eligible compensation. The Employer may make a discretionary additional matching contribution to the Plan. The amount will be based upon years of service. For those participants with at least 3 years of service but less than 5, the matching contribution will be made on elective deferrals that are in excess of 6% of compensation but less than 7%. For participants with 5 years of service or more, the matching contribution will be made on elective deferrals that are in excess of 7% of compensation but no more than 10%. No Employer discretionary contribution was made for the June 30, 2024, plan year.

Vesting

Participants are immediately vested in their contributions, Employer safe harbor matching contributions, discretionary employer matching contribution, plus actual earnings thereon.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Employer’s contribution and (b) Plan earnings and losses thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. All investments are participant directed.

1. Description of Plan (continued)

Payment of Benefits

Participants are eligible to receive benefit payments when they terminate service or reach age 59 ½. Upon termination of service, a participant may elect to receive a distribution in the amount equal to the participant's vested interest in their account. Benefit payments are also permitted for death, disability and hardship.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. The loans bear interest at prime rate as published in the Wall Street Journal and are secured by the participant's account. Principal and interest are repaid through payroll deductions in equal payments over the term of the loan (up to five years). A participant may have no more than one outstanding loan from the Plan at any time.

Expenses

Certain expenses related to maintaining the Plan are paid by the Employer and are excluded from these financial statements. Any expenses not paid by the Employer are paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. As of June 30, 2024 and 2023, all of the Plan's investments were valued using level 1 inputs.

2. Summary of Significant Accounting Policies (*continued*)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The mutual funds and money market fund are valued at the daily closing price as reported by the fund. The mutual funds and money market fund held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the plan year.

Notes Receivable from Participants

Participants loans are measured at their unpaid principal balance plus any accrued unpaid interest and are classified as notes receivable from participants. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded as deemed distribution.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is April 11, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at June 30, 2024 and 2023, and the net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company, a qualified institution.

4. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

5. Tax Status

The Internal Revenue Service (“IRS”) has determined and informed the volume submitter preparer by a letter dated June 30, 2021, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. Although the Plan has been amended since receiving the letter, the plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

6. Party-in-Interest Transactions

All the Plan’s investments are managed by American Funds a subsidiary of Capital Group Retirement Plan Services. Capital Group Retirement Plan Services is the record-keeper for the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

7. Non-Exempt Party-in-Interest Transactions

During the plan year end June 30, 2024, certain participants’ contributions and loan repayments totaling \$60,061 were remitted by the Employer to the Plan later than required by Department of Labor Regulation 2510.3-102. Pursuant to the guidance issued by the Department of Labor, lost earnings were calculated and contributed to the Plan for affected participants by the Employer.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

8. Risks and Uncertainties (*continued*)

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to June 30, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.





1. Description of Plan

The following description of Bedford Stuyvesant New Beginnings Charter School 401(k) Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all the employees of Bedford Stuyvesant New Beginnings Charter School (the “Employer”). Employees who are 21 years or older are eligible to participate in the Plan upon their date of hire. Entry dates for employees are the first day of each month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute up to 100% of their eligible compensation on a pre-tax or after-tax (Roth) basis, subject to the limitations established by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into the various investment options offered by the Plan.

The Employer makes a safe harbor matching contribution equal to 100% of each participant’s elective deferrals not to exceed 6% of the participant’s eligible compensation. The Employer may make a discretionary additional matching contribution to the Plan. The amount will be based upon years of service. For those participants with at least 3 years of service but less than 5, the matching contribution will be made on elective deferrals that are in excess of 6% of compensation but less than 7%. For participants with 5 years of service or more, the matching contribution will be made on elective deferrals that are in excess of 7% of compensation but no more than 10%. No Employer discretionary contribution was made for the June 30, 2024, plan year.

Vesting

Participants are immediately vested in their contributions, Employer safe harbor matching contributions, discretionary employer matching contribution, plus actual earnings thereon.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Employer’s contribution and (b) Plan earnings and losses thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. All investments are participant directed.

1. Description of Plan (continued)

Payment of Benefits

Participants are eligible to receive benefit payments when they terminate service or reach age 59 ½. Upon termination of service, a participant may elect to receive a distribution in the amount equal to the participant's vested interest in their account. Benefit payments are also permitted for death, disability and hardship.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. The loans bear interest at prime rate as published in the Wall Street Journal and are secured by the participant's account. Principal and interest are repaid through payroll deductions in equal payments over the term of the loan (up to five years). A participant may have no more than one outstanding loan from the Plan at any time.

Expenses

Certain expenses related to maintaining the Plan are paid by the Employer and are excluded from these financial statements. Any expenses not paid by the Employer are paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. As of June 30, 2024 and 2023, all of the Plan's investments were valued using level 1 inputs.

2. Summary of Significant Accounting Policies (*continued*)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The mutual funds and money market fund are valued at the daily closing price as reported by the fund. The mutual funds and money market fund held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the plan year.

Notes Receivable from Participants

Participants loans are measured at their unpaid principal balance plus any accrued unpaid interest and are classified as notes receivable from participants. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded as deemed distribution.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is April 11, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at June 30, 2024 and 2023, and the net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company, a qualified institution.

4. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

5. Tax Status

The Internal Revenue Service (“IRS”) has determined and informed the volume submitter preparer by a letter dated June 30, 2021, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. Although the Plan has been amended since receiving the letter, the plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

6. Party-in-Interest Transactions

All the Plan’s investments are managed by American Funds a subsidiary of Capital Group Retirement Plan Services. Capital Group Retirement Plan Services is the record-keeper for the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

7. Non-Exempt Party-in-Interest Transactions

During the plan year end June 30, 2024, certain participants’ contributions and loan repayments totaling \$60,061 were remitted by the Employer to the Plan later than required by Department of Labor Regulation 2510.3-102. Pursuant to the guidance issued by the Department of Labor, lost earnings were calculated and contributed to the Plan for affected participants by the Employer.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

8. Risks and Uncertainties (*continued*)

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to June 30, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
