### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2023 Financial Statements***

We have performed audits of the financial statements of the 403(B) Thrift Plan for Employees of Person Centered Care Services, Inc., (the Plan) an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## 1. Description of Plan

The following description of the 403(B) Thrift Plan for Employees of Person Centered Care Services, Inc. (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

### *Plan amendment*

Effective December 1, 2023, the Plan was amended and restated, and a new custodian, administrator and record keeper were appointed. The name of the plan was changed from 403(B) Thrift Plan of Person Centered Care Services, Inc. to the 403(B) Thrift Plan for Employees of Person Centered Care Services, Inc. The plan sponsor elected to implement a process called “mapping”, through which account balances from the former plan custodian and administrator were transitioned to new investment options at the new administrator that have similar risk and reward characteristics. After the transition period, participants had an opportunity to change their future allocations to their own investment choices. The conversion initiated a blackout period beginning December 4, 2023 and continuing through December 20, 2023. During this period, funds could not be applied to the employee selected funds with the custodian or withdrawn from the plan until the custodian could accurately complete the conversion.

### *General*

The Plan is a defined contribution plan sponsored by Person Centered Care Services, Inc. (the “Sponsor”). All permissible employees of the Sponsor, as defined in accordance with the universal applicability standards, are eligible to enroll on their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

### *Contributions*

Participants may contribute up to 100% of pretax annual compensation, as defined by the Plan. Participants who have attained the age of 50 may also make catch-up contributions to the Plan. Special Internal Revenue Code Section 403(b) catch-up contributions are permitted as well, if a participant has 15 years of service. In no event may a participant’s contributions exceed any statutory limitations. Participants direct the investment of their contribution into various investment options offered by the Plan.

The Plan sponsor can elect to contribute to the Plan on behalf of eligible employees. Employees eligible for an employer contribution are those that are (i) 21 years of age; (ii) have a minimum of one year of service with the Plan sponsor; and (iii) have completed 1,000 hours of service. For the years ended June 30, 2024 and 2023, the Organization made a contribution of \$13,500 and \$12,988, respectively.

## ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocation of plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon.

The amounts in a participant's employer contribution account shall be 100% vested upon the attainment of Normal Retirement age, or earlier, upon meeting the applicable vesting requirements as detailed below:

## ***Investment Options***

Upon enrollment in the Plan, the participant may direct their contributions in any of a multitude of investment options featuring an interest accumulation account as well as various equity and debt mutual funds.

## ***Payment of Benefits***

Upon termination of service, a participant may elect to receive the vested value of their account in a lump-sum or periodic installments as described in the plan document. In addition, the Plan provides for participant withdrawals in the event of hardships, as defined in the plan document. In service withdrawals are permitted beginning at age 59.5, and are also permitted for hardship, disability or a deemed severance distribution.

## ***Participant Loans***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans bear interest at 9.50% and 3.25% as of June 30, 2024 and 2023, respectively, which are commensurate with local prevailing rates by the plan administrator. Principal and interest is paid ratably through bi-weekly payroll deductions. Terms range from one to five years or greater for the purchase of a primary residence. As of June 30, 2024 and 2023, \$9,426 and \$3,724, respectively, of participant loans were outstanding.

## ***Forfeited Accounts***

At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$308 and \$716, respectively. Beginning in fiscal year 2024, these accounts will be used to reduce nonelective contributions, matching contributions, and pro-rata based contributions.

## **2. Summary of Significant Accounting Policies**

### ***Method of Accounting***

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United State of America.

## ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## ***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchase and sales of securities are reflected on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

## ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

## ***Payment of Benefits***

Benefits are recorded when paid.

## ***Expenses***

Certain expenses of the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

## ***Subsequent Events***

The Plan has evaluated subsequent events through April 14, 2025, the date on which these financial statements were available to be issued.

## **3. Information Certified by Trustee (Unaudited)**

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, The Voya Retirement Insurance and Annuity Company, the custodian of the Plan, has certified to the completeness and accuracy of all investments reporting in the accompanying Statement of Net Assets Available for Benefits as of June 30, 2024 and the supplemental Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of June 30, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended June 30, 2024.

Mutual of America Life Insurance Company, the former custodian of the Plan, has certified to the completeness and accuracy of all investments reporting in the accompanying Statement of Net Assets Available for Benefits as of June 30, 2023.

## **4. Fair Value Measurements**

FASB ASC 820 established a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

## ***Fixed Account***

Voya's Fixed Account is a fixed-interest investment option available within Voya's retirement programs that guarantees a minimum rate of interest and may credit interest that exceeds the minimum guaranteed rate. Guarantees are based on the claims-paying ability of Voya Retirement Insurance and Annuity Company. The estimated fair value represents deposits made into the account, plus earnings at crediting rates established by the Investment Company; less withdrawals and fees, if any. Fair value approximates cost. The interest rate credited to the investments in the account is a current rate and is not dependent upon the length of time the assets are invested with the Investment Company. Requests for withdrawal can be made at any time and are processed on the day that they are received. There are no deferred sales charges, load assessments or interest rate adjustments that would affect the value as a result of a withdrawal request.

## *Mutual Funds*

Mutual funds are valued at the daily closing prices as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **5. Rollover Contributions**

Rollover contributions are allowed to be made to the Plan. There were rollover contributions of \$-0- and \$30,599 for the years ended June 30, 2024 and 2023, respectively.

## **6. Related Party and Party in Interest Transactions**

Certain plan investments are shares of mutual funds managed by The Voya Retirement Insurance and Annuity Company. The Voya Retirement Insurance and Annuity Company is the trustee as defined by the plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the plan for the investment management services are included in the net appreciation in fair value of investments. Additionally, the plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

## **7. Plan Administration**

Employees of the Sponsor perform certain administrative functions for the Plan. No such employee receives compensation from the Plan. In addition, certain administrative expenses for the Plan are paid directly by the Sponsor.

## **8. Administration of Plan Assets**

The Plan's assets are administered under a contract with The Voya Retirement Insurance and Annuity Company, the custodian of the Plan. The custodian invests funds received from contributions, investment sales, interest and dividend income and makes distribution payments to participants.

## **9. Plan Termination**

Although it has not expressed any intention to do so, the Sponsor reserves the right to terminate the Plan at any time, subject to the provision of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

## **10. Tax Status**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The terms of the Plan have been prepared to conform to the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. The Plan administrator intends to apply for a determination letter once the IRS opens such a program. The Plan is required to operate in conformity with the IRC to maintain its tax-exempt status for plan participants under Section 403(b). Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax position taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain income tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **11. Risks and Uncertainties**

The Plan provides for various investment options in combinations of mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

As of June 30, 2024 and 2023, the Plan had investments of \$585,331 which were concentrated in five funds, and \$512,417 which were concentrated in six funds, respectively.

## **12. Prohibited Transactions**

During fiscal year 2023, the Sponsor failed to remit certain employee contributions totaling \$16,207 within the time frame required by the Department of Labor under the plan asset rules. The Sponsor will make contributions to the affected participants' accounts to compensate those participants for potential lost income due to the delays.
