Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Abilis, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 – DESCRIPTION OF PLAN

The following description of Abilis, Inc. (Company) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of the Company. Employees who have attained age 21 and have completed six consecutive months of eligible service with at least 500 service hours are eligible to contribute to the Plan and to receive safe harbor employer matching contributions. In addition, employees who have completed one year of service with at least 1,000 service hours and are employed on the last day of the Plan year are eligible to receive discretionary employer profit sharing contributions. The profit sharing contribution excludes per diem employees and individuals in a rehabilitation program with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan. The plan administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Directors.

Contributions

Plan participants may make pre-tax and Roth salary reduction contributions to the Plan, subject to contribution limits under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions in accordance with the IRC. Participants may also contribute amounts representing distributions from certain other eligible retirement plans (rollover), in accordance with the Plan Document.

The Company elected to make a safe harbor contribution during the 2024 plan year. The contribution was allocated to all eligible employees calculated as 4% of their eligible compensation. For year ended June 30, 2024, the safe harbor amount contributed by the Company was \$316,557.

The Company may make discretionary profit-sharing contributions to the Plan. For the year ended June 30, 2024, the Company elected to make a discretionary profit-sharing contribution of \$1,281,516. The contribution was allocated to all eligible employees, calculated as 10% of their eligible compensation, less the \$316,557 safe harbor matching contributed, noted above.

Participant Accounts

Participants direct the investment of contributions to their accounts into various investment options by the Plan within Voya Retirement Insurance and Annuity Company's (Voya) pooled separate accounts. Participants may also elect to maintain their investment in Voya's general account, which provides a guaranteed rate of interest.

Each participant's account is credited with the participant's and the Company's contributions and Plan earnings or loss from the investments.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and employer safe harbor contributions, plus actual earnings thereon. Vesting in the Company's profit sharing contribution portion of their accounts is based on years of continuous service. Participants vest in the Company's profit-sharing contributions plus earnings thereon according to the following schedule:

If a participant terminates employment before becoming 100% vested, the non-vested balances are forfeited. Participants become fully vested in profit-sharing contributions made by the Company, without regard to years of service, upon death or disability. Under the terms of the Plan, participants are eligible to receive vested amounts upon reaching retirement.

Notes Receivable from Participants

Participants may receive loans of up to 50% of their vested account balances. Amounts may be borrowed between \$1,000 and \$50,000, utilizing the participant's remaining account balance as security for the loan. The interest rate for the loan is calculated using the prime rate per the Wall Street Journal plus 1%. Loans must be repaid through payroll deductions within five years. Participants who do not repay their loans under certain circumstances, as defined in the Plan, will be deemed to have received a distribution for federal income tax purposes under the Plan.

Hardship Withdrawals

In the event of financial hardship, as defined under the Plan and under current Internal Revenue Service regulations, participants are permitted to receive hardship withdrawals of a portion of their vested account balance.

Payments of Benefits

On separation of service due to death, disability, retirement, or termination, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a rollover distribution paid directly to an eligible retirement plan. Various terminated participant account balances are included in the Plan as of the end of each Plan year and may be distributed in accordance with the Plan's procedures.

Forfeited Accounts

The Plan instrument provides that the plan administrator may apply forfeited non-vested accounts of terminated participants against the amount of the employer contribution that is payable to the Plan. The plan administrator may first, at their discretion, utilize the forfeitures to pay Plan expenses or to restore the non-vested accounts of prior terminated participants who return to the Company in certain circumstances as defined in the Plan.

At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$29,682 and \$14,198, respectively. The Company allocated forfeitures of \$12,887 to individual participants based on each participant's compensation during the Plan year ended June 30, 2024.

NOTE 2 – ORGANIZATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Summary of Significant Accounting Policies:

Basis of Accounting and Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Employer Contribution Receivable

Employer contribution receivable is measured at the amount owed to participants by the Company at June 30, 2024 and 2023.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of June 30, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan agreement.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 6 for discussion of fair value measurements and Note 7 for discussion of the contract with the insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) of the fair value of investments includes the Plan's gains and (losses) on investments bought and sold as well as held during the year.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Expenses incurred for the administration of the Plan are the responsibility of the Plan. If incurred directly by the Plan, these expenses are included in administrative expenses on the statement of changes in net assets available for benefits. Other investment related expenses are included in the change in fair value of investments. Certain other expenses of the Plan are deducted from the Plan participants' accounts, which include administrative fees for participant specific benefit payments for withdrawals and loan requests, and annual loan maintenance fees. Participants participating in the Investment Management program are charged a quarterly service fee. Internal expenses within the various investment funds which the participants are invested in are offset against the participants' investment returns.

NOTE 3 – TAX STATUS

The Plan is based on the Non-Standardized Defined Contribution Pre-Approved Plan of Employee Benefit Compliance Services Inc., which received a determination letter from the IRS dated June 30, 2020, stating that the Plan was designed in accordance with the provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since the effective date of the determination letter, the plan administrator believes the Plan is qualified and the related trust is tax-exempt based on the advice of the Plan's third-party administrator.

Tax Status, Continued

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 – RISKS AND UNCERTAINTIES

The Plan participants invest in various investment options offered by the Plan. Investment options offered in the Plan are subject to various risks, such as interest rate, market value and credit risks. Market risks include global events which could impact the value of investment securities, such as political changes, pandemics, international conflicts or financial institution collapses. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 5 – INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to be as complete and accurate by Voya Retirement Insurance and Annuity Company, an insurance company holding and administering Plan investments, as permitted by the election made by the plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

NOTE 6 – FAIR VALUE OF FINANCIAL ASSETS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). - inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Pooled Separate Accounts: Pooled separate accounts invest directly in designated mutual funds. The Plan and participants hold units of participation in the separate account. The fair value of the pooled separate accounts is determined based on the accumulation unit value (AUV) multiplied by the number of units held. The AUV is established when a new fund starts (typically at \$10.00) and is then determined daily based on the quoted net asset values of the shares of the underlying mutual funds, mutual funds dividends, and the contract's separate account changes.

NOTE 7 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds a portfolio of investment contracts that comprises a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract; plus earnings, less participant withdrawals and administrative expenses. The following represents the disaggregation of contract value between types of investment contracts held by the Plan.

For traditional investment contracts, the Plan owns only the contract itself. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and may change and be higher or lower than the previously identified rate but is guaranteed not to be less than 1.0%. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The following events might limit the ability of the Plan to transact at contract value with the contract issuer:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, the following events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

NOTE 8 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Voya Retirement Insurance and Annuity Company, as the investment custodian of the Plan, is a party-in-interest as defined under ERISA. All fees for their services are paid by the employer and participants.

Morningstar Investment Management LLC, as an affiliate of Voya that provides investment management services, is a party-in-interest as defined under ERISA. All fees for their services are paid by the participants.

Devlin & Hale Associates, Inc., as the third-party administrator for the Plan for compliance testing and annual report preparation, is a party-in-interest as defined under ERISA. All fees for their services are paid by the employer and participants.

Notes receivable from participants totaled \$624,012 and \$553,314 at June 30, 2024 and 2023, respectively, and interest income on notes receivable from participants totaled \$38,654 for the year ended June 30, 2024.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 9 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 10 – SUBSEQUENT EVENTS

Formal Amendment

Effective July 1, 2024, the Plan was formally amended to change the amount of outstanding loans from 4 to 2.

Change of Custodian/TPA

During 2025, the Plan switched from Voya Retirement Insurance and Annuity Company and from Devlin & Hale Associates, Inc. to Fidelity Management Trust Company.

Evaluation of Subsequent Events

Subsequent events have been evaluated through the audit report date, the date the financial statements were available to be issued.
