1. Description of Plan

The following description of the Allegro School Defined Contribution Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General Information

The Plan, which became effective on April 1, 1992, is a defined contribution retirement plan covering substantially all eligible employees of the Allegro School, Inc. (the “School”). The Plan is a non-contributory plan; contributions are solely discretionary from the School. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Plan management is responsible for oversight of the Plan. The trustee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s management.

Plan Amendments

Effective January 1, 2015, the Plan was amended and restated to provide for only non-elective discretionary employer contributions based on the performance of the School. Effective December 31, 2020, the Plan was amended for the provisions of the Coronavirus Aid, Relief, and Economic Security Act (the “CARES Act”).

Administration of the Plan

The general administration of the Plan and the responsibility for carrying out its provisions shall be placed on the Allegro School, Inc. The School shall be the Plan Administrator, and has the authority to appoint or remove the trustee. The School has engaged the services of an independent profit sharing and pension plan administration firm to assist it with the performance of its duties. Teachers Insurance and Annuity Association (TIAA) and the College Retirement Equity Fund (CREF), serves as trustee and custodian of the Plan (the “Trustee”) and Planned Retirement Consultants and Administrators serves as a third-party administrator to the Plan.

The School has entered into a trust agreement with the Trustee providing for the establishment of a trust to which all employer contributions shall be contributed and from which all benefits under the Plan shall be paid. The Trustee values all accounts on each measurement date.

Eligibility

Employees of the School can participate in the Plan once they are deemed eligible and have completed two years of service and attained age 21. All employees, including part time and temporary, will not be eligible for employer contributions until they have completed 1,000 hours of service during a 12 consecutive calendar month period. Such employees are eligible to participate in the Plan the first day of the subsequent month following the satisfaction of the eligibility requirements.

Contributions

The School may elect to make a discretionary contribution amount, which amount, if any, shall be a nonelective contribution, not to exceed the limits imposed by Section 415(c) integrated with section 403(b) of the Internal Revenue Code.

Participants direct the investment of the employer contributions made to their account into various investment options offered by the Plan. The Plan currently offers a guaranteed fixed annuity contract, a pooled separate account, and various mutual funds as investment options for participants. The School elected to make discretionary contributions in the amount of \$178,070 and \$0 for the years ended June 30, 2024 and 2023, respectively.

The Plan does not permit rollover contributions into the Plan.

Participant Accounts

Each participant's account is credited with an allocation of the School's discretionary contribution, if any, and the Plan's earnings or losses. Allocations are based on each participant's earnings, account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully and immediately vested in amounts attributable to plan contributions once they are made plus actual earnings thereon, therefore there are no forfeitures.

Payment of Benefits

No distributions from the Plan are made until participants retire, die (in which case, payments are made to their named beneficiary, or if none, their legal representative), or otherwise terminate employment with the School. Benefits are payable only as annuity income for at least the participant's lifetime except to the extent that provision for the Retirement Transition Benefit and repurchase as described in the Plan document may apply. The Plan does not provide for payment of benefits in relation to disability.

During fiscal year ended June 30, 2020, participants of the Plan were allowed to receive coronavirus-related distributions. Pursuant to section 2202 of the CARES Act, coronavirus-related distributions are defined as any distribution from an eligible retirement plan made on or after January 1, 2020, and before December 31, 2020, to a qualified individual. Participants of the Plan who met certain qualifications, as described in section 2202 of the CARES Act, were deemed qualified individuals and eligible to receive a coronavirus-related distribution.

Prior to the passing of the CARES Act, the Plan did not permit participant loans, in-service withdrawals or hardship distributions. However, for the Plan to be treated as operating in accordance with its terms, the Plan was amended to reflect the provisions of the CARES Act effective December 31, 2020.

2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements are prepared on the accrual basis of accounting and present the net assets available for benefits and the changes in net assets available for benefits of the Plan in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The investment contract held by the Plan is a non-benefit responsive investment contract. The Statement of Net Assets Available for Benefits presents the fair value of the investment contract. The Statement of Changes in Net Assets Available for Benefits is prepared using the fair value basis for a non-benefit responsive investment contract.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and contingent liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at estimated fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The School determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The TIAA Traditional Annuity is a guaranteed fixed annuity offered to participants in employer-sponsored retirement plans and Individual Retirement Accounts (IRAs) through a contract with TIAA, an insurance company. Participants who choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid.

The participant's principal, plus a specified rate of interest, is guaranteed by TIAA's claims paying ability. TIAA Traditional Annuity also provides an opportunity for participants to receive additional amounts, which the TIAA Board of Trustees may declare on a year-by-year basis.

These additional amounts, when declared, remain in effect for the 12-month “declaration year” that begins each March 1 for accumulating annuities and January 1 for lifetime payout annuities; they are not guaranteed for future years.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the School and are excluded from these financial statements. Investment related expenses are a reduction of investment income presented on the statement of changes in net assets available for benefits.

Subsequent Events

The Plan’s administrator has reviewed subsequent events and transactions that occurred after June 30, 2024 through the date of the independent auditors’ report and the date the financial statements were available to be issued, February 24, 2025. The financial statements include all events or transactions, including estimates, required to be recognized in accordance with generally accepted accounting principles. Management has determined that there are no non-recognized subsequent events that require additional disclosure.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual funds - investments in registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate account: These accounts invest in securities which generally have publicly quoted prices which are used in determining the net asset value of the pooled separate account. The NAV, as provided by the trustee, is the basis for current transactions and can be redeemed at NAV as of the measurement date. Therefore, these investments have a readily determinable fair value.

While the underlying asset values are quoted prices, the net asset value of a separate account is not publicly quoted. Pooled separate accounts are an accounting entity rather than a legal entity. Separate accounts are credited with the income, gains or losses resulting from the assets allocated to that specific account only. The return on separate accounts is not guaranteed as the value of an interest in a separate account increases or decreases based on the value of the assets held in the separate account. Each plan that invests in the pooled separate accounts obtain units of participation in the pooled account and through those units of participation, share in the gains and losses of all investments in the pooled account. Pooled separate accounts can be redeemed on a daily basis.

Guaranteed fixed annuity contract: Guaranteed fixed annuity contracts are valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer (see Note 5). Because the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only. In determining the reasonableness of the methodology, the School evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. In estimating fair value of the investments in level 3, management may use third-party pricing sources or appraisers. In substantiating the reasonableness of the pricing data provided by third parties, management evaluates a variety of factors including review of methods and assumptions used by external sources, recently executed transactions, existing contracts, economic conditions, industry and market developments, and overall credit ratings.

5. Guaranteed Fixed Annuity Contract with Teachers Insurance and Annuity Association

The Plan entered into a guaranteed fixed annuity contract (the “contract”) with Teachers Insurance and Annuity Association (“TIAA”). Participants who choose to allocate a portion of their retirement savings to the contract make contributions that purchase a specific guaranteed minimum amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant’s principal, plus a specified rate of interest, are guaranteed. TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and transfers.

The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan. The contract provides a guarantee of principal, a guaranteed minimum interest rate between 1% and 3% and the potential for additional interest, if declared by TIAA.

Because the guaranteed investment contract is non-benefit responsive, fair value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at fair value. The fair value of the guaranteed investment contract represents contract value adjusted to reflect current market interest rates only to the extent such market interest rates exceed the crediting rates.

Fair value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals and transfers. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at the fair value. There are no reserves against fair value for credit risk of the contract issuer or otherwise. The fair value of the fixed annuity contract at June 30, 2024 and 2023 was \$1,878,820 and \$1,799,422, respectively. The crediting interest rate is based on a formula agreed upon with the issuer and reviewed on an annual basis for resetting.

6. Related-Party Transactions and Party in Interest Transactions

Plan investments are managed by TIAA-CREF. TIAA-CREF is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan Sponsor pays directly any other fees related to the Plan's operations.

7. Plan Termination

Although it has not expressed any intent to do so, the School has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Participants are fully and immediately vested in amounts attributable to plan contributions once they are made plus actual earnings thereon. Each participant is entitled to full distribution of such amounts.

8. Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The terms of the Plan have been prepared to conform with the sample language provided by the Internal revenue Service (IRS) in Revenue Procedure 2007-71. The Plan administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment funds. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. Other Payable

Other payable in the amount of \$7,000 at June 30, 2024 and 2023, respectively consists of amounts owed to the Allegro School Tax-Deferred Annuity Plan. During the years ended June 30, 2023 and 2022, contributions of \$4,000 and \$3,000, respectively intended for the School's Tax Deferred Annuity Plan were incorrectly deposited in the Plan's assets within the Defined Contribution Retirement Plan.
