### Report on the Financial Statements

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Partnership Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

### (1) DESCRIPTION OF PLAN

The following description of the Partnership Retirement Plan (“*Plan*”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### A. General

The Plan is a defined contribution plan covering substantially all employees of Partnership for Community Supports (“*Partnership*”). The Plan was adopted July 1, 2004. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (*ERISA*). All employees who have attained the age of 18 are eligible to participate in the Plan.

#### B. Contributions

The Plan provides for employer and employee contributions. The Plan documents stipulate that Partnership may elect to make matching contributions to the Plan. Partnership will contribute a fixed amount equal to 25% of the participant’s elected deferrals up to 10% of the participant’s compensation on a per pay basis and an additional 3% of employee earnings on a per pay basis.

Eligible participants can elect to defer any amount of their salary up to the maximum allowable deferral. For plan year ended June 30, 2024, the maximum allowable elective deferral was \$23,000. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

#### C. Participants Accounts

Each participant’s account is credited with the participant’s contribution, the Plan’s match, and allocation of the Plan’s earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### D. Vesting

Participants are immediately vested in their contributions, rollover contributions and actual earnings thereon. Vesting in the Organization contribution is based on years of continuous service. A participant with two years of service is 25% vested in the employer contribution portion of the account. Each year, a participant gains another 25% vesting until the participant is 100% vested after the fifth year of credit service.

#### E. Participant Loans

The Plan permits participants to borrow funds against vested account balances. In general, the maximum amount that can be borrowed is the lesser of 50% of a participant’s vested interest or \$50,000, at a reasonable rate of interest. Loans are generally repaid within five years. Interest is charged at the prime rate plus 1% which is set upon the date the loan agreement is executed.

#### F. Investment Options

Upon enrollment in the Plan, and at any time during the plan year, a participant may direct all future employee and employer contributions into any of the investment options available under the Plan.

### G. Payment of Benefits

A participant's vested benefits will normally be distributed to the participant or the participant's beneficiary upon retirement, disability or death of the participant, by transfer to another qualified plan or individual retirement account, through a lump sum distribution or in installment payments.

In-service withdrawals of all or a portion of a participant's vested account balance may be made by participants who have attained the age of 59-1/2. Hardship withdrawals from a participant's deferral contribution accounts are permitted when certain criteria are met. In-service withdrawals of all or a portion of a participant's rollover account balance may be withdrawn at any time.

### H. Administration

Partnership is the administrator of the Plan. Empower Retirement has been designated as the custodian and trustee of the Plan. Empower Retirement maintains individual participant account records and advises the Plan on other matters related to the operation of the Plan. Admin Partners serves as the third-party administrator for the Plan.

### G. Forfeitures

Forfeitures resulting from the non-vested portions of participants' accounts who terminate prior to being fully vested are used to reduce future Partnership contributions. During the years ended June 30, 2024 and 2023, employer contributions were reduced by \$26,700 and \$26,200, respectively, from forfeited non-vested accounts.

## (2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### ***BASIS OF ACCOUNTING***

The financial statements of the Plan are prepared under the accrual basis of accounting.

### ***INVESTMENT VALUATION AND INCOME RECOGNITION***

The Plan's investments in mutual funds and the guaranteed fixed fund are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

### ***PAYMENT OF BENEFITS***

Benefits are recorded when it has been determined that a distribution will be made.

### ***OPERATING EXPENSES***

Partnership pays costs associated with maintaining and administering the Plan.

### ***USE OF ESTIMATES***

The preparation of the financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

### (3) INVESTMENTS

The Plan's investments are held in participant directed fixed and variable annuities. The variable annuities are held in the insurance company's pooled separate accounts. Within these accounts, there are several investment options available to the participants. Participant accounts are allocated based on the decisions of the individual participants. The following table presents the market value of these investments at June 30.

### (4) FAIR VALUE OF FINANCIAL INSTRUMENTS

The Plan utilized various methods to measure the fair value of its investments on a recurring basis. Generally accepted accounting principles establish a hierarchy that prioritizes inputs to valuation methods. The three levels of inputs are described below:

Level 1 – Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 – Observable inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly. These inputs may include quoted prices for the identical instrument on an inactive market, prices for similar instruments, interest rates, prepayment speeds, credit risk, yield curves, default rates and similar data.

Level 3 – Unobservable inputs for the asset or liability, to the extent relevant observable inputs are not available, representing the Plan's own assumptions about the assumptions a market participant would use in valuing the asset or liability, and would be based on the best information available.

The inputs methodology used for valuing securities are not necessarily an indication of the risk associated with investing in those securities.

There were no transfers between Level 1 and Level 2 during the years ended June 30, 2024 and 2023.

The fair value of the mutual funds (variable annuities) is classified as Level 2 as these investments are based on the quoted market price of the underlying mutual fund adjusted for an expense factor as disclosed in the respective annuity contract. The guaranteed fixed fund held in the insurance company's general account (unallocated contract) is classified as Level 2 based on the fair value being determined by discounting the related cash flows based on current yields of similar investments with comparable durations considering the credit-worthiness of the issuer.

### (5) GUARANTEED INVESTMENT CONTRACT WITH GREAT-WEST LIFE & ANNUITY INSURANCE COMPANY

The Plan has a guaranteed fixed fund, a non-fully benefit responsive fixed income annuity contract, with Great-West Life & Annuity Insurance Company ("*Great-West*"). Great-West maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed fixed fund issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan.

The guaranteed fixed fund is presented on the face of the statement of net assets available for benefits at fair value. The annuity contract value, as reported to the plan by Great-West, represents contributions made under the annuity contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment.

There are no reserves against the annuity contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract at June 30, 2024 and 2023 was approximately \$312,000 and \$306,500, respectively. The crediting interest rate as of June 30, 2024 and 2023 and for the years then ended was 3.50%.

Certain events limit the ability of the plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the plan's ability to transact at contract value with participants are probable of occurring.

### **(6) PLAN TERMINATION**

Although it has not expressed any intent to do so, Partnership has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **(7) TAX STATUS**

The Plan, established under a prototype plan to hold the Plan's assets, is qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the Plan's net investment income is exempt from income taxes. Although the Plan has been amended, the Plan sponsor believes that the Plan continues to qualify and to operate as designed.

Management has reviewed the tax positions for each of its open fiscal tax years (2021 – 2023) or expected to be taken in the Plan's fiscal year 2024 tax return and has concluded that there are no uncertain tax positions that would require recognition in the financial statements.

### **(8) RISKS AND UNCERTAINTIES**

The Plan invests in shares of registered investment companies which employ various investment strategies. The investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **(9) PARTY-IN-INTEREST TRANSACTIONS**

Certain administrative costs of the Plan are paid by the employer/sponsor.

### **(10) SUBSEQUENT EVENTS**

Subsequent events after the statement of net assets available for benefits date through the date that the financial statements were available for issuance, April 15, 2025 have been evaluated in the preparation of the financial statements and management has determined that there were no subsequent events that would require disclosure or adjustment in the financial statements.
