Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 401(k) Profit-Sharing Plan for Employees of Arundel Lodge, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the 401(k) Profit-Sharing Plan for Employees of Arundel Lodge, Inc. (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

Income Tax Status

The Internal Revenue Service has determined and informed the Employer by letter dated March 31, 2008, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Subsequent to this issuance of the determination letter, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan's informational return filings are subject to audit by the Internal Revenue Service, generally for three years after filing.

General: The 401(k) Profit-Sharing Plan for Employees of Arundel Lodge, Inc. (the Plan), established July 1, 1998 and amended effective March 1, 2020, is a defined contribution plan covering substantially all employees of Arundel Lodge, Inc. (the Employer). Under the provisions of the Plan effective March 1, 2020, employees age eighteen or older become eligible to participate in the Plan on the day they are hired. Employees that are hired on or after March 1, 2020 are automatically enrolled in the Plan at a default participant contribution rate of 1% of compensation, unless the employee elects to opt out of the Plan in writing. Upon the provisions of the Plan prior to March 1, 2020, an employee age eighteen or older becomes eligible to participate in the Plan after completing one year of service and completing 1,000 hours of service during a Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions: Effective March 1, 2020, participants may defer a portion of their salary into the Plan. Participant contributions are subject to the annual Internal Revenue Service Code limits as adjusted each year. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Prior to March 1, 2020, participants could not contribute to the Plan.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Employer Contributions: The Employer may make a discretionary profit sharing contribution to the Plan. There were no employer contributions for the years ending June 30, 2024 and 2023.

Participant Accounts: Each participant's account is credited with the participants contributions, the Employers discretionary contribution, Plan earnings, and charged with applicable fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's, in one, several, or all of the investment alternatives selected by the plan administrator.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer contribution portion of each participant's account is based on years of continuous service. A participant is 100% vested after five years of credited service. A year of credited service is a Plan year in which the participant is credited with at least 1,000 hours of service with the Employer. On termination of employment due to death or disability (approved by Social Security), a participant becomes fully vested in their account.

Notes Receivable from Participants: Participants may borrow from their account a minimum of \$1,000. The loans are secured by the vested balance in the participant's account and bear interest at rates of 4.25% - 9.50%. Principal and interest is paid ratably through biweekly payroll deductions.

Payment of Benefits: On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in annual installments over the life expectancy of the participant and/or designated beneficiary. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures: Forfeitures shall be allocated to participants who are active in the Plan on the accounting date in the ratio that the compensation of such participant bears to the compensation of all Plan participants. The amounts available to be allocated to participants at June 30, 2024 and 2023 were \$6,321 and \$4,706, respectively. For the years ended June 30, 2024 and 2023, there were no forfeitures allocated to participants, respectively.

Administrative Expenses: The administrative expenses related to the Plan's Trustee are paid by the Plan. The Employer pays all other administrative expenses of the Plan.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Financial Statements

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America. The basis of accounting involves the application of accrual accounting; consequently, revenues and gains are recognized when earned, and expenses and losses are recognized when incurred.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual amounts could differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of net assets available for benefits of a defined-contribution plan attributed to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Statements of Changes in Net Assets Available for Benefits are prepared on a contract value basis for the fully benefit-responsive investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. The Plan administrator has determined all notes receivable are fully collectible from the participants' vested account balances, consequently, no amount has been recorded as an allowance for doubtful accounts.

Payment of Benefits

Benefits are recorded when paid.

Contributions

Contributions from the Plan are recorded in the year in which the participant contributions are withheld from the amounts paid. Employer discretionary profit sharing contributions are recorded in the year in which the employer designates the contributions. All participant and employer contributions are participant-directed.

NOTE 3 - INVESTMENT DATA

All investment data contained in the statements of net assets available for benefits as of June 30, 2024 and 2023, the changes of changes in net assets available for benefits for the years ended June 30, 2024 and 2023, and the Schedule H, line 4i – schedule of assets (held at end of year) as of June 30, 2024 was summarized from information provided by Mutual of America Life Insurance Company, the Trustee of the Plan, and furnished to the plan administrator. The plan administrator has obtained a certification from the Trustee that the information provided to the plan administrator by the Trustee is complete and accurate.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows.

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 4 - FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Variable Annuities: Valued at the net asset value of the variable annuity contracts, as reported by the Trustee and calculated in a manner consistent with Generally Accepted Accounting Principles for investment companies. The net asset value is calculated based on the values of the underlying mutual funds, domestic stocks, international stocks, and other fixed securities held by variable annuity contract. As permitted by *FASB ASC 820*, net asset value is used as a practical expedient to estimate fair value of the Plan's variable annuities as of June 30, 2024 and 2023 was \$3,141,244 and \$2,513,304, respectively.

NOTE 5 - INVESTMENTS AT CONTRACT VALUE

The Plan entered into a fully benefit-responsive investment contract with Mutual of America Life Insurance Company. Mutual of America Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value is reported to the Plan by Mutual of America Life Insurance Company. Contract value represents contributions made under contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed in the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value at June 30, 2024 and 2023 amounted to \$18,482 and \$14,716, respectively.

NOTE 5 - INVESTMENTS AT CONTRACT VALUE (CONTINUED)

Because the contract is an insurance contract, the Plan may transact according to the terms defined in the contract at any time. If the Plan wishes to terminate its interest in the contract, it would be paid the value of its interest, the issuer of the contract has the right to no longer receive deposits. Termination of the contract would occur when the deposit arrangement no longer exists and there are no guaranteed interest funds with a value greater than zero remaining under the contract. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 - REPORTABLE TRANSACTIONS

A reportable transaction is a transaction, or series of transactions, exceeding five percent of the current value of the Plan's assets at the beginning of the year. During the Plan years ended June 30, 2024 and 2023, there were no reportable transactions.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS

Mutual of America Life Insurance Company is the Trustee of the Plan and charges administrative fees for certain transactions initiated by participants. These transactions qualify as party-in-interest transactions. For the years ended June 30, 2024 and 2023, administrative fees paid by the Plan to the Trustee amounted to \$1,502 and \$1,180, respectively.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS (CONTINUED)

The Plan Sponsor provides certain accounting and administrative services to the Plan for which no fees are charged. The Plan's auditor who audits the Plan's financial statements and the third-party administrator who provides accounting and administrative services are paid directly by the Plan Sponsor. These fees are not reflected in these financial statements.

NOTE 9 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

NOTE 10 - TAX STATUS

Effective March 1, 2020, the Plan adopted a non-standardized form of prototype plan. The prototype plan obtained its latest opinion letter on June 30, 2020 from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by the Plan. The Plan has been amended since the prototype received its opinion letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently not audits for any tax period in progress.

NOTE 11 - SUBSEQUENT EVENTS

The Plan has evaluated the impact of significant subsequent events. There have been no subsequent events through April 11, 2025, the date the Plan's financial statements were available to be issued, that require recognition or disclosure.
