Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Earp Meat Company, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended September 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

NOTES TO FINANCIAL STATEMENTS

September 30, 2024 And 2023

1. Description Of The Plan

The following description of the Earp Meat Company, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees, except union employees and leased employees, of Earp Meat Company, Inc. (the Company or Employer) who have completed two consecutive months of service and have attained the age of 18. Eligible participants may enter the Plan on the first day of the month coinciding with or next following the date on which such requirements are satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Company administers the Plan.

Contributions

The default rate for automatic enrollment is 4% of compensation. A participant may modify the automatic election on the first day of each month to elect a different salary deferral percentage or elect not to participate.

Participants may elect to defer salary up to 100% of eligible compensation to the Plan as Roth contributions, pre-tax contributions, or a combination thereof, subject to certain Internal Revenue Service (IRS) limitations. Participants also have the option to elect a separate deferral percentage, up to 50%, of bonus compensation. All employees who are eligible to make elective salary deferral contributions under the Plan and who have attained age 50 prior to the end of the Plan year shall be eligible to make catch-up contributions in accordance with, and subject to IRS limitations.

The Plan allows employee rollover contributions from other qualified plans.

The Plan allows for discretionary Employer matching contributions. For the years ended September 30, 2024 and 2023, Employer discretionary matching contributions were equal to 50% of employee contributions up to 4% of eligible compensation.

Notes To Financial Statements (*Continued*)

Participant Accounts

Each participant's account is credited with the participant's and Employer's contributions and an allocation of Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may only have one loan outstanding at any point in time. Loans used for purchase of a residence must be repaid within a reasonable time as determined by the Plan administrator. All other loans must be repaid within a period not to exceed five years. Loans are secured by the vested balance in the participant's account and bear interest at a reasonable rate. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment Of Benefits

Participants are entitled to receive the vested balance of their accounts upon death, total disability, normal retirement, early retirement or termination of employment. Normal retirement age is the later of a participant's 65th birthday or the 5th anniversary of the first day of the Plan year in which participation in the Plan commenced. Early retirement is defined as the anniversary date coinciding with or next following the date on which a participant attains age 55 and has completed at least 11 years of service. Benefit payments may only be made in the form of lump-sum cash distributions.

The Plan allows in-service hardship withdrawals from a participant's elective salary deferral account. Hardship distributions may not be less than \$1,000. Hardship withdrawals are subject to the Internal Revenue Code (IRC) safe-harbor provisions with respect to the amount, nature, and source of the withdrawals. In-service distributions may be made to a participant who has not separated from service provided the participant has attained the age of 62.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in each participant's Employer matching contributions is based on years of continuous service, as follows:

Forfeitures

Forfeitures of nonvested participant balances are used to reduce Employer contributions. During the years ended September 30, 2024 and 2023, \$35,979 and \$45,147, respectively, of forfeited nonvested balances were used to reduce Employer contributions. Forfeited nonvested balances which will be used to reduce future Employer contributions totaled \$4,184 and \$554 as of September 30, 2024 and 2023, respectively.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The accompanying financial statements are presented on the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Notes To Financial Statements (*Continued*)

Investment Valuation And Income Recognition

The Plan's investments, other than the fully benefit-responsive investment contract, are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Net change in fair value of investments represents the difference between the aggregate fair value of investments at year end and the values at the beginning of the year and includes any realized gains and losses in securities that were bought and sold during the year.

Interest income is recorded as earned on the accrual basis. Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date.

Investment contracts held by a defined contribution plan that are fully benefit-responsive are reported at contract value, rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in the Key Guaranteed Portfolio Fund is a fully benefit-responsive investment contract and is reported at contract value in the statement of net assets available for benefits.

The crediting interest rate is based on an agreed-upon schedule with the issuer and is reset quarterly. The average crediting interest rate was 1.38% in 2024 and 1.16% in 2023.

Notes Receivable From Participants

Notes receivable from participants are measured at the outstanding balance plus accrued and unpaid interest. Delinquent loans are recorded as a distribution based on the terms of the Plan Document.

Payment Of Benefits

Benefit payments are recorded when paid.

Subsequent Events

Management evaluates subsequent events through the date financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Certified Investment Information

Financial information related to all of the Plan's investments, notes receivable from participants, and related earnings thereon, as of and for the years ended September 30, 2024 and 2023, are included in the accompanying financial statements and supplemental schedule and are based on information provided by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively Empower). The Plan Administrator has obtained certifications from Empower that such information is complete and accurate. This information has not been audited by the Plan's independent auditors.

Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets as of December 31:

4. Fully Benefit-Responsive Investment Contract

During 2024 and 2023, the Plan had a group annuity contract with Empower Annuity Insurance Company of America that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions.

The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan Document (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Sponsor does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

5. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Registered Investment Companies

Valued at the daily closing price as reported by the funds. Registered investment companies held by the Plan are open-end investment funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price.

Common/Collective Trust

Valued at the NAV of units, or NAV equivalent, of the individual funds. The NAV, as provided by the trustee of the invested fund, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The common/collective trust held by the Plan is redeemable daily, and files an annual report on Form 5500 as a direct filing entity. There is no capital commitment related to the Plan's common/collective trust.

Pooled Separate Account

Valued at the NAV of units held by the Plan at year end. The NAV as provided by Empower, is used as a practical expedient to estimate fair value. The NAV is determined by dividing the net assets, at fair value, of the fund by the number of units outstanding on the day of valuation. The pooled separate accounts is primarily comprised of shares of registered investment companies held through subaccounts of a separate account of an insurance company at September 30, 2024 and 2023. The Plan has concluded that the NAV as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company approximates fair value of the investments. The pooled separate account has a daily redemption frequency at NAV with no redemption notice periods and files an annual report on Form 5500 as a direct filing entity. There is no capital commitment related to the Plan's pooled separate account.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Plan Termination

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. Upon termination, participants will become 100% vested in their accounts.

7. Income Tax Status

The Company utilizes a pre-approved plan sponsored by Compensation Benefits Planning, Inc. (CBP), as restated on October 1, 2020. CBP received an opinion letter from the IRS dated June 30, 2020, stating that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC and, therefore, not subject to tax. The Plan itself has not received a determination letter. The Plan has been amended since the date of the opinion letter. The Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

8. Risks And Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the financial statements.

9. Transactions With Party In Interest

During 2024 and 2023, certain Plan assets were invested in an investment contract managed by Empower Annuity Insurance Company of America, a Custodian of the Plan. These transactions are considered party in interest transactions allowable under ERISA.

Certain employees have outstanding loans with the Plan as of September 30, 2024 and 2023. These loans are considered party in interest transactions allowable under ERISA.
