Opinion

NOTE 1 DESCRIPTION OF PLAN

The following description of The Vollrath Company, L.L.C. Retiree Health Care Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 2011 to provide health and other benefits to eligible retirees of The Vollrath Company, L.L.C. (the Company) and covered dependents. Certain Plan assets are held in an irrevocable trust (Trust). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan provides participants with hospitalization, surgical-medical, accident, sickness, drug coverage, vision, dental and death benefits, subject to certain exclusions and specified maximum coverage limitations, as described in the various Plan documents.

Contributions

Company contributions are made to the Plan as needed throughout the year. Participant contributions are determined each year based on levels of coverage selected and are made by monthly payments to the Company at rates determined each year. The Company then makes payments to the trustee based on receipts. Retiree contribution rates are as follows:

Hourly retirees (based on retiring age 65 or after): For retirements prior to April 1, 1995, no contribution is required. For retirements on or after April 1, 1995 and prior to April 1, 2007, retirees pay the cost of insurance less an annual subsidy of \$90 (single) or \$135 (family) per year of service, up to a maximum 30 years of service. For retirements on or after April 1, 2007, retirees pay the cost of insurance less an annual subsidy of \$90 (single) or \$150 (family) per year of service, up to a maximum 30 years of service.

Salaried retirees (based on retiring age 65 or after): For retirements prior to June 1, 1994, no contribution is required. For retirements on or after June 1, 1994 and prior to April 1, 2007, retirees pay the cost of Medigap insurance less an annual subsidy of \$1,000 (single) or \$1,500 (family).

Benefits

The Company, as Plan administrator, entered into administrative service contracts with Prairie States Enterprises, Inc. (Prairie States) and Serve You Custom Prescription Management, Inc. (Serve You) whereby Prairie States performs the processing and payment of all medical and dental benefits, and Serve You performs the processing and payment of all drug benefits. All other benefits are administered by the Company.

Stop Loss Coverage

The Company has entered into a stop-loss insurance arrangement in an effort to limit the Plan's exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Administrative Expenses

The Trust pays administrative expenses reasonably incurred in the administration of the Plan and Trust. These expenses are reported on the statements of changes in net assets available for benefits as Administrative Expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

Payment of Benefits

Claim payments are recorded when paid by the Trust.

Premiums paid by either the Company or the Trust are recorded in the accompanying statements of changes in net assets available for benefits.

Stop Loss

Premiums for stop loss insurance are included in insurance premiums paid for participants in the accompanying statements of changes in net assets available for benefits. There were no stop loss refunds received by the Plan for the years ended June 30, 2024 and 2023.

Refunds

Refunds from Prairie States and Serve You are due to the Company based on the arrangement. The Company decides whether to contribute to the Plan. Refunds received by the Company and subsequently contributed to the Plan are included with Company contributions. Refunds of \$366,126 and \$211,605 for the years ended June 30, 2024 and 2023, respectively, have been included with Company contributions in the accompanying statements of changes in net assets available for benefits.

Plan Benefits and Benefit Obligations

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service previously rendered. Postretirement benefits include benefits expected to be paid to or for (a) retired employees or their beneficiaries and dependents, and (b) active employees or their beneficiaries and dependents after retirement from service with the Company. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date that will be paid from the Plan.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The Plan's postretirement benefit obligation does not reflect an amount associated with the Medicare subsidy allowed under the Medicare Prescription Drug Improvement and Modernization Act of 2003 because the Plan is not directly entitled to the Medicare subsidy. The Company has included the effects of the Medicare subsidy in measuring its postretirement benefit obligation; therefore, the Plan's postretirement benefit obligation differs from that of the Company.

Significant assumptions underlying the computations included in the actuarial valuations are as follows:

Weighted average discount rate:	5.55% and 5.45% as of June 30, 2024 and 2023, respectively
Retirement:	100% by age 70
Mortality:	Pri-2012 separate employee, retire, and survivor mortality tables and projected forward on a fully generational basis using MP-2021.
Withdrawal:	Rates of turnover inherent in Sarason T-6 Table
Health care cost trend rate:	6.0% for 2024 and 2023, decreasing to 4.5% at a rate of 0.2% per year until 2032

The foregoing actuarial assumptions are based upon the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated postretirement benefit obligations.

The health care cost-trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If this rate was increased by one percentage point, the obligation as of June 30, 2024 and 2023 would increase by \$918,542 and \$473,199, respectively.

The Plan's deficiency of net assets available for benefits over obligations at June 30, 2024 and 2023 relates to the postretirement obligation, which is funded on a pay-as-you-go basis. It is expected that the deficiency will be funded through future Company and eligible retiree contributions.

Subsequent Events

The Plan has evaluated subsequent events through April 14, 2025, the date the financial statements were available to be issued.

NOTE 3 TAX STATUS

The Trust established under the Plan is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC) and, accordingly, the Trust's net investment income, to the extent allowed under the IRC, is exempt from income taxes. The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated February 5, 1988 that the Trust, as then designed, was in compliance with the applicable requirements of the IRC. The Trust has been amended since receiving the determination letter. The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related Trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 5 PARTY-IN-INTEREST TRANSACTIONS

As described in Note 1, the Plan has several arrangements with service providers. These transactions qualify as party in interest transactions, which are exempt from the prohibited transaction rules of ERISA.

NOTE 6 RISKS AND UNCERTAINTIES

The postretirement benefit obligation is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
