INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of 403(b) Thrift Plan for Employees of Special Service for Groups, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of June 30, 2024 and 2023, and the related Statements of Changes in Net Assets Available for Benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of 403(b) Thrift Plan for Employees of Special Service for Groups, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of 403(b) Thrift Plan for Employees of Special Service for Groups, Inc. and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.



NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following description of 403(b) Thrift Plan for Employees of Special Service for Groups, Inc. (“the Plan”) provides only general information. Participants should refer to the Plan’s agreement for a more complete description of the Plan’s provisions.

General

The Plan is a 403(b) tax-deferred plan, established on January 1, 2013, under the provisions of the Internal Revenue Code and covers substantially all employees of Special Service for Groups, Inc. (“SSG”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). SSG is the plan sponsor and serves as the plan administrator.

Contributions

A participant becomes eligible to make contributions to the Plan on the date of hire and has reached the “entry date” as defined in the Plan. Participants may contribute a percentage, or a fixed amount of their eligible compensation as defined in the Plan. In addition, participants qualifying for age-based provisions may contribute an additional catch-up deferral. Participants with at least 15 years of service with SSG after testing required for eligibility are also able to make special catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans.

Employees who are at least 21 years of age and have completed at least one year of service (1,000 hours) are entitled to receive employer base contributions for each plan year equal to 7.5% of compensation whether or not any salary reduction is made to the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contribution; the allocation of SSG’s base contribution, and the Plan earnings. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are fully vested, at all times and in all events, in their contributions. A participant is 100% vested in the employer base contributions upon completion of five years of service.

Notes Receivable from Participants

Loans to participants are not permitted under the plan.

NOTES TO FINANCIAL STATEMENTS

1. Description of Plan, continued

Payments of Benefits

In general, on termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the fair value of the participant's account balance or a purchase of a guaranteed lifetime or a uniform monthly annuity.

Forfeitures

Forfeitures are the non-vested portion of a participant's account that are lost upon termination of employment. Forfeited non-vested amounts may be used to reduce the Plan expenses and any remaining forfeitures may be used to reduce any employer contribution. At June 30, 2024 and 2023, there were \$10,128 and \$21,164, respectively, of forfeited non-vested accounts. Forfeitures used to reduce plan expenses and employer contributions during June 30, 2024 and 2023 were \$327,474 and \$309,877, respectively.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements is as follows:

Basis of Presentation

The financial statements of the Plan are reported on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Fair Value Measurements

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statement elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs – quoted prices in active markets for identical assets

Level 2 inputs – quoted prices in active or inactive markets for the same or similar assets

Level 3 inputs – estimates using the best information available when there is little or no market

The Plan is required to measure certain investments at fair value. The specific technique used to measure fair value for the financial statement element is described in the notes below that relates to the element.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risk. It is reasonably possible, given the level of risk associated with certain investment securities, that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Administrative Expenses

SSG absorbs all administrative expenses of the Plan other than the contract services fees charged by the trustee. During 2024 and 2023, total administrative expenses were \$23,319 and \$16,405, respectively.

Subsequent Events

3. Information Prepared and Certified by the Trustee

No auditing procedures were performed on investments and Plan income as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

6. Plan Termination

Although it has not expressed any intent to do so, SSG has the right under the Plan to discontinue its contribution at any time and to terminate the Plan, subject to the provisions of ERISA.

7. Tax Status

The Plan presently does not have a tax determination letter from the Internal Revenue Service ("IRS") since the IRS has not established a process for issuing determination letters for individually designed 403(b) plans. However, the plan administrator and the plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Service Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. **Tax Status**, continued

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

8. **Related Party and Party-in-Interest Transactions**

ERISA defines parties-in-interest more broadly than generally accepted accounting principles' related parties, encompassing all service providers to the Plan. Management identified no related parties that were not also parties-in-interest, and no material related party transactions occurred during the Plan year regarding compensation arrangements, expense allowances, or similar items.

Parties-in-interest transactions include those with Plan fiduciaries or employees, service providers, employers with covered employees, employee organizations with covered members, and persons owning 50% or more of such employers or employee associations, along with their relatives. Trustee transactions, including revenue sharing and fee offset agreements, as well as SSG' payment of certain Plan fees and expenses, qualify as parties-in-interest transactions. Administrative fees paid by the Plan to the trustee were \$23,319.

The Plan's investment options include funds managed by Mutual of America Life Insurance Company or its affiliates. As custodian and recordkeeper, Mutual of America Life Insurance Company's transactions qualify as exempt parties-in-interest transactions.
