Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Central Oklahoma Family Medical Center 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023 and for the year ended June 30, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

A. DESCRIPTION OF THE PLAN

The following description of the Central Oklahoma Family Medical Center 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established for the benefit of Central Oklahoma Family Medical Center, Inc. (the Organization) employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's effective date is July 1, 2018, and was restated effective March 1, 2024.

The Plan is administered by individuals appointed by the Organization's board of trustees. American United Life Insurance Company (the Custodian) serves as the custodian of the Plan, processes and maintains the records of the participant data, and holds the Plan's assets.

Eligibility

All full-time employees of the Organization are eligible to make contributions to the Plan. Employees who have reached 21 years of age and have completed at least one year of service and 1,000 hours are eligible to receive matching contributions.

Contributions

Each year, participants may contribute up to 100 percent of pre-tax annual compensation, as defined by the Plan, up to IRS maximum limits. Salary deferral contributions can be made on a pre-tax basis or directed towards a Roth (after-tax) account. Participants who are projected to be age 50 or older by the end of a calendar year may also make catch-up contributions. Employee rollover contributions are also permitted.

The Plan also provides for employer matching contributions. Prior to December 31, 2023, the Organization matched up to 2.5% of a participant's compensation, as defined by the Plan. Beginning January 1, 2024, this match increased to 3.0%. Employer matching contributions are based on deferrals made each payroll period.

Contributions are subject to certain limitations.

Participant Accounts

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the funds offered by the Plan and may change the allocation daily. Each participant's account is credited with the participant's contribution, the Organization's contribution, and Plan earnings, and is charged with an allocation of administrative expenses. Allocations of expenses are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in employer contributions is based upon years of continuous service as follows:

<u>Years of vesting service</u>	<u>Vesting Percent</u>
Less than three years	0%
Three or more years	100%

Participants automatically become 100% vested upon: 1) normal retirement age (attainment of age 65); 2) disability; or 3) death. Participants who terminate for any other reason are entitled to the vested amount of their accounts.

Payment of Benefits

Upon retirement, termination, disability, or death, a participant, or his or her beneficiary in the event of death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Additionally, participants may take an in-service distribution upon reaching the age of 59 ½. Upon termination, automatic distributions are required for balances of less than \$5,000. Generally, certain minimum distributions are required for participants who have separated from service and have reached age 72.

The Plan allows hardship withdrawals from the participants' 100% vested accounts, subject to account balance limits and applicable laws.

Forfeitures

Forfeitures are used to pay employer contributions, or to pay Plan expenses. During the year ended June 30, 2024, \$14,354 of forfeited amounts were used to reduce employer contributions. The Plan had no unallocated forfeitures at June 30, 2024 or 2023.

Administrative Expenses

Administrative expenses may be paid by the Organization or the Plan, at the Organization's discretion. Certain investment-related expenses are included in net appreciation in fair value of investments.

B. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles accepted in the United States of America.

B. SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are held in a group annuity contract with American United Life Insurance Company (OneAmerica), under pooled separate accounts and a stable value account. Pooled separate accounts are reported at fair value. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

C. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian has certified that the following data included in the accompanying financial statements and supplemental schedule of assets (held at end of year) is complete and accurate:

- Investments as shown on the statements of net assets available for benefits as of June 30, 2024 and 2023;
- Net appreciation in fair value of investments as shown in the statement of changes in net assets available for benefits for the year ended June 30, 2024;
- Investment information related to pooled separate accounts and the stable value account included in the footnotes as of June 30, 2024 and 2023, and on the supplemental schedule of assets (held at end of year) as of June 30, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

D. INVESTMENTS MEASURED USING THE NET ASSET VALUE PER SHARE PRACTICAL EXPEDIENT

Investments held by the Plan include pooled separate accounts and a stable value account. There have been no changes in the methodologies used to value mutual fund accounts or the stable value account at June 30, 2024.

Pooled separate accounts are stated at fair value as determined by the issuer of the mutual fund accounts on the fair market value of the underlying investments, which is valued at net asset value (NAV) as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investments for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

E. STABLE VALUE ACCOUNT

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with OneAmerica. OneAmerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. OneAmerica is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the stable value account meets the criteria to be considered fully-benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the stable value account. The stable value account is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by OneAmerica, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the stable value account at June 30, 2024 and 2023 was \$298,631 and \$182,841, respectively. The crediting interest rate is set by OneAmerica on an annual basis. The rate in effect at June 30, 2024 and 2023 was 1%.

E. STABLE VALUE ACCOUNT (CONTINUED)

Certain events limit the Plan's ability to transact at contract value with OneAmerica. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants or the issuer are probable of occurring.

F. PLAN TERMINATION

The Organization may amend or terminate the Plan at any time. Any such termination or amendment shall be effective at such date as the Organization shall determine. In the event of termination of the Plan, the value of the participants' accounts attributable to the Organization's contributions shall become fully vested to the participants.

G. TAX STATUS

The Plan operates under a non-standardized adoption agreement in connection with a volume submitter plan with a cash or deferred arrangement sponsored by the Plan's third-party administrator. The Internal Revenue Service advised on March 31, 2017, that the volume submitter plan, which the Plan has adopted, was acceptable under Section 403(b) of the Internal Revenue Code and that the related trust was tax exempt as of the date of the letter. The Plan has been amended since the date of the letter; however, the plan administrator believes that the Plan and the related trust is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to income examination for years prior to 2020.

H. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

I. PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain accounting and auditing fees related to the Plan are paid by the Organization. The Organization does not expect reimbursement from the Plan for these services. Certain administrative functions are performed by officers and employees of the Organization. No officer or employee receives compensation from the Plan for these services.

Certain plan investments are managed the Custodian. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment.

J. SUBSEQUENT EVENTS

Subsequent events have been evaluated through the date of the independent auditor's report, which is the date the financial statements were available to be issued.
