**1. DESCRIPTION OF THE PLAN**

The following description of the Greenwood Village South Internal Revenue Code Section 403(b) Tax Deferred Annuity Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement or the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, established July 1, 1984, and restated September 1, 2011, covering all employees of Westminster Village Greenwood, Inc. d.b.a. Greenwood Village South (the Plan Sponsor). Employees are eligible to participate in the Plan upon commencement of employment. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions and Funding Policy

Participants may contribute up to 100% of their annual pretax compensation as defined by the Plan, up to the maximum allowable under the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans in the form of rollovers.

The Plan Sponsor may elect to provide a matching contribution and/or a profit-sharing contribution each plan year. The extent and amount of each year's contributions, if any, are at the discretion of the Board of Directors of the Plan Sponsor. Any profit-sharing contribution will be calculated based on the ratio each participant's compensation bears to the total of such compensation of all participants. Participants must have attained age 21, have three consecutive months of service or one year of service if earlier, and be employed as of the end of the plan year to receive the matching and profit-sharing contributions. The Plan Sponsor made matching contributions of \$125,931 for the year ended June 30, 2024. The Plan Sponsor did not make a profit-sharing contribution for 2024.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's deferral contributions, Plan Sponsor's matching and profit-sharing contributions, and allocations of plan earnings thereon. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct their investments into various options offered by the Plan. The Plan offers various funds and a fixed annuity contract as investment options for participants.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contributions is based on years of continuous service as shown below:

Forfeited Accounts

In the event of termination of employment before full vesting, the nonvested portion of the Plan Sponsor contribution account is forfeited and may be used to reduce future Plan Sponsor contributions. During 2024, forfeited accounts of \$21,394 were used to reduce Plan Sponsor contributions. Forfeitures included in net assets available for benefits were \$2,473 and \$10,018 at June 30, 2024 and 2023, respectively.

Notes Receivable from Participants

Pursuant to plan provisions, participants are not permitted to borrow from their fund accounts.

Payment of Benefits

In general, on termination of service, death, disability, or retirement, a participant may elect to receive a cash distribution equal to the value of the participant's vested interest in his or her account. Distribution methods available to participants include lump-sum, partial lump-sum, installments, and annuities. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

**2. SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Each individual investment offered to the participants has varying investment objectives. Participants should refer to the custodian for a more complete description of the investment objectives.

Concentration of Credit Risk

Financial instruments that potentially subject the Plan to concentrations of credit risk are part of the holdings in Plan's investments. Management believes that the custodian maintains the Plan's investments with high quality institutions and attempts to limit the credit exposure to any particular investment.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

An annual administrative fee for processing Form 5500 (the Plan's annual tax filing) and a full-service fee based on the number of participants in the Plan are paid by the Plan Sponsor. The Plan Sponsor also pays most of the administrative expenses including audit fees and legal fees. Fees paid by the Plan relate primarily to third party processing fees and administration of the Plan. These fees are included in administrative expenses within the statements of changes in net assets available for benefits. Fees related to distributions are deducted from the participant's account.

Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is April 14, 2025.

**3. INFORMATION CERTIFIED BY THE CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Bank, the custodian of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, the schedule of assets at June 30, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended June 30, 2024.

**4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds an investment contract that comprises of a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for a fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. With a traditional investment contract, the Plan owns only the contract itself. A traditional investment contract is designed to accrue interest based on crediting rates established by the contract issuers.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed periodically for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

**5. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**6. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS**

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Plan Sponsor and certain others.

Transactions with parties-in-interest included administrative fees for the Plan's custodian, Charles Schwab Bank (Schwab). The Standard Insurance Company is the Plan's third-party administrator and receives payment for those services. Blue & Co., LLC is the independent auditor of the Plan and receives payment for those services.

The Plan Sponsor pays the majority of expenses of the Plan, including administrative, accounting and auditing fees. These expenses qualify as party-in-interest transactions.

**7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**8. TAX STATUS**

The Internal Revenue Service (IRS) has yet to establish its determination letter program for individual 403(b) plans. Therefore, the Plan has not submitted its plan document to the IRS to obtain an individual determination letter. However, the IRS does require that 403(b) plans conform to the guidelines of preapproved 403(b) plan documents. The Plan Sponsor believes that the Plan was designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. Management has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements net assets available for benefits.
