INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Schmitty and Sons School Buses, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

NOTE 1 DESCRIPTION OF PLAN

The following description of the Schmitty and Sons School Buses, Inc. (the "Employer") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was originally effective July 1, 1995. The Plan has been amended and restated throughout the years. The Plan is a defined contribution plan sponsored by Schmitty and Sons School Buses, Inc. for all employees, except those covered by a collective bargaining agreement and non-resident aliens. All eligible employees who have attained the age of 21 and have completed one year of service are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

The Plan includes a cash or deferred arrangement allowed under Section 401 of the Internal Revenue Code. Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) contributions to the Plan. Participants age 50 and older are allowed to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

Each year, the Employer may make a matching contribution. During the year ended June 30, 2024, the Employer made safe-harbor matching contributions of 100% of the first 3% of each participant's contributions and 50% of the next 2% of participant contributions for a maximum safe-harbor match of 4%. Each year, the Employer may also make a discretionary profit-sharing contribution. In order for a participant to share in a profit-sharing contribution, the participant must complete 1,000 hours of service during the Plan year, unless termination is due to death, disability or retirement. There was no Employer discretionary profit sharing contribution for the year ended June 30, 2024. Contributions are subject to certain limitations.

The Plan also permits rollover contributions from other qualified plans.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contributions and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's matching and profit-sharing contribution portion of their accounts plus actual earnings thereon, is subject to a graded vesting schedule based on years of continuous service. A participant is 100 percent vested after six years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, upon death, or upon permanent disability.

Benefit Payments

Upon termination of service, including death, disability, or retirement (age 65), a participant may elect to receive their vested account balance in the form of a lump sum. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the

Plan Administrator will authorize the benefit payment without the participant's consent. The Plan also allows for in-service withdrawals at age 59 1/2 and hardship distributions subject to limitations, as defined in the Plan.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to a variety of pooled separate accounts maintained by John Hancock Life Insurance Company (U.S.A.). The investment options range from low risk income funds to high-risk international growth funds.

Forfeited Accounts

If a participant withdraws from the Plan prior to becoming fully vested, the non-vested portion of a participant's account is held in a suspense account and forfeited as of the last day of the Plan year. These accounts are allocated to participants who have completed a year of service and are employed on the last day of the Plan year. At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$923, respectively. During the plan year ended June 30, 2024, no forfeitures were used to reduce employer contributions.

Notes Receivable from Participants

Participants are entitled to borrow up to 50% of their account balances, subject to a \$1,000 minimum and \$50,000 maximum loan for specified purposes. Loans are payable over periods of not more than five years, bear interest at 2.4% over the prime rate at the loan date and are secured by the balance in the participant's account. Loans are repaid ratably through payroll deductions. At June 30, 2024, the interest rate on outstanding loans were between 5.65-10.65%.

Administrative Expenses

The Employer pays certain administrative expenses on behalf of the Plan. Expenses paid by the Plan are included in the statement of changes in net assets available for benefits.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expense during the reporting period. Actual results could differ from those estimates.

The severity, magnitude and duration, as well as the economic consequences of the COVID-19 pandemic, are uncertain, rapidly changing and difficult to predict. Therefore, our accounting estimates and assumptions may change over time in response to COVID-19 and may change materially in future periods.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. As of June 30, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Benefit Payments

Benefits are recorded when paid.

Risks And Uncertainties

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Management evaluates events occurring subsequent to the date of the balance sheet in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through **April 15, 2025**, which is the date the financial statements were available to be issued.

NOTE 3 INFORMATION CERTIFIED BY THE CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended June 30, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Life Insurance Company USA (John Hancock USA) and Alerus Financial, the custodians of the Plan.

NOTE 4 TAX STATUS

The Plan is placing reliance on an opinion letter dated September 18, 2001 received from the Internal Revenue Service on the prototype plan indicating that the prototype Plan is qualified under Section 401 of the Internal Revenue Code and is therefore not subject to tax under current income tax law. The prototype Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits

for any tax period in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 5 TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, the Employer will direct the Trustee with respect to the distribution of accounts. Liquidation of assets and payment of benefits will be made provided that the Plan is in compliance with the applicable plan termination requirements of ERISA and the Internal Revenue Code (IRC).

NOTE 6 FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Level 2 Fair Value Measurements

Pooled Separate Accounts: Valued at the net asset value (NAV) of units of and insurance pooled account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the pooled separate account, the investment advisor reserves the right to temporarily delay withdrawal in order to ensure that securities liquidation will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
