Report of Independent Auditors

To the Participants and Trustees of
South Central Minnesota Electrical
Workers' Vacation and Holiday Plan

Opinion

We have audited the financial statements of South Central Minnesota Electrical Workers' Vacation and Holiday Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of South Central Minnesota Electrical Workers' Vacation and Holiday Plan as of June 30, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Notes to Financial Statements

June 30, 2024 and 2023

Note 1. Description of the Plan

South Central Minnesota Electrical Workers' Vacation and Holiday Plan (the Plan) was established effective June 1, 1980, as a result of a collective bargaining agreement between International Brotherhood of Electrical Workers Local Union No. 343 (the Local) and South Central Division of Twin Cities, National Electrical Contractors Association, Inc. (the Contractors Association). The Plan is a multiemployer defined contribution vacation (welfare) plan subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by a joint board of trustees consisting of an equal number of representatives from the Local and the Contractors Association.

The Plan covers individuals employed by participating employers under the terms of either a collective bargaining or participation agreement. The purpose of the Plan is to provide vacation and holiday benefits for eligible participants.

Contributions are credited to participants' accounts and are fully vested at all times once a participant designates a deposit institution, such as a bank or credit union. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. No earnings are allocated to participants' accounts.

Benefit payments to participants represent transfers to a credit union or other financial institution account held in the participant's name. Benefit distributions are made without delay once the contributions are received, provided that an account has been established or designated. Alternatively, if a participant has not established an account at the credit union or other designated financial institution, prior to January 1, 2024, the Plan will distribute the participant's account on a monthly basis in the form of a single check. Effective January 1, 2024, the Plan was amended to distribute checks to participants with no accounts on file on a semi-annual basis.

Plan participants with \$40 or more in vacation and holiday monthly contributions are assessed a \$5 monthly member fee for automatic clearing house transfers. The Plan would assess a \$38 check fee for distributions made directly to participants without an established credit union or designated financial institution. Effective May 7, 2024, the Trustees approved waiving the \$38 check fee for these distributions.

Participants should refer to the summary plan description for more complete information.

Note 2. Summary of Significant Accounting Policies

Method of Accounting - The accompanying financial statements have been prepared using the accrual basis of accounting.

New Accounting Pronouncement - In June 2016, the Financial Accounting Standards Board issued Accounting Standards Update No. 2016-13, *Financial Instruments - Credit Losses* (Topic 326), which is effective for the Plan for the year ended June 30, 2024. This new standard provides financial statement users with more decision-useful information about the expected credit losses on financial instruments and other commitments to extend credit held by a reporting entity at each reporting date. The standard replaced the incurred loss impairment model with a methodology that reflects expected credit losses and requires consideration of a broader range of reasonable and supportable information to inform credit loss estimates. The standard had no material impact on the Plan's financial statements.

Contributions Receivable - Employer contributions due and not paid at year end are recorded as contributions receivable. Deficiencies established through payroll compliance audits are recognized upon settlement with the employer. An allowance for uncollectible accounts is considered unnecessary and is not provided.

Revenue Recognition - Revenue derived from employer contributions is recognized in the period in which covered employment is performed, based on the straight-time wages earned in covered employment and the contribution rates set forth in the collective bargaining agreements. Employers are required to remit contributions monthly. The Plan carries out its purpose described in Note 1 within a jurisdiction primarily located in southern Minnesota.

Payment of Benefits - Benefit payments made to or on behalf of participants are recorded upon transfer to the participant's individual credit union or bank account or issuance of a monthly check, as described in Note 1. Participant distributions approved for payment but not yet paid totaled \$6,947 and \$10,313 at June 30, 2024 and 2023, respectively.

Estimates - The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Subsequent Events - Subsequent events have been evaluated through April 14, 2025, which is the date the financial statements were available to be issued.

Note 3. Priorities upon Termination

It is the intent of the Trustees to continue the Plan in full force and effect; however, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the net assets of the Plan will be allocated to pay benefits in priorities as prescribed by ERISA and its related regulations. Termination shall not permit any part of the Plan assets to be used for or diverted to purposes other than the exclusive benefit of the participants. Whether or not a particular participant will receive full benefits should the Plan terminate at some future time will depend on the sufficiency of the Plan's net assets at that time and the priority of those benefits.

Note 4. Tax Status

The Plan's notice of exemption is dated March 27, 1981, in which the Internal Revenue Service stated that the trust established under the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the notice of exemption. The Plan's administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken and recognize a tax liability if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Funding Policy

The Plan is primarily funded by employer contributions as specified in the collective bargaining agreements. The contribution rate for the majority of participants covered under the Plan is 12% of straight-time wages.

Note 6. Major Employers

Contributions from two employers accounted for approximately 28% and 22% of total contributions during the years ended June 30, 2024 and 2023, respectively. In the event these employers were to suspend contributions, the Plan would retain the risk of meeting fixed administrative expenses until the appropriate adjustments were made.

Note 7. Related Organizations

The Plan is related to a labor union, a retirement plan, a health plan, an apprenticeship training trust fund and a labor management cooperation committee, all of which are tax-exempt.

The related health plan pays all administrative expenses incurred by the Plan and collects participant fees. The excess participant fees received, less administrative expenses paid, is recorded as due from related organization on the statements of net assets available for benefits. At June 30, 2024 and 2023, the Plan was owed \$45,761 and \$28,074 respectively, from the health plan.

A shared receiving agency serves to collect contributions and union dues and distribute these to the various related organizations. The receiving agency also collects fees from these organizations and pays the administrative expenses of operating the account. Amounts due from the shared receiving agency are included in employer contributions receivable at year end.
