Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Insight Human Services Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Insight Human Services Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan

(investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEARS ENDED JUNE 30, 2024 AND 2023

1. Description of the Plan

The following description of the Insight Human Services Retirement Plan ("Plan") is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering employee of Insight Human Services, Inc. ("Company") immediately upon date of service (as defined in the Plan document). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company's Board of Directors is responsible for the oversight of the Plan. The Company's investment committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions – The Plan allows participants to contribute from 0% to the IRS limit of pretax annual compensation, as defined by the Plan. The Company may make discretionary matching contributions, as determined and authorized by the Board of Directors, to each eligible participant, after completing 6 months of service, based on the participant's salary reductions. At the Board of Directors discretion, the Plan Sponsor contributed 100% of the first 5% of compensation that a participant elects to contribute to the Plan as a matching contribution for the years ended June 30, 2024 and 2023. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts - Each participant's account is credited with the participant's contribution, matching contribution, and Plan earnings, and charged with benefit payments and allocations of administrative expenses. The allocation of Plan earnings is based on the participants' account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their voluntary contributions and the Company's matching contributions plus actual earnings thereon. If a participant dies or becomes disabled while still employed by the Company, his or her entire account balance becomes 100% vested.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Loan terms are limited to five years unless the loan is used to purchase a primary residence, in which the loan is capped at twenty years. The loan rate of interest will be the prime lending rate (8.50% and 8.25% at June 30, 2024 and 2023, respectively), plus 1%. Loan payments of principal and interest must be in level amortized payments, either monthly or quarterly.

Payment of Benefits – Upon termination of service due to death, disability, or retirement, a participant will receive periodic payments equal to the value of the participant's account as prescribed by the Plan's provisions, annuities, or may elect to receive a lump-sum amount equal to the value of the participant's account. Upon termination of service for other reasons, a participant will be entitled to receive their entire account balance which they can elect to have distributed to them upon termination. If the value of a participant's benefit is less than \$7,000, a distribution will automatically be made within a reasonable time after their employment is terminated.

Application of Forfeitures - At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$245 and \$223. Forfeitures arising from employer contributions are used to reduce administrative expenses or future employer contributions. In 2024 and 2023, administrative expenses were reduced by \$0 from forfeited non-vested accounts.

Plan Termination – Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants' balances will be distributed in accordance with the Plan agreement.

2. Summary of Significant Accounting Policies

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. The Plan changed accounting policies in the current year by adopting AICPA Statement on Auditing Standards (SAS) No. 136.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attributable for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Management has determined that the fixed annuity contract issued by Lincoln Financial Group and held by the Plan is not fully benefit-responsive and therefore is recorded at fair market value.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the Trustees. See note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) is reflected in the Statements of Changes in Net Assets Available for Benefits and consists of realized gains and losses and unrealized appreciation (depreciation) in the fair value of investments.

Contributions – Contributions from Plan participants and the matching contribution from the Plan Sponsor are recorded in the year in which the participant contributions are withheld from the amounts paid. All participant and employer contributions are participant-directed.

Notes Receivables from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events – The Company has evaluated subsequent events through April 12, 2025, the date which the financial statements were available to be issued.

3. Information Certified by the Trustees (Unaudited)

At June 30, 2024 and 2023, the Plan's investments were held by the Trustees. The following is a summary of the Plan's financial information that is included in the Plan's financial statements and supplementary schedule based on information certified by the Trustees as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Account Standard Codification (ASC) 820 provides the framework for measuring fair value: a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Variable Annuities – Valued at the net asset value (NAV) of shares or units held by the Plan at year-end based on market quotations or independent pricing sources of underlying investments.

Fixed Annuity Contracts – Valued at fair value by discounting the related cash flows based on the current yields of similar instruments with comparable durations considering the creditworthiness of the issuer (Note 5).

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Lincoln National Life Insurance Company (Lincoln) and management of the Plan have determined that the guaranteed investment contract is considered non-benefit responsive and is thus recorded at fair-value. The guaranteed investment contract provides a guaranteed interest rate for the length of the contract, reset at least quarterly. The rate credited is the rate in effect when the contract is purchased. The rate and yield in effect for the years ended June 30, 2024 and 2023 was 3.0%. Investments within the guaranteed investment contract totaled \$229,687 for 2024 and \$236,710 for 2023.

6. Related-Party and Party-in-Interest Transactions

Personnel and facilities of Insight Human Services, Inc. have been used to perform administrative functions for the Plan at no charge. Insight Human Services, Inc. pays Martin Starnes and Associates, CPAs, P.A. for the audit of Insight Human Services Retirement Plan. All of these related party and party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Certain Plan investments are shares of variable and fixed annuities managed by PCS Retirement, LLC and Lincoln Financial Group. Both PCS Retirement, LLC and Lincoln Financial Group are the trustees as defined by the Plan and qualify as a party-in-interest. Fees paid by the Plan for investment management services amount to \$22,249 and \$22,946 for the years ended June 30, 2024 and 2023, respectively.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEARS ENDED JUNE 30, 2024 AND 2023

7. Tax Status

The IRS has determined and informed the Organization by a letter dated March 27, 1994 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in a variety of investment securities. Investments securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

9. Late Remittances

During 2024 and 2023, the Company failed to timely remit certain employee deferrals to the Plan aggregating \$1,812 and \$0, respectively. As of April 12, 2025, the Company is computing loss earnings on the 2024 late remittances and is currently working on submitting to the Plan.
