Opinion

We have audited the accompanying financial statements of Iron Workers Local No. 67 Defined Contribution Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of November 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Iron Workers Local No. 67 Defined Contribution Fund as of November 30, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

FOR THE YEARS ENDED NOVEMBER 30, 2024 AND 2023

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Iron Workers Local No. 67 Defined Contribution Fund (Plan) provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution retirement savings plan covering eligible employees (Participants) as provided by collective bargaining agreements (Agreements) between Iron Workers Local No. 67 in Des Moines, Iowa (Union) and Des Moines Construction Council (Association). A trust, with Trustees designated by the Union and Association, has been established to manage and operate the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was created May 1, 1998.

Contributions

Contributions are made for all Participants working under the provisions of the Agreements. The current hourly contribution rates are as specified in the Agreements. Additional contributions are received through reciprocity agreements with other jurisdictional areas. Contributions are remitted to the fund office prior to being remitted to Principal Life Insurance Company ("Custodian").

Reciprocity

Reciprocity contributions are collected by and remitted to the Plan on behalf of Participants who worked with contractors at chapters outside the previously defined Union area. The Plan pays reciprocity amounts collected from employers for employees, whose home local unions are outside the Iron Workers Local No. 67 area.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each Participant's account is credited with the employer contributions, reciprocity contributions, rollovers, and an allocation of Plan earnings (losses) and charged with withdrawals and an allocation of administrative expenses. Allocations are based on a Participant's earnings or account balance, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account. Participants direct their funds into the Plan investments of their choice.

Vesting

Participants are 100% vested in employer contributions and earnings or losses on their accounts.

Payment of Benefits

Provisions relating to payments of vested benefits are as follows: (1) Participants or their beneficiaries may, at date of retirement, disability or death, elect to receive one of several options, including a lump sum benefit or receive an annuity; or (2) an inactive participant may elect to receive their benefits at any time following the date he has had a severance from employment within the trade for one full calendar year.

NOTES TO FINANCIAL STATEMENTS

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for details.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Employers' Contributions Receivable

Employer contributions are accrued as receivables and recorded as income in the month the work is performed. Contributions were deposited into the Plan's checking account at Community State Bank and then were transferred to Principal Life Insurance Company.

Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for plan benefits.

Payment of Benefits

Benefit payments to participants are recorded upon distribution. As of November 30, 2024 and 2023, no amounts were payable to participants who had withdrawn from participation in the Plan.

Date of Management's Review

Subsequent events were evaluated through March 24, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – RELATED PARTY TRANSACTIONS

Joint administrative and operating expenses are paid for by the Des Moines Iron Workers Welfare Fund and then an allocation of the expenses is made to the Plan, who reimburses the Welfare Fund. As of November 30, 2024 and 2023, the Plan owed the Welfare Fund \$61,528 and \$27,383, respectively.

The Plan shares a fiduciary insurance policy and fidelity bond with the Des Moines Iron Workers Pension Plan who it reimburses for half of the premiums.

NOTE 4 – TAX STATUS

The Internal Revenue Service has informed the Plan Sponsors by a letter dated March 30, 2016 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan sponsor believes that the Plan is currently designed and operated in compliance with applicable requirements of the Internal Revenue Code and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

The plan has adopted guidance on accounting for uncertainty in income taxes issued by the Financial Accounting Standards Board. Management of the Plan believes that the Plan has taken no uncertain tax positions that require adjustment to the financial statements in order to comply with the provisions of this guidance. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intention to do so, the Plan Sponsors have the right under the Plan provisions to discontinue contributions at any time and to terminate the Plan. In the event of termination of the Plan, the net assets will be distributed according to the Plan document and as required by ERISA. After satisfaction of all liabilities under the Plan, the participants’ vested account balances would be distributed to them.

NOTE 6 – CONCENTRATION OF CREDIT RISK

At November 30, 2024, the book balance of deposits in local banks was \$454,679 while the bank balance was \$454,569 of which \$204,569 was not insured by the Federal Depository Insurance Company (FDIC). There is no collateral on these deposits.

NOTES TO FINANCIAL STATEMENTS

NOTE 7 – FAIR VALUE MEASUREMENTS

The framework for measuring fair values provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 30, 2024 and 2023.

Mutual Funds: Valued at the net asset value of shares held by the Plan at year-end.

Common Collective Trust: Valued at the Net Asset Value (NAV) of units of the fund held by the Plan based on the fair market value of the underlying investments of the fund. This fund contains synthetic investment contracts comprised of both underlying investment and contractual components which have observable level 1 pricing inputs.

Pooled Separate Accounts: Valued at the net asset value (NAV) per share held by the Plan based on the underlying securities which have observable level 1 pricing inputs.

NOTE 8 – RESTRICTED NET ASSETS AVAILABLE FOR BENEFITS

Each participant in the plan has their own account balance where contributions made by employers on their behalf are added to their account. The investments of the plan are held by Principal Life Investment Company so that each participant could self-direct his or her own investments. Benefit payments are subtracted from their account balance. A summary of the Net Assets available for benefits as of November 30, 2024 and 2023 is as follows:

Assets identified as participants account balances are assets that are specifically allocated to each members' account at Principal Life Insurance Company.

The Plan has unallocated net assets in this crediting account derived from fees that were withheld from contributions to the Plan. The Plan also has unallocated net assets derived from quarterly service charges to the participants' accounts in order to pay administrative expenses.
