## INDEPENDENT AUDITOR'S REPORT

To the Participants and Trustees of  
Teamsters Local 2785 Convention Trades Training Trust:

### Opinion

We have audited the financial statements of Teamsters Local 2785 Convention Trades Training Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits – cash basis as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits – cash basis for the years then ended, and the related notes to financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Teamsters Local 2785 Convention Trades Training Trust as of June 30, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with the cash basis of accounting as described in Note 1.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). ### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the cash basis of accounting described in Note 1, and for determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## Auditor's Responsibilities for the Audit of the Financial Statements

**1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements of Teamsters Local 2785 Convention Trades Training Trust (the "Plan") have been prepared using the cash basis of accounting. This basis differs from generally accepted accounting principles primarily because revenue is recognized when received rather than when earned and expenses are recognized when paid rather than when the obligation is incurred.

**Benefit Obligations**

Due to the nature of benefits provided by the Plan, there are no benefit obligations. Therefore, the statements of benefit obligations and statements of changes in benefit obligations are not included in the financial statements.

**Administrative Expenses**

Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

**2. DESCRIPTION OF THE PLAN**

The Plan was established effective January 1, 2000, as a result of collective bargaining agreements between Brotherhood of Teamsters and Auto Truck Drivers, Local Union No. 85 and independent employers. The Plan provides a program of education and training for employees, covered by the collective bargaining agreements, in the skills and requirements for work performed in connection with the Convention Teamster's trade. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

**3. PRIORITIES UPON TERMINATION**

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

**4. TAX STATUS**

The Plan obtained its latest determination letter, dated February 21, 2001, in which the Internal Revenue Service stated that the Plan is in compliance with the applicable requirements of the Internal Revenue Code under Section 501(c)(9). The Plan has been amended since receiving the determination letter. However, the Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

The Plan's administrator has analyzed the tax positions taken by the Plan and has concluded that, as of June 30, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**5. FUNDING POLICY**

Participating employers contribute such amounts as are specified in their collective bargaining agreement. The hourly employer contribution rate was \$0.25 for work performed for each of the years ended June 30, 2024 and 2023. Based on an evaluation of the cash needs of the organization, effective January 1, 2025 the contribution rate increased to \$0.50 per hour.

**6. MAJOR EMPLOYERS**

During the years ended June 30, 2024 and 2023, one employer accounted for 65% and 50%, respectively, of employer contributions. In the event this employer suspends contributions, the Plan would terminate coverage to the employer's participants, as required under the Agreement and Declaration of Trust. The Plan would retain the risk of current fixed administrative expenses until appropriate adjustments were made.

**7. PARTY-IN-INTEREST TRANSACTION**

The Plan has a contract with one of the participating employers. Under the terms of the contract, the employer will make an employee available to provide training to participants for at least three eight-hour days per month. The employer is paid an hourly rate for services provided by this employee plus other related training expenses. During the years ended June 30, 2024 and 2023, \$0 and \$3,190 was paid, respectively.

**8. SUBSEQUENT EVENTS**

In preparing these financial statements, management has evaluated events and transactions that occurred after June 30, 2024, for potential recognition or disclosure in the financial statements. These events and transactions were evaluated through April 7, 2025, the date that the financial statements were available to be issued, and no items have come to the attention of management that require recognition or disclosure.
