Opinion

We have audited the financial statements of Baker & McKenzie Group Medical Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in benefit obligations and net assets available for benefits for the years then ended, and the related notes (collectively referred to as the “financial statements”).

Notes to Financial Statements

June 30, 2024

1. Description of the Plan

The following description of the Baker & McKenzie Group Medical Plan (the Plan) provides only general information. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

General

If coverage is elected, the Plan provides health and welfare (medical, hospital, surgical and prescription drug) benefits to Principals (as defined), and eligible employees who are scheduled to work in the U.S. 20 or more hours per week on a regular and ongoing basis of Baker & McKenzie LLP (the Firm), and eligible dependents (as defined). Coverage becomes effective retroactively to the first day of service. When medical coverage is elected, prescription drug coverage is automatic.

Additionally, Principals and eligible non-principal attorneys working outside the U.S. are offered coverage under the Plan. If coverage is elected, it becomes effective the first day of service and the Principal or eligible non-principal attorney is responsible for the full cost. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Benefits are provided under a combination of self-insured and fully insured options.

The trust was established at Bank of America, N.A. and pays benefits on behalf of the Plan's participants and the related administrative expenses. Medical claims for benefits provided to associates and staff under the self-insured option are administered, processed, and paid by Blue Cross Blue Shield of Illinois (BCBSIL) and funded by the trust. Pharmacy claims, including administrative fees, provided to associates and staff under the self-insured option are administered, processed, and paid by Express Scripts Inc. (ESI) and funded by the trust. Medical and pharmacy claims for benefits provided to Principals, also under a self-insured arrangement, are administered, processed, and paid by BCBSIL and ESI, respectively, and funded from general assets of the Firm.

Contributions

Participants make contributions to the Plan based on rates established by the Firm's International Benefits Committee, which are based in part on the advice of the Plan's benefit consultants and actuaries. The Firm's contributions to the Plan represent the total estimated funding requirement, less participant contributions.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Plan Termination

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the Plan's assets will be used to pay all claims incurred prior to the termination date as they are presented for payment.

Administrative Expenses

All administrative expenses are paid by the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedules. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Estimated Claims Incurred but Not Reported

Amounts for claims incurred but not reported represent an estimate, based on claims history, of the ultimate cost of all claims incurred but not reported as of June 30.

Payment of Claims and Premiums

Claim payments are recorded when paid by the claims administrator. Certain premiums and claims are paid from the general assets of the Firm; however, all premiums and claims are recorded in the accompanying statements of changes in net assets available for benefits, regardless of whether they were paid from plan assets or from the general assets of the Firm.

Rebates

Rebates from prescription drug programs are recorded when earned from the provider and netted with claim payments in the accompanying statements of changes in net assets available for benefits.

3. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

3. Fair Value Measurements (continued)

- Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:
 - Quoted prices for similar assets and liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in markets that are not active
 - Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level of input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value.

Money market fund: Shares of the money market mutual fund are valued based on quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

4. Income Tax Status

The trust funding the Plan has received an exemption letter from the Internal Revenue Service (the IRS) dated May 19, 1994, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (the Code) as a Voluntary Employees' Beneficiary Association. However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 for unrelated business taxable income. The Plan and the trust are required to operate in conformity with the Code to maintain the tax-exempt status of the trust. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and therefore, believes that the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of benefit obligations and net assets available for benefits.

6. Related-Party and Party-in-Interest Transactions

During 2024 and 2023, the Plan held shares of a money market fund managed by Bank of America, N.A., the trustee of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.
