Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Handy Truck Line, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Handy Truck Line, Inc. (“Company”) 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of the Company who have one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company pays the administrative costs of the Plan, except certain maintenance and transaction fees charged by John Hancock.

Contributions

Participants may elect to contribute 100% of pretax annual compensation, up to a limit of \$22,500 for calendar year 2023 and \$23,000 for calendar year 2024, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contribution, to a limit of \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of his or her account within options offered by the Plan. The Company may contribute a matching contribution equal to a percentage of each participant’s elective deferrals. The Company contributes a matching contribution equal to 25% of the first 4% of each participant’s elective deferrals. The Company may also make an additional profit-sharing discretionary contribution, if desired by management. The Company pays the accounting and legal fees incurred by the plan.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and Company matching contributions, as well as allocations of the Company’s profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The Plan currently offers investment options through John Hancock.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company contributed portion of the account is based on years of continuous service. A participant is 100 percent vested after five years of credited service.

Participant Loans

The plan does not allow participant loans.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments over a period of time. For termination of service due to other reasons, a participant may receive the value of the vested interest in his other account as a lump-sum distribution.

In-Service Withdrawals

Payment of benefits to participants is generally not permitted before termination of employment with the Company. However, the following in-service withdrawals are permitted by the plan: 1) all or any portion of participant benefits can be withdrawn upon attaining age 59 ½; 2) all or any portion of a participant's rollover contributions upon request; 3) all or any portion of a participant's benefits if the participant become disabled; or 4) if the participant seeks a hardship withdrawal.

Hardship Withdrawals

Under certain "hardship" conditions, participants, while still employed by the Company, are permitted to withdraw amounts necessary to relieve such hardship. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of postsecondary education tuition, room, board, and education fees, the payment of burial or funeral costs of immediate family members, the payment of natural disaster clean-up on the participant's principal residence, or to prevent eviction or foreclosure from the participant's principal residence. A participant's right to make deferrals to the Plan will be suspended for six months after the receipt of a hardship withdrawal.

Forfeited Accounts

At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$781 and \$955, respectively. Forfeitures of non-vested accounts are used to reduce future Company contributions to the Plan. During the year ended June 30, 2024, forfeitures used to reduce employer contributions and to pay administration fees totaled \$0. The balance in the forfeitures account at June 30, 2024 is \$2,679.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting. Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan follows the fair value measurement and disclosure requirements of Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, which defines fair value as the exchange price that would be received for the asset or paid to transfer a liability in an orderly transaction between market participants. See Note 3 for the discussion of fair value measurements. The Plan Administrator determines the Plan's valuation policies using information provided by the custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are reported on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Credit Risk

The Plan is exposed to a concentration of credit risk. All funds are presently invested and managed by John Hancock. Participants have the ability to choose from various funds. Investment funds available carry varying degrees of investment risk. In addition, the Plan is dependent on the Company's ability to fund employer contributions.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

General Plan administrative expenses, such as legal fees and administrative costs, have generally been paid for directly by the Company. Fees specific to the participant's investment selections and accounts are charged against that participant's account balance.

Recent Accounting Pronouncements

There are no recent accounting pronouncements that have a significant impact on the financial reporting of the plan.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds

If present, mutual funds are Level 1 investments and fund holdings are generally valued using market quotations. Each fund determines its share price or net asset value (NAV) daily. The funds invest principally in domestic and international equity securities, fixed-income instruments, real estate securities, asset allocation, and other mutual funds and short-term instruments in accordance with each fund's investment objectives.

NOTE 4—PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 5—TAX STATUS

The Plan is intended to be a qualified plan under Section 401(a) of the Internal Revenue Code. The Plan is interpreted, applied, and administered consistent with the intent to qualify under the above code section. The Plan was established through a prototype plan of Transamerica Retirement Services, who has received a letter from the IRS indicating this type of plan is acceptable. The Plan has subsequently amended; however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. No provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the relevant taxing authorities. There are currently no audits for any tax periods in progress.

NOTE 6 -- RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect

participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 7 – INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, John Hancock, the custodian of the Plan as of June 30, 2024, has certified as being complete and accurate the following information:

- All investments reported in the Statement of Net Assets Available for Benefits
- Investment activity reported in the Statement of Changes in Net Assets Available for Benefits
