Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Urban Dove 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

1. Description of Plan

The following description of Urban Dove 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all the employees of Urban Dove Team Charter School (the “Employer”). Employees are eligible to start making elective deferrals to the Plan after attainment of age 21 and completion of 6 months of service. Employees are eligible to receive the Employer discretionary matching contributions and Employer discretionary nonelective contributions upon attainment of age 21 and completion of 1 year of service. Entry dates are the first day of the month coinciding with or next following the date the eligibility requirements have been met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute up to 100% of their eligible compensation on a pre-tax or Roth basis, subject to the limitations established by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into the various investment options offered by the Plan. The Plan has an automatic enrollment feature whereby eligible participants are automatically enrolled in the Plan at a pre-tax contribution rate of 3% of their eligible compensation upon meeting the eligibility requirements.

The Employer may make a discretionary matching contribution and/or a discretionary nonelective contribution determined by management. During the 2024 Plan year, discretionary matching contributions were made based on participant’s years of service. Participants with one to four years of service received a 25% match to 6% of compensation. Participants with five to seven years of service received a 50% match to 6% of compensation. Participants with eight to ten years of service received a 75% match to 6% of compensation. Participants with greater than ten years of service received a 100% match to 6% compensation. There were no Employer discretionary nonelective contributions made for the 2024 Plan year.

Vesting

A participant is 100% vested in their contributions including allocated earnings thereon at all times. Participants vest in the discretionary Employer matching contributions and Employer discretionary nonelective contributions based on the following table:

Plan Expense Account

The Plan and Empower entered into a service based pricing arrangement whereby a portion of the revenue earned by certain Plan investments is passed through to the Plan for payment of permitted Plan expenses. The Plan Expense Account is a nonparticipant directed account within the Plan. The Plan Expense Account balance was \$0 at June 30, 2024 and 2023. During 2024, \$4,909 from the Plan Expense Account was used to reduce Plan expenses.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

Payment of Benefits

Participants are eligible to receive benefit payments when they terminate service or reach age 59 ½. On termination of service, a participant may elect to receive a distribution in the amount equal to the participant's vested interest in their account. Benefit payments are also permitted for death, disability and hardship.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. The loans bear interest at prime rate and are secured by the participant's account. Principal and interest are repaid through payroll deductions in equal payments over the term of the loan (up to five years). The Plan permits longer repayment terms for loans made for the purchase of a principal residence. A participant may have no more than two outstanding loans from the Plan at any time.

Expenses

Certain expenses related to maintaining the Plan are paid by the Employer and are excluded from these financial statements. Any expenses not paid by the Employer are paid by the Plan. Investment related expenses are included in net appreciation in value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the guaranteed interest fund, which is stated at contract value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price and are deemed to be actively traded. The common/collective trusts are valued at the NAV of units held by the Plan as a practical expedient. The guaranteed interest account is valued at contract value, which represents contributions plus credited interest less participant withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

Notes Receivable from Participants

Participants' loans are measured at their unpaid principal balance plus any accrued unpaid interest and are classified as notes receivable from participants. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the participant loan balance is reduced, to the extent there is a distributable event, and a benefit payment is recorded as a deemed distribution.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is April 15, 2025.

5. Common/Collective Trusts

The Putnam Retirement Advantage Trusts (the “funds”) are a series of ten collective investment trusts designated for participants who want to structure their asset allocation towards a specific target year in which they intend to retire. The Plan held seven of the ten collective investment trusts as of June 30, 2024 and 2023. The objective of each fund is to maximize returns while maintaining a level of risk appropriate for a person planning to retire on or about the calendar year designated in the fund’s name. The collective trusts are managed and distributed by Putnam Fiduciary Trust Company, LLC. The price of each fund’s units is based on its NAV, which is in turn based on the NAVs of each portfolio in which it invests. The NAV per unit of each fund equals the total value of its assets, less its liabilities, divided by the number of its outstanding units. These funds have no unfunded commitments.

Purchases of the fund are accepted daily and are credited based upon the net asset value per unit as of the close of business on the date the purchase is received by the trustee. Withdrawals generally will be permitted daily for the funds, at a redemption price equal to the net asset value per unit redeemed as determined by the trustee.

6. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. As of June 30, 2024 and 2023, the Plan had \$19,950 and \$11,789 in excess contributions payable. The Plan distributed the 2023 excess contributions to the applicable participants prior to September 15, 2024.

7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

8. Tax Status

The Internal Revenue Service (“IRS”) has determined and informed the plan document preparer by a letter dated June 30, 2020, that the Plan was designed in accordance with the applicable regulations of the IRC. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

9. Party-in-Interest Transactions

The guaranteed interest account was issued by Empower Life & Annuity Insurance Company, a trustee of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statement of net assets available for benefits.

Certain employees of the Employer, who may be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

10. Non-Exempt Party-in-Interest Transactions

During the 2023 and 2022 Plan years, the Employer failed to transmit to the Plan certain participants’ contributions and loan repayments totaling \$40,299 and \$2,279 within the period prescribed by the Department of Labor regulations. Delays in remitting these amounts to the Plan were due to an administrative oversight. In December 2023 the Employer made the necessary corrections for the 2022 delinquent contributions to satisfy both the Department of Labor and IRS guidance for this matter and is in the process of implementing procedures to reduce the time needed to transmit participants’ contributions to the Plan. The Employer has made the necessary corrections for the 2023 delinquent contributions subsequent to the Plan year end.

11. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

11. Risks and Uncertainties (*continued*)

The global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to June 30, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
